UKWESABA NGEZIMPETSHENI

UMTHETHO sivivinywa omusha ka Hulumeni omayelana nempesheni usuvuse izikhalo okudala babakhona mayelana noku-faka imali ezikhwameni zempesheni futhi esezado-nsela ekubeni kuqubuke eziningi iziteleka neseziseduze ukuqubuka e Mpumalanga Kapa kanye nase Natal.

Ukuhlangabeza inkinga, abasebenzi bakwa Sappi, nabakwa Huletts kanye nakuma Council ama Shop Steward eNtalasifali sebe-bhale phansi kaningi ngalezidingo bafuna lezidingo:

* Ulwazi olugcwele ngwa abasebenzi mayelana nokugcinwa kwezimali zempesheni nokuphathwa kwazo.

* Ukumelwa okulinga-nayo emkhandlweni waba-phathi bemali yempesheni.

* Abasebenzi (Phansi kwanoma yisiphi isimo) kumele babe nelungelo lokuthola okufakwa ngum-Qashi esikhwameni sempe-sheni.

Udaba lwempesheni lwaqu-tshulwa yisinqumo sika Hulumeni sokuba "Alondo-loze" abasebenzi izimali zempesheni.

Phambilini, iningi labasebenzi lalingase liyikhiphe imali yalo esikhwameni sempesheni uma labo basebenzi sebewuyeka umsebenzi. Ngaphansi komthetho omusha akukho mali eyokhi-shwa esikhwameni sempesheni ngemva kokuba umthetho omusha ususebenza ngaphandle kokuba kutholakele imvumo ethile ku Hulumeni.

Umphumela waloku ke kube ngukuthi iningi labasebenzi linqume ukuthi likho-khelwe manje imali yalo esi-sesikhwameni sempesheni.

Kwa Sappi, abasebenzi ababetelekile babengaculisive nje ngumthetho omusha kuphela. Babengaculisikele yindlela izimpesheni ebezisebenza ngayo esikhathini esedlule.

Phakathi kwezikhalo abaziveza kubaQashi kwaba ngukuthi:

* Babengatshelwa mayelana nokujoyina isikhwama sempesheni nanokuthi imali yempesheni iyobajwa nini.

* Babengazi nenkuthi imali yabo yenzenjani nanokuthi ilondolozwe kanjani.

* Kwakumele bayisebenze iminyaka eyikhulu inkampani ngaphambi koku-balungelo lwemali efakwa ngumQashi esikhwameni sempesheni.

* Uma bethola imali yempesheni enkampanini, balahlekelwa yilungelo loku-thola eka Hulumeni.

* Uma impeshini izo-kwenganelwa ngu Hulumeni, bayothola ubunzima obufanayo nalobo ababuthola ekufuneni imali yempesheni yoMbuso noma imali yabala-hlekwe ngumsebenzi (UIF).

Ngokusho kuka Dusty Ngwane, uNobhala we Transvaal Regional Educational Committee, ezifanayo izikhalo ezimayelana nezi-mpesheni zavezwa ngaba sebenzi kuma Seminar ka FOSATU amuva nje e Ntalasifali.

"Kuyacaca ngokusobala ukuthi abasebenzi abagculi-sekile ngenxa yokuthi kabanazwi ngendlela izikhwama ezisebenza ngayo, nangale nje komthetho omusha," wakusho loku kwi FOSATU Worker News.

Njengesixazululo sesikhasana abasebenzi ezingxenyeni ezithile e Kapa kanye nase Natal bavunyelwa ukwesula emisebenzini yabo, bathola izimali zabo zempe-sheni bese babuyela baqashwe ngaphandle kokulahlekelwa ngamalungelo eminyaka yabo yesevisi.

Ezinye izinkampani ezinjengo Sappi zavuma ukucela imvume ku Hulumeni emthethweni omusha kodwa ke ngisho noma loku kungase kwenzeka, abasebenzi kuyomelele baphonse esikhwameni sempesheni izikhalo ezindala ziyobe zilokhu zikhona kwabe kungukuvimbela loku okwenza ukuba kubhacwe uhlalwalezizidingo.. PENSION BILL IHLEHLISIWE

Umthetho omusha we pensions heni uzohleliswa iminyaka emithathu mayelana nesime-

mezelo esedlule yi Registrar of Pensions. Kodwa okuba-lulekile ngokubusa ngaphezu kwepentsheni kuzekubemanje

akukaphethwa futhi izoxoxwa ngo October kumhlango we Central Committee.

Inyunyana ethuthukayo isiphezulu

UMHLANGANO ohlanganisa cishe zonke iziNyunyana zabasebenzi ezithuthukayo e Ningizimu Afrika waba impumelelo ebalulekile obumbanweni lwabasebenzi.

U FOSATU kanye iziNyunyana zahlangana ngo August 8 e Capt Town ukuze zithathe isimo esisodwa nesifanayo mayelana nomthetho ohlongozwayo ophathelene nezobudlelwane kwezemisebenzi.

Estatimendeni esenziwa sahlanganyelwa esakhishwa ngemuva komhlango, lapho iziNyunyana zaziwuhlaba khona lomthetho.

* Ukuzigaxa kuka Hulumeni ezindabeni zezinglangano zabasebenzi,

kanye * Nenqubo yama Industrial Council ekhona manje.

LeziNyunyana zaphakamisa ukuthi:

* Zithumele ama delegate kuNgqongqoshe wase Ciskei u Lennox Sebe ukuyohlaba isimo sakhe sokuphikisana nezinhlangano zabasebenzi, kanye nokuba

* Kwakhiwe amakhomidi obumbano kwisifunda ngasinye azobhunga futhi aqalise ubumbano kanye lokubambisana.

Kuzozonke iziNyunyana zabasebenzi ezakhombisa umdlandla ngobumbano lwabasebenzi umhlango waba luphawu olukhuthaza kakhulu.

Ezinyangeni eziyishumi nesishiyagalombili ezedlule kwabo noqhekeko olukhulu ezinhlanganweni zomzabalazo wabasebenzi. Loku kwadala ukuthi ezinye iziNyunyana zichithe isikhathi sazo esiningi ziqhubukushana nezinye izinhlangano zabasebenzi esikhundleni sokuba zicindezele abaQashi ngezidingo zazo.

Isiphakamiso isiNyunyana kumele zizame ukwakha nokumisa amakhomidi obumbano ukuthuthukisa ubumbano lweqiniso ezifundeni ezehlukene saba ngesamukeleka ngesasa elikhulu.

Kusukela ekubunjweni kwakhe u FOSATU usaloku egcizelela kokubambisana

phakathi kwabasebenzi ezimpandeni zefekthri.

Izitimende ezikhombisa ukuphikisana nomthetho ka Hulumeni zibalulekile ekwakheni ubumbano lwabasebenzi ekubhekane nabaqashi kanye no Hulumeni.

Kodwa ngaphandle kokubambisana kwe qiniso kubaholi wabasebenzi ezindaweni ezahlukene, ubumbano kungasho ukuthi lwakhiwe esihlabathini nje asiqinile.

Leqiniso ke, ubumbano ekugcineni phakathi kwabasebenzi alusoze lwakhiwa kubantu abalaphaya phezulu, ubumbano lweqiniso kumele lwakhiwe ezimpandeni phansi emzabalazweni wabasebenzi.

Isivumelwano — Yinselelo

IMIZAMO eya phambili ayenziwa iziNyunyana zika FOSATU eminyakeni embalwa eyedlule isicelwa inselele evela endaweni engalindelekile.

Ngenxa yokuthi manje inani abaQashi sebepheqekile ukulivuma ilungelo lama Shop Steward nokwamukela amaxoxo amiswe phezu kwesisekelo sefekthri, sebezama ukuthatha izintambo ngokujobelela imitheshwana evimbayo ezi-vumelwaneni abazisayindayo neziNyunyana.

Lesi yisimemezelo esakhi-shwa kwe Seminar kazwelonke ye FOSATU e Wilgespruit Fellowship Centre esontweni lokugcina ku August.

Ama Delegate angu 35 aqhamuka ezindaweni ezinezimbongi ezinkulu e Ningizimu Afrika axoxa ngolwazi lwawo ekuxoxisaneni kwawo naba Qashi kwakavuma nje.

Ingingi labe lisho into efanayo yokuthi abaqashi babeveza izivumelwano eziphicayo eziNyunyaneni ezixube kuzo zonke izinhlobo zemitheshwana evimbala amalungelo leNyunyana.

Phakathi kwemithetho evimbayo emibi ngokudlulele kwabe kuyile yokuthi:

* Ama Shop Steward kufanele abe neminyaka engu 5 esebenzela inkampani nanokuthi abe ne rekodi elimsulwa lokuziphatha

* INyunyana kumele ingavumeli nanoma yiziphi iziteleka enkampanini futhi iyale amalunga ayo ukuba abuye emsebenzini.

* Abaphathi -msebenzi banelungelo labo bodwa nje qha lokuzinqumela ngezindlela zokwenza umsebenzi, nelokuqhuba umsebenzi kanye nokuhlela mayelana nomkhqizo.

* INyunyana kufanele ijoyine kwi Industrial Council naphakathi nesikha-

thi sezinyanga ezintathu sebemukeliwe inkampani uma kungenjalo balahlekelwe ukwemkelwa inkampani.

* Amakomidi lawo enza ukuxoxisana kumele axube nabameleli abasebenzi abangawona amalunga eNyunyana kafuthi abangagqu-gquzelekile.

Kwavela obala ukuthi imikhankaso ehlangene equkethe ukuqhutshekiswa kwenyanyana yabe isisendleni eya phambili.

Ama Delegate ase Natal, ukulinganisa, abika ukuthi Natal Chamber of Industries kumanje isiqashe abammeli abathathu kumbe abane abasebenza isikhathi esigcwele abazobhekana ngqo nezivumelwana kanye nezinye izindaba Nyunyana.

Amanye amaDelegate abika ukuthi abaQashi babeshi-

ntshanisa ngazo kanjani bezizibonise nokwehlu-

kana kwezindawo zweni.

Loku kwakusho ukuthi ukwakha isivumelwano nenkampani eyodwa kwakuyothinta ndlenithize uku-xoxisana nenkampani kwenye indawo.

Njengoba uikunqoba odabeni lwe Industrial Council kuzisile ezinye iziNyunyana ezibhekene naloludaba, kanjalo ukwamukelwa kwemitheshwana engazange inakwe esi-vumelwaneni esisodwa ingase idale ubunzima emaxoxweni kwezinye iziNyunyana ezikwezinye izindawo.

Kunokwenzeka manje ukuthi isivumelwano efekthri eyodwa singacaba indlela yokulandelwa yibobonke, ngaleyondlela ama delegate aphikisana ngokuthi kwakungcono ukungenzi sivumelwano esibhalwe phansi kunokwenza isivumelwano esizofaka abanye emgodini.

Isivumelwano akunto engathatha isikhundla enhlanganweni enamandla laphaya phansi esizindeni sabasebenzi efekthri.

Loku kuchaza ukuthi isivumelwano kumele siveze obalala izinto ezidingayo abasebenzi, kungabi yinto eyakhiwe ochwepehshe

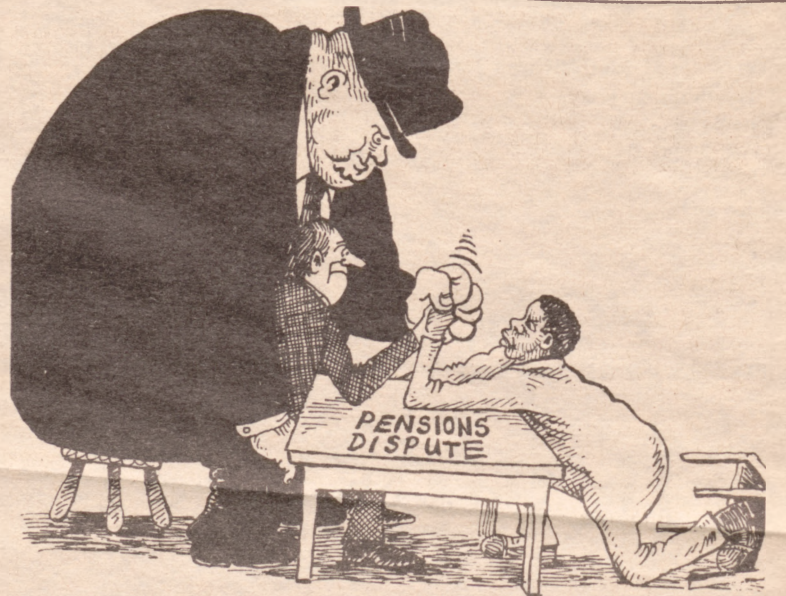
abathile bangaphandle.

Abasebenzi kumele bazinqumele ngezidingo zabo, bese bexoxisana ngazo naba-Qashi nokuthike yingale yonkathi-ke lapho zingabhalwa phansi njengesivumelwane esibophayo.

Ama Delegate abeka ukuthi izivumelwano zabe zingadi-ngeki ngokungakanani ikakhulukazi efemini enkulu futhi nenhlangano iqinile. Okungenani amalungelo abasebenzi kumele avikelwe ngukuqina kwenhlangano ezimpandeni zefekthri

Ama Delegate apahwula ukuthi emafemini amancane, abasebenzi babesimweni esintengayo, kodwa ke inhlangano yabo iqinile. Babesobala kakhulu ngaphandle uma babeyingxenyeyenhlangano enkulu kunge-njalo ke bonke abasebenzi kuleyondawo abakuyo begququzelelwe enhlanganweni efanayo.

Kodwa-ke njengokusho koMgqugquzeli we NUTW, u Georffrey Gwala, abaQashi bangasephula isivumelwano ngokuthanda kwabo, uma abasebenzi bengagququzel-ekile ngokwanele ukuze babone ukuthi abaQashi basihlonipha isivumelwano.

Ama Shop Steward angu 41 akwa Sigma abane Seminar yokuwaqeqesha izinsuku ezine kusukela ngo September 2 e Pitoli. Loku kwakungokokuqala ezinsu-kwini zabo eziyi 10 zokuqeqesha bekhokhelwa ngokugcwele abazabelwa ngokuxoxisana nabaphathi be Sigma.

Izihloko ezaxoxwa kwi Seminar zabe zixube iNyunyana kanye nenqubo ka FOSATU, imisebenzi yama Shop Steward kanye noku phathwa kwezikhatho.

Ama Executive e PWAU yaba ne Seminar yosuku olu-lodwa okwabe kungamatu-ngiselo omhlangano nenhlangano yabaQashi okwakubhungwa nge Industrial Council.

I Seminar yaba isinyathelo esibalulekile esasizolandelwa umhlangano ongakaze ube khona phakathi kwenhlangano kazwe lonke yabaQashi kanye neNyunyana eyabe ifufusa yaba mnyama.

U FOSATU wabe ne Seminar e Eastern Province eyaba ngempela sonto eyayimayelana eneziNyunyana zaba sebenzi kanye nemithetho eNingizimu Afrika.

Isifunda sase Goli se MAWU saba ne Seminar yama Shop Steward eyadonsa izinsuku ezintathu eyabe imayelana nendlela yokuphathwa kwezikhatho kanye namaxoxo okwafunda ngo September 22 kanye ne Seminar ye BEC eyabe isise Hammanskraal kusukela ngo September 26.

I — I.C. ingase iguqulwe

Izinguquko ezinkulu nezibalulekile ziyacatshangiswa ekusebenzeni kwama-Industrial Council okungenxa yokududula kanzima kwezi-Nyunyana.

Ezimbili zezinhlangano ezinkulu zabaQashi SEIFSA kanye FCI seziku-bekile ukuthi ziyabhunga ngokuthi ama-Industrial Council angabunjwa kangcono kanjani.

IziNyunyana zika FOSATU zibe nesandla esikhulu ekuphoqeleleni lokukucatshangiswa kabusha. Amaxoxo eziNyunyaneni ze Paper, Iron and Steel Chemical, nokuphikisa nezimbongi zezinye ze Textile zonke ziphoqelele abaqashi ukuba basicabangisise isimo sabo.

"Inhloso ka FOSATU ngokusho kuka Nobhala jikelele u Joe Foster, "Ingu-kwakha indlela yokuzuzela bonke abasebenzi ngendlela egculisa bonke abasebenzi.

"Siyawamukela umgomo wokuzuzela ngezimbongi kumbe ngezifunda jikelele. Futhi siyazikhuthaza ngokugcwele lezozinqubo ezihlangabeza-nayo nezidingo zethu. Umgomo wethu lubumbano lwabasebenzi namandla abasebenzi futhi sikhohlwa ukuthi amaxoxo embonini-jikelele ayosiza ekunqobeni indlela yokuzuzela ngokwehlukana ngamafekthri.

"Ngesikhathi esifanayo, acesize sayeka umfutho

wethu akubasebenzi ezimpandeni ze fekthri. Ziningi izi-Nyunyana esikhathini sanjaye ezesekela indlela ye-Industrial Council ngenxa yokuthi kazinazo izakhiwo phansi ezimpandeni zefekthri ezingase zibavumele ekuzuzeni ngokuphelele lapho. Loku ngeke sakuvumela futhi into esilokhu sayihlaba,, washo kanje.

Embonini yensimbi, kwaba nezingxoxo phakathi kweziNyunyana zika FOSATU kanye neqembu elikhulu labaQashi. Loku kungadonsela ekubeni kube ne-seminar phakathi kwezinhloko zeNyunyana ye nsimbi okuyiNyunyana ka FOSATU kanye nezinhloko ze Nhlango yabaQashi. Ngaphezulu kwaloku sekube namaxoxo phakathi Nyunyana kaFOSATU ekhula ngamandla, okuyiNyunyana nensimbi, i-MAWU kanye ne-Industrial Council.

Embonini ye phepha, sekube nezingxoxo phakathi kwama-Executive enhlangano yabaqashi yephepha kanye neNyunyana yephepha. Kungasekuba neminye imihlangano.

Embonini ye-Textile, amaxoxo asehambe indawo

ende ukwedlula zonke. Ezi-nyangeni ezintathu ezedlule, amaxoxo aseye enziwa phakathi kwenhlangano yabaQashi iTextile and Yarn Fabric Manufacturers (TYFMA) kanye ne National Union of Textile Workers (NUTW).

Ngokusho kuka Prof Sineke, onguMgqugquzeli iNyunyana ibeke phansi imigomo emithatu. Leyo migomo ilena:

* Amaxoxo ayasendlelelo samahoto embonini yonkana kumele ambandakanywe namaxoxo efekthri avumela ukuzuzwa kwamahoto aphezulu.

* Ama-House Agreement akumele enziwe iziNyunyana ezimbili efekthri eyodwa. Inyumelwano kumele zenziwe kuphela lapho iNyunyana eyodwa inamalunga amaningi ngaphakathi e Fekthri.

* Akukho kuxazululwa kwengxabano okuchitha ilungelo elisemthethweni lokuteleka okungase kwemkelwe.

I-TYFMA yaphendula ngokubeka iziphakamiso izintathu. Yaqala ngokuzama ukucindezela iNyunyana ngokufunza nge-Industrial Council. Ngenkathi iNUTW yenqaba, i-TYFMA yabe isiphakamisa isivumelwano sasendlini esisha (Model House Agreement) esizosingatha wonke

amafekthri embonini, inqobo nje uma i-NUTW iyemukela i-Industrial Council.

INyunyana yaphinde yaku-thola loku kungemukeleki okuthe emaxoxweni amuva nje, i-TYFMA yabe isikuvuma loku:

* House Agreement
* Ukuzuzela abasebenzi embonini yonkana ngaphandle kwenkundla ye-Industrial Council

Kodwa ke isimo esingagcuelisi ukuthi lemibandela enenhla iyoma isebenze kuphela uma i-NUTW yemukale i-Industrial Council njengomgomo okuyofinyelelwa kuwo ekugcineni.

Yaphinda futhi i-NUTW yasichitha lesisimo sokugcina nokuthi ke amaqembu omabibili asevumelene manje izinhloko zamaqembu omabili zichazelane ngesimo.

Abasebenzi e-Leyland basaqinile

NJENGOKUSHO kuka Nobhala we NUMARWOSA e Cape Town u Joe Foster, "Kungenzeka ukuthi sehlulekile kuloku" ngemva kokuba abasebenzi base Leyland muvanje sebeye basiyeka isiteleka esithathe amasonto ayishumi, kodwa loku kusenze sahlomela ingomuso.

Abateleki babuyela emsebenzini e Blackheath nase Elsie's River ngemva kokuba abaQashi sebe vumile ukubuyisela emsebenzini abasenzi abangu 150 e Elsie's River ekupheleni kuka July nabangu 200 kusukela ngo August 3. abasasele bayophinda babuyiselwe emsebenzini uma izikhala seziveliile.

Ebuzwa ngaloku, uMnu Foster wajobelela ngokuthi loku kungeke kwabizwa ngokuthi "kuyimpumelelo enkulu" kubasebenzi njenga- loku bengazizuzanga izinto ababazitelekele.

Kodwa ke, abaQashi baye- nysa imali ngo 7c, okwenza ukuba kube ngu R1,46 awa. Loku kungaphansi kwemali yeholo e Mpuma- langa Kapa nase Ntilasifali, kodwa kunga phezulu kwemali eholwa e Thekwini. Kodwa kusengaphansi ngo 54c kuloko okufunwa ngu FOSATU okungu R2,00 -awa.

Kodwa uMnu Foster wajobelela, wathi isiteleka

kasibanga ukwehlulwa ngo-

kuphelele kweNyunyana. Kwayinika isifundo i Leyland sokuthi kumele ibaphathe kanjani abasebenzi.

Ukwenqaba kweNkamani ukuba kuxoxiswane ngendlela egculisayo kwayifaka ezindlekweni ezinyizinkulu- ngwane zama-Randi. Kuyomele ibe yinkampani enothe kakhulu ukuba iphinde ikhokhe kabili ngephutha elifanayo." washo kanje.

Ngaphezulu kwaloku aba- senzi kwabanika ithuba kha uxhumano olubalulekile nezinye iziNyunyana kanye nezinhlangano zomphakathi ezazibekile. Amalunga eNyunyana a yekhuluma emihlanganweni yomphaka- thi pahkathi nsiteleka kanjalo

izinkulungwane zabantu zakubona ukubaluleka komzabalazo wabasebenzi.

Kusukela esitelekeni iNyunyana ibisiyakha amalunga ayo. Okumanje isinamalunga angaphezulu kuka 780, ngaphezulu kuka 60% wabasebenzi. Iningi labaholi beNyunyana sebebuyele emsebeni futhi kulindeleke ukuthi abasasele nabo bazobuyela emsebenzini ngokushesha.

Ugqozi lwabasebenzi efekhtri lusalokhu lulukhulu. uSihlalo weGatsha le NURWOSA u Natie Gantama wabingelelwa njenge qhawe ngenkathi ebuyela emsebenzini emasontweni

ayithupha edlule. INyunyana ibingakawaqali amaxoxo nenkampani kodwa asokwenziwa esikhathini esifushane esizayo.

Okwalandelwa yisiteleka kwaba yisinyathelo senkan- tolo esathathwa yiNyunyana eyabe ifaka icala lokuthi ngokuxosha abasebenzi, i Leyland yephula indlela okungeyayo evinqubo.

INyunyana yabeka nokuthi ukumiswa kwama Stop Order inkampani yabe yephula isivumelwano sayo neNyunyana. AbaQashi bavuma ukuqhubeka nokwenza ama Stop Order.

Kusalindeleke isinqumo senkantolo odabeni lwephuzo lokuqala.

IZINYUNYANA zika FOSATU zenza amaxoxo ngezivumelwano zokuvikela abasebenzi okudalwa ukwehla kwezinga lomnotho okulin- ndelekile e Ningizimu Afrika. Lesinikelo sakhiwe ikakhulu ngamaxoxo enqubo engala- ndelwa ekudilizweni kwaba- sebenzi.

I SFAWU e Kellogs kanye ne MAWU e Tensile Rubber and Pigott Maskew sebewenzile amaxoxo enqubo yokudiliza kwabasenzi enalezinto ezi- landelayo:

* Umgomo oyisisekelo uthi owangene kuqala efemini uye oyogcina ekudilizweni. IziNyunyana ziphumelele ukuthola isiqiniseko ukuthi abaQashi bangakusebenzisi ukudiliza abasebenzi asebenenkonzo ende nenkampani ngoba nje bengasenamkhiqizo njengal- abo abasebancane.

* Kuyoxoxiswana diliza. Kokubili ukudilizwa kanje nenqubo kuyoxoxisw- ana ngakho. Isivumelwano sase Kellogs siqukethe ukuthi iNyunyana kumele yaziswe ngaphambili ukuze kwenziwe umhlangano wokuzoxoxa ngaloku.

Esitelekeni samuva nje sase Dorbyl e Uitenhage, kwenzeka ngendlela Ngemva kokubheduka kwesiteleka, amaphoyisa abopha amalunga amahlanu Shop Steward Committee abe esebatheswa icala lokwesabisa nokuphehla isiteleka.

IMPENDULO: MAWU Into enkulu ebalulekileyo oku—guquka noma ukukhuphuka kwenani lamalunga. Ngonyaka ophelileyo besimalunga angu 200 emhlanganweni kawonke wonke esasinawo. Manje sinamalunga angaphezulu kuka 2000. Inani seliphinde kayishumi kumalunga ebesinawo. Sizizwa ukuthi inguquko inkulu. Kusho ukuthi abasebenzi bayawubona umsebenzi wenyonyana.

Okunye okubalulekile okwenzeka kumhlangano kawonke wonke kwakukhona abasebenzi ababekhuthela kakhulu kulowo mhlango. abantu bakhuluma abakuthandayo nabakucabangayo. IMPENDULO: kukhona inkolelo ejikelezayo, esho ukuthi ubudlelwano phakathi bunyenzeka nge Industrial Councils. Lokhu kuyamangaza ngoba abasebenzi nabaqashi bano budlelwano ku shop floor. I Industrial Councils isho ukususa ubudlelwano phakathi embonini. Babheka isimo se Industrial Council, sithola nokuthi abasebenzi

ngoke bakwazi nokuzenzela bona ngamandla abo. Izinyonyana ezidala zikhona zihlezi ku Industrial Council zinemidlandla eyahlukeneyo ngobuningi babasebenzi kulolonke izwe. Nge 50% yalabo abahlezi ku Industrial Council ngokuhlukaniswa ngabaqashi babo, sizoba sephutheni ngokuzama ukuthola utho ngamalunga ethu.

UMBUZO: Kubukeka sengathi akujabulisi ngesimo sokumelwa i Industrial Council. Yini okunye okungamukelela kuwo

IMPENDULO: I MAWU ingayamukela i Industrial Council uma ingezu kukakwa inxoxa ye shop floor. Uma Industrial Council inokwenza, siyesaba ukuthi izifiso zethu azinokwenzeka ngenxa yokwenza izifiso ezahluke—neyo zezinye izinyonyana. Singafisa ukuhlangana ne Industrial Council uma sineqiniso lokumela amalunga ethu.

Sinokukwenza ke lokhu ngobuhlobo nagenani babasebenzi esibamelayo. Siyathanda futhi ukuba sibe nezwi ngokwenzeka komzimba ukuba sikwazi ukwanelisa komdlandla yabantu bonke.

UMBUZO: Mpumelo yini esezenzele yona iMAWU.

IMPENDULO: Sifuna ukuzibona sesithole utho oluphathekayo ngabasebenzi kule izwe, abasebenzi kufanele babendlela ethile yokuphathwa.

ABASEBENZI base Volks—wagen e Uitenhage okungabe Nyunyana i National Union of Motor Assembly and Rubber Workers (NUMARWOSA) Baphakathi kwabasebenzi abagqogqo—zeleke kahle eningizimu Afrika.

Kubasebenzi bakwa Volks—wagen abangu 7000 abangu 6000 bangamalunga e NUMARWOSA. Iningi lalabo abangesiwo amalunga ngabasebenzi abadala abangahambisani neNyunyana. Bangu 23 abangama Shop Steward kodwa abangenzi umsebenzi wobu Shop Steward ngokugcwele kanye nabathathu abenza umsebenzi wobu Shop Steward nje qha ngokugwele abangabameleli babasebenzi futhi abaneluu—ngelo lokuhlangana nxa kuvela udaba olubalulekile.

Amalungelo abasebenzi bakwa Volkswagen azuzwa nje ngemuva komzabalazo omude. Ngo June 1980, abasebenzi bakwa Volks—wagen bateleka amasonto amathathu lapho ke bazuzela bonke abasebenzi embonini amaholo asezingeni lokuziphilisa. Kusukela ke sikhathi amaholo abasebenzi ezimbonini zezimoto akhuphuka kulolonke elase Ningizimu Afrika futhi kwazinye izindawo akhuphuka afinyelela emqomweni

odingwa u FOSATU wama Randi amabili nge awa.

Akukho nokukodwa nje kwaloku okwazuzwa kalula nje. Njengokusho kwenye i Shop Steward esinesikhathi eside: "AbaQashi bakwa Volkswagen bazama ukuqinisa kakhulu ngama Supervisor kubasebenzi kanjalo ama Shop Steward kanye nabasebenzi bawalela kanzima amalungelo abo. Kusukela esitelekeni kwaba nokubekwa phansi kwamatuluzi okungaphezulu kwamashumi amathathu okwakudalwa ukuxoshwa ngokungafanele kanye nokuphatha ngesihluku kwama Supervisor."

Enye i Shop Steward u John Gomomo yathi: lele esimweni manje lapho abaQashi kumele babonisane nama Shop Steward ezinqwamweni ezibalulekile mayelana nabasebenzi."

Okunye okukhulu ukunqoba okuhlaba umxhwele okwazuzwa kwaba ukuguqula isiqu sabaqashi sokuqalisa indlela yokusebenzisa abasebenzi izinsuku eziyikhombisa ngama shift. "Loku kwaba ukunqoba okukhulu. Umkhqizo yiyo—nanto abaQashi abayibheke ngamhelo abomvu. "Ngisho nabasebenzi bemboni yezimoto base Jalimane abakaze bazizuze lezinto

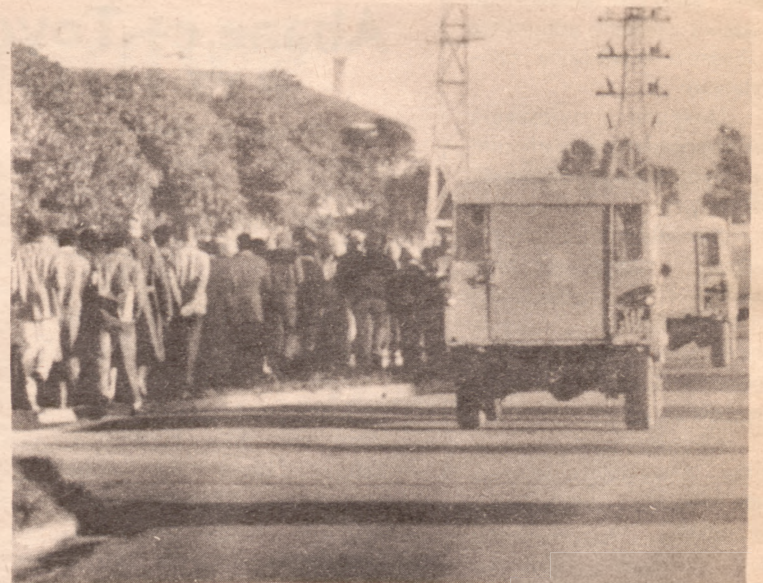
nanamuhla" Ngokusho kuka Freddy Sauls uNobhala Jikelele we NUMARWOSA.
