MINUTES OF A MEETING OF THE STANDING COMMITTEE ON NON-EUROPEAN HEALTH SERVICES HELD IN THE INSTITUTE'S OFFICES AT THE UNIVERSITY MILNER PARK, JOHANNESBURG, ON SATURDAY, OCTOBER 6th, 1934 at 2.30. p.m.

PRESENT:

Dr. H.A. Moffat (Chairman), Doctors Hamilton Dyke, N.M. Macfarlane, A. Simpson Wells and R.H. Welsh, Miss Ruth Cowles, Mrs. Rheinallt Jones and Mr. Rheinallt Jones.

1. APOLOGIES: Apologies for absence were received from Mrs. Bennie, Miss Alexander and Dr. Alan B. Taylor.

2. MINUTES: Minutes of the last meeting held on October 2nd, 1933 were confirmed and signed.

3. NATIVE MEDICAL SERVICES - GOVERNMENT SCHEME:

Very full discussion took place on the Government's scheme for medical services in Native areas, and the discussion yielded general agreement on the following points which, it <u>was decided</u>, should be submitted to the Secretary for Health for his consideration by a deputation from this Committee to be arranged through the Chairman:-

I. Training and Employment of Nurses and Nurse Aids

(A memorandum prepared by the Institute was laid on the table and <u>approved</u>). Findings:-

a. The Committee was satisfied that there is now available a sufficient supply of Native girls who have passed Standard VIII. and thus have the necessary educational pre-requisite for training for the State certificate.

b. The Committee considered that the present shortage in the number of fully trained Native nurses is due to the lack of facilities for training, and supported a resolution of the Trained Nurses Association that hospitals which have the necessary facilities should be pressed to give full training to their Non-European nurses. c. The Committee foresaw difficulties in the relationship between medical aids (with the training contemplated in the scheme) and trained nurses more particularly in respect of the subordination of the one to the other.

II.Native Medical Training

Findings:a. The Committee expressed the conviction that from every point of view it is highly desirable that medical training should be given to Natives in South Africa and as Soon as possible.

b. The Committee also recommended that - pending -

pending the provision of medical training in South Africa, specially selected individuals should have State aid to enable them to proceed overseas for training.

III. Training and Employment of "Medical Aids" Findings:-

a. The Committee agreed in principle with the proposal to employ "medical aids", but wished to emphasise the importance of direct supervision by district surgeons.

b. The Committee having considered the draft syllabus for the training of "medical aids" prepared by the Inter-Departmental Committee on Native Medical Education made the following suggestions:-

"We think the training should be preponderatingly practical in character and should emphasise sanitation and hygiene, that arrangements might be made for the employment of the trainees during the first year on work which is usually done by ward orderlies with instruction in elementary anatomy and physiology, and that one year at the close of the training might be arranged for fulltime employment under a Municipal or Government health officer. The training would therefore work out as follows:-

<u>lst Year</u> Elementary Anatomy and Physiology

Practical Hospital Orderly work

Systematic Instruction in Elementary Anatomy and Physiology, instructional demonstrations in Pharmacy, Pathology and Bacteriology. Elements of medicine and surgery (N.B. Midwifery and Gynaecology might well be omitted altogether) Clinical work in wards and out-patient departments, including Dispensing Sanitation and Hygiene under an approved Municipal or Government health officer and, if possible, additional clinical work.

It was <u>agreed</u> that in view of the fact that the Official Committee to discuss these arrangements was to meet at Fort Hare two days later a letter should be written to Principal Kerr embodying the views of this Committee. It was <u>agreed</u> that the Government report embodying the draft scheme should be circulated to members.

4. <u>DISCUSSION ON THE POSSIBILITIES FOR NATIVE RURAL HEALTH</u> SERVICES AND THEIR URGENCY:

Mrs. Rheinallt Jones reported briefly on the Conferences on Rural Health Services

- called -

called at Government House Capetown and Government House Pretoria in May and September, both of which she had attended on behalf of the South African Institute of Race Relations and emphasised the interest in and sympathy with Native needs which had been shown by the members of the Conferences. The Resolutions of the later Conference were not yet available and it was therefore decided to discuss these at a later meeting. It was, however, decided that this Committee should urge on the authorities:-a. "That the Rural Nursing services for Natives should be established as rapidly as Nurses or Nurse Aids are available". b. "That where possible existing missionary and other medical services should be used for the supervision of rural nurses". c. "That a graded scale of salaries should be established for such nursing services".

# 5. TRAINING AND EMPLOYMENT OF NON-EUROPEAN NURSES:

This matter had been partially dealt with 'earlier as regards Native nurses. Dr. Moffat reported on the difficulties as to the training of Coloured Nurses in the Cape Province.

It was resolved "that it is desirable that definite schemes for the training of Coloured Nurses be established and arrangements be made for the employment of the nurses so trained".

Mrs. Rheinallt Jones reported that with the enlargement of St. Aidan's Nursing Home there was some hope for the training of Indian Nurses in Durban. Through the kindness of Mr. Lewis Byron she was getting into touch with information regarding Indian Health needs, and hoped to report on these at the next meeting.

It was <u>agreed</u> "that it is desirable that Indian girls should have facilities for Nursing Training".

# 6. VARIOUS RESOLUTIONS FROM OTHER CONFERENCES:

As time was short it was agreed that these resolutions should be circulated. They are appended hereto.

7. MEMORANDUM "NATIVE GIRLS AND THE NURSING PROFESSION": It was agreed that this memorandum should be circulated to those likely to be interested.

8. NEW MEMBERS:

It was <u>agreed</u> to ask the members of the Committee on Medical Work of the South African General Missionary Conference to join this Committee. Also that Miss Pritchard, Dr. Stevenson Pietermaritzburg, the Matron, Ceneral Hospital, Johannesburg and the Matron of St. Monica's, Capetown. be asked to join this Committee.

9. GENERAL:

1. Dr. Simpson Wells submitted a report by the Matron of St. Monica's, Capetown on the employment of Midwives trained in the Home. Agreed to circulate. 2. Dr. Mackenzie submitted a memorandum on

Mrs. Rheinallt Jones submitted notes on Health Services in the Dutch East Indies (from a recent publication).

Agreed to circulate.

5. Mrs. Rheinallt Jones reported from information kindly supplied by Dr. Anning, on the scheme initiated by the Medical Officer of Health, Pietermaritzburg for the Training and Employment of Non-European Sanitary Inspectors and Municipal Health Assistants (male).

Noted and notes attached.

6. Mrs. Rheinallt Jones reported that a scheme for simple mothercraft and children's nurse training at the Princess Alice Nursing Home, Johannesburg, was being prepared. The intention was to apply modern mothercraft methods to practical uses in Native life, urban and rural.

7. Date of next meeting - It was agreed that as many members of the Committee as possible should be brought together in Capetown in January.
