Every Indian, no matter what his or her trade or occupation must make this conference of primary concern.

If you belong to an organisation -- sporting, social, cultural, business or religious -- your duty is to ensure that delegates are elected to this conference. Everyone of you, no matter what your views and policy, must ensure that your opinions are expressed at Conference through your accredited representatives.
