Dear Sir/Madam

It has come to our attention that your conference has passed a most encouraging resolution on community service as an alternative to military service.

Motions such as these are a source of great encouragement to us in our work. A major demand that we have made since our inception is, of course, the call to end conscription. In addition to this we have always strongly promoted the call for viable forms of alternative service for as long as conscription remains. An ECC delegation put this to the SADF's Geldenhuys Committee in August 1985. Unfortunately the Defence White Paper published earlier this year rejected any new form of alternative service. I have enclosed a copy of our evidence to the Geldenhuys Committee and refer you specifically to pp 145 - 147.

Earlier this year we ran a nationwide campaign to raise public awareness and support for our call for alternatives to military national service. Through it we went a step further than merely making calls. We involved outselves in community work projects which we hoped would serve as an example of viable forms of alternative service. The campaign was a great success with many volunteers coming forward to work on the projects. We culminated it with big public meetings in Cape Town and Johannesburg attended by a total of 6000 people. I have enclosed a pamphlet which we brought out at the time of the campaign which will provide you with more details of the projects we ran.

A long and warm (but not quite hot, if you know what I mean) Fall is turning into Winter, quickly now reminding us that 1987 will be a fast-paced year, that the '80's are turning into the '90's at an ## alarming rate.

Page 3 of the N.Y. Times reports: "Leaving South Africa Increasingly Alone With It's Troubles" in re: IBM & GM, and I cannot help but shift quickly to business - my frined, confidant, dear Laurie.

Just spoke to Ivan Toms, he'll pass the message no, and Ian Linden earlier this week, for another message passed. Your letter arrived two days ago, not dated, but clearly fresh - straight from Graceland.

How can I explain completely, the problems put forth by your letter? Of course I understand your problems (w/PFP and perceptions at that end, and the increasing attacks, etc.), but I cannot help but really feel that with a possible Aida Parker victory for ECC, and Dominique still on hold, you can only lose by backing ECC into the single issue legalistic c-rner, away from your natural allies. If they want to ban you that much, they'll ban you anyway. From that end, as I say, I understand the absolute need for the greatest possible political breadth - and you and I and Gavin and I discussed (and must continue to discuss) legalistic and the propogandistic ways of making the package acceptable for folks at home.

But from this end, my friend, it is absolutely impossible for us to do a successful tour without putting ECE firmly in the context of the wider movement, which is led by UDF. Without UDF, American Committe on Africa will pull out of the coalition immediately. Though Bayard would be thrilled, no significant Black leader - grassroots or governmental -would have high level meetings with you. Advances within the white "mainstream" (to the extent that this actually exosts) would not be forthcoming. Ivan has tilled that field, and Gavin the more progressive end of it, but the next step must be with taken with your Black counterparts in the legal organizing sector.

On the ohher hand, a joint tour, as I and the WRL and the ACOA leadership now see it - would be a unique opportunity to present to the U.S. movement and people (for the first time in years and years) representatives of South African activists - the spectrum of people, Black and white - who are actually strugglind legally within South Africa today. We are clear that ECC could not and would not meet with or share a meeting with any organization that was not legal, or with any banned movement, even if the UDF, at times, would. But to present the legal spectrum - Black and white representatives together - to activists here, would indeed be a first, and an historic moment for the peace and anti-apartheid movement here to go beyond disinvestment towards direct links and support work. The myths of: the military, Black vs. white, Black on Black violence, etc. could be addressed as never before.

Let me make clear that what we're envisioning and hoping for is a large scale "events" oriented tour. A meeting with the Mayors of Atlanta, Georgia and/or New Orleans, Louisiana, getting the key to the city; with speacial Senate and Congressional caucuses in Wash. D.C.; large meetings in NYC and San Francisco and elsewhere; some stops in the deep South; press conferences and cocktail parties, etc. etc. We've already started the planning since the go-ahead from Gavin last month, and as the days go no on, more planning is being done. Tomorrow night there's an internal WRL meeting to discuss our role at the next coalition meeting, and to help plan for a special "Racism and Militarism" educational packet that we're producing for the tour. Next Monday another meeting with ACOA and CALCL will discuss fundraising, and will confirm cities and dates (which we've tentativeley set, if o.k. by you, at March 5 - April 5).

So I need word immediately on what's on or off. I hope that it is more a question of legalistic and logistical manuscring than a cancellation. But a 'by chance' occasional meeting with UDF tour scheme will not work. We'll hold off (maybe permanently) at rpinting UDF/ECC TOUSTATIONARY, but the tour package, from this end, needs to remain pretty much intact. Maybe folks (ECC?) need to travel in their individual capacity?? Though even this, I think, would be a drawback, and of course I and WRL would be disappointed if ECC couldn't come "officially" and in an organizational capacity.

There's <u>much</u> to be gained at hhis time as far as international solidarity. I hope that we can figure out a way out of this problem.

So much for hurried business. The book looks exciting.
And the thought of you as close by as England is exciting, indeed.
I've already passed the idea along to one good \$ source, and will work on others in time. Marie and I are well, WRL is getting geared up, Susan S. is in Costa Rica, the New York Mets baseball team have won the "World" Series, and the November mornings are cold, even under my Indian shawl. Be well, my dear friend.

Motivation from the Cape Town ECC for Nic Borain for the position of National Organiser

Nic Borain has been the ECC chairperson in Cape Town, a position he has held since November 1985. This period has seen the continued growth of the ECC in Cape Town as well as being marked by the second State of Emergency. Nic has responded well and adapted to both situations with his leadership qualities and organizational skills being an asset to Cape Town's ECC.

Nic is well qualified for the position of the National Organizer in terms of the political training he has received through a period of being involved in a variety of political areas. Nic was a student at UCT where he was actively involved in various SRC subcommittees. In 1982/3 he was the editor of the student newspaper 'Varsity'. In 1984, he was the President of the SRC and commanded the respect of a broad range of constituencies, both on campus and off. In 1985 he worked at Nusas Head Office as Secretary General. After the first State of Emergency was declared in Cape Town in 1985, he assumed a leadership role in a broad coalition of 23 'white' organizations, formed to protest against the Sof E. In other forums as well, Nic is consistently perceived of as being a leadership figure. He has a particular ability to work with a wide range of different people from varied organizations as a result of an unalienating disposition.

During Nic's period of being involved in the ECC, a broad range of qualities has been consistently evident. He has excellent organizational skills in terms of a good understanding of and a sensitivity to the functioning of a healthy organisation. As a result, he has been able to deal successfully with a number of sensitive and difficult situations. His presence on the Cape Town executive has served as a source of inspiration to many of the Exec members. His leadership qualities were particularly well utilized during the new styles of organisational operation that emerged during the present S. of E.

As an organizational figure, Nic is approachable, respected and well liked by CT ECC activists. He has an air of quiet confidence, is hard working and is dedicated to the democratic processes in ECC. A particularly important quality which Nic possesses is an ability to impart his particular skills. He has a notable insight into the importance for and the need of passing on particular skills and the training of activists. This relates to both organizational skills and the development of a broader political understanding.

Possibly one of Nic's most important characteristics is the particular vision that he articulates. He has an unsurpassed vision about the ECC in terms of its inherent potential and the particular role of the ECC. His optimism and enthusiasm about ECC has inspired many Cape Town activists.

Linked to this, is Nic's sharp and incisive political understanding of the struggle in South Africa. He is well informed politically as a result of the links he has had over a number of years with activists working in different communities in Cape Town. He has also developed national contacts and understanding during his year in a national position in Musas. His political understanding has been particularly useful over the last year for the ECC. Nic is undoubtedly a superb candidate for NO.

As you've probably both heard, physical attacks have been on the increase, with Pete Hathorne beaten up twice in the last month, his girlfriend badly beaten with sjamboks, an East London member shot in the back, and another E.L. member's car blown up. Ominous signs of an ominous time.

On a brighter note, we ore two days away here from what will probably be the largest anti-apartheid demonstration in U.S. history. Possibly over 100,000 people will come together from Harlem and the U.N. to a public rally in Central Park. The organizing force behind this has been DC/65 United Auto Workers union, who have pulled together a strong labor movement grouping, with the active support of student groups, churches and the usual peace groups.

Well, I trust that all is going well and busy with both of you. Keep in touch; I look forward to hearing about the activities of both CIIR and IFOR.

UPDATE ON ECC

Hello all.

This is a general pulling together of different areas of ECC work nationally at the moment.

For a campaign that is essentially between focuses at the moment we are amazingly busy. Of course this is largely due to the actions of the state in its mad path of destruction through Southern Africa. Rambo lives! A large part of ECC work over the past ten days or so has been devoted to responding to the raids. Action in protest was so widespread that it assumed the proportions of a national ECC campaign. Snappy responses in most of our regions ensured that ECC was at the forefront of protest.

There are two other major items on the ECC National agenda at present. The first is the issue of the widespread harrasment of ECC and the other is the planning and build up to the July call up. Although no region has finalised its plans yet for the call-up campaign, developements are such that we are set to have a vibrant and forceful campaign nationally. A particular trend that is emerging in the planning is a move towards creative action around this campaign. This adds to a lot of our established patterns of organising at a public level.

On the issue of the attacks on ECC I refer you to the letter of motivation for action as well as the update below.

What follows is a rough and uneven account of developments in the regions at present. I apoligise to regions for leaving areas out. This would be more in ignorance than deliberately.

Johannesburg

Jo'burg responded to the raids with media as well as a lunchtime meeting. Pickets, stickers and posters were produced and distributed very quickly. The public meeting held in a central city venue was attended by about 100 people.

End Conscription Campaign

Paul Goller of ECC chaired and the speakers were Steve Lowry, Philip Wilkinson and Curnick Ndlovo (UDF). The loony right used the occasion to make a bomb threat but the people at the meeting voted to ignore it and to continue. 1.00pm, the time at which the supposed bomb was meant to explode, came and went without incident.

ECC has started to plan for the call-up campaign, although the breathing space between campaigns is being used to consolidate sub-committees, for education, etc. A very successful workshop on "the conscript" was held last week which looked at the position of conscripts and CO and the law. What made it a memorable event was the sharing of stories by two vets at present studying at RAU.

ECC on campus is busy with a focus week on troops in the townships. It will consist of low profile events (video shows) as well as high (a rally on Thurs day). Last Friday night saw a very successful ECC concert on campus attended by about 400 people.

Stellenbosch

The big issue at the moment is the university council's ban on ECC. A lot of energy is being put into reversing the ban. A petition calling on the university to recognise ECC's right to organise is being circulated on the campus. A letter has been sent to the university council by ECC calling on it to reconsider its stand.

A group of 31 academics have endorsed a statement in support of ECC and it is hoped that the University Lecturer's Association might take a sympathetic stand.

If you can it might be useful to get the SRC of your local university to pressurise its admin to call on the Stellenbosch Council to reverse its decision. The Stellenbosch SRC has said that it might help. Even though it does not support ECC's aims it does recognise our right to exist and organise. The same is true of the Stellenbosch student parliament.

As if Stellenbosch ECC does not have enough on its plate it has taken up the issue of organizing support for Crossroads. ECC people have spoken at churches and resses and have collected a load of material. It has also been organizing people to go to Crossroads - as a white presence - to keep the security forces at bay.

Port Elizabeth

Work is going well. A General Body meeting of 25 people started working on

ideas for the call-up, around Philip's trial, and the survey. Sub-groups are taking forward the plans. The Port Elizabeth group is growing and is being consolidated.

Work on the creche in Walmer carried on last weekend. A picnic for Walmer and ECC people is to happen soon. Also planned for P.E. is an NVDA workshop for mid-June.

Grahamstown

Campus ECC held a successful focus week last week. It started with a cheese and wine at which videos were shown. A meeting to protest at the raids was held on the Tuesday evening. Nic Borain spoke at it. Anti-war videos were shown on the Wednesday. On Thursday there was a panel discussion organised by the Christian affiliates of Campus ECC. This was on the topic of The Christian and War. This Saturday there will be a fare/concert organized jointly by Grahamstown and Rhodes ECCs.

A planning workshop was held this past weekend. It presented an opportunity for everyone in ECC to get together and have a good general discussion. Sub-committee work is underway with the schools group having already adressed a few school groups. Churches too is getting into gear. Contact has organised house meetings and meetings with affiliates. Rape Crisis has expressed a lot of interest in getting involved.

Other plans include an NVDA workshop jointly hosted by the Sash, as well as preparing ECC input to the Grahamstown festival. The festival coincides with the call-up and so will provide a very useful focus for ECC activities.

A number of fake/smear pamphlets attacking ECC have been distributed in Grahamstown. These are covered in another section below.

Cape Town

Much of the recent work has consisted of responding to the raids. Pickets and pamphlets went out and a public meeting was held. The meeting was jointly called with the UDF (Observatory and Claremont) and the Black Sash. Nic chaired and speakers included Prof Savage, Mary Burton, Philip Wilkinson and Cheryl Corolus of the UDF. About 500 people attended. A rally adressed by Chippy Olver was also held at UCT.

This week CAG on campus are holding a focus with the theme "Botha we have had

enough". Open air drama, a debate in a res, an advice bureau presentation and a rally all form part of the weeks activities. A banner with the slogan "If we had the choice, we would not go into the townships" is to be displayed. Students will be asked to endorse it by making a mark on it. This "petition banner" will then be presented to the press.

Other activities in Cape Town have included an ECC weekend away and ongoing sub-committee work.

Pietermaritzburg

Responding to the raids has also been to the fore in 'Maritzburg's recent work. There were street pickets, an ECC speaker at a black student meeting on campus, as well as a joint ECC/Sash/PACSA meeting at lunchtime on Friday in town. Jac was the ECC speaker.

Ongoing work is concentrated on consolidating the group of people who joined the work projects during the WJP. To this end there was a very successful afternoon workshop attended by about 35 people. It was an introduction to ECC as well as a brainstorming session for the call-up campaign.

Durban

Emphasis at the moment is being placed on smoothing out the coordination of the organisation as well as education and training. Thought is going into the possible establishment of a contact group.

CAG on campus has changed its name to ECC and is to structure itself as a front. The name change is to ensure that ECC gains in profile on campus. The group recently had a weekend away.

There was also a response to the raids in Durban. This consisted of street pickets (some of which were torn up by overzelous right wingers) and the stringing of a 15 metre long banner across a major highway. It carried the slogan "We say no to SADF raids -End Conscription Campaign". It stayed up for an astonishing 15 minutes.

East London

E.L. has had its second monthly meeting. It was a focus on troops in the townships withspeakers giving a national perspective as well as a local one. The next meeting is planned and will have as its topic CO and the law.

Philip Wilkinson

Philip appeared in court on Friday June 23. He was not asked to plead and his case was remanded until July 29. At present he is preparing his case together with the lawyers. The idea at present is that he will be running a high profile defence i.e. with a Bishop or Archbishop of the Catholic church, a soldier, a township resident etc. giving evidence. Regions should consider ways of giving support and raising public awareness.

Harrasment Update

Since the last NC meeting there have been a number of instances in which ECC has been threatened in various ways. You should already have recieved the motivation I sent out for action in response to the harrasment.

Since Malan's last attack on us which was at the same time as Barabara Orpen was attacked in Port Elizabeth there have been a number of instances of harrasment. I've drawn up a list of those that I know of.

Grahamstown has had a spate of smear pamphlets and posters which came out to coincide with the Campus focus week. Items were:

- A poster advertising ECC's fare was put up but it had the wrong date on it.
 This was an obvious attempt at disinformation. It had the slogan, "Secure a better future conscript" printed on it. This came out on Saturday 17 May.
- 2) On Monday 19th hundreds of photocopies of the Aida Parker Newsletter were spread throughout Rhodes campus.
- 3) On Tuesday '20th a pamphlet in the style of an earlier ECC one came out. It had an image of a dove on it with the title "War or Peace?". Slogans
- on it included "End the Call-Up and Peace flies out of the window" and "Choose to reject the ECC". It was put out in the name of the EECC (End the End Conscription Campaign) and used the ECC chain.
- 4) On Friday 23 ECC blitzed town with the Philip Wilkinson pamphlet. A while later a similar but larger pamphlet came out with a picture of Philip and the wording "Philip Wilkinson Conscientious Objector or Coward?" printed on it. It was also put out in the name of the EECC.

All of this media was crudely produced. It was typed and blown up on a photocopier. All had been photocopied.

During the pickets in Durban, Maritzburg and Jo'burg picketers were harrased by police, pickets were torn up, names and photographs were taken, and one picketer was arrested and held in PMB for a short period.

There was a bomb threat at the Jo'burg public meeting and a large police presence at the Cape Town one.

A new edition of the Aida Parker Newsletter has been released with an article on Gavin's tour in it. We have also heard that the Afrikaans daily Beeld has taken official policy not to carry any ECC stories.

Finally, on the 8.00pm TV1 news on Tuesday 26 May a Mrs Malan, who heads the 500 000 strong Vrouefederasie was interviewed. She was commenting on the VFs concern at the "revolutionary situation", and the "Marxist onslaught" against South Africa. A large part of her comment was devoted to the ECC which she described as cowardly, as working to prevent their sons from going to the SADF, and as working under the guise of seeking peace. She called for something to be done.

It is important that we keep one another informed of developments like these in the regions.

Op Manouvres

Two significant developments in the SADF have become evident of late.

The first is the widespread mobilization of the dad's army especially in the rural areas of the Eastern Cape. Some units have been mobilized for early June (possibly to coincide with June 16), while in others men have to register by July 1. The operation to mobilize these units is officially known as Operation Buttermilk. It's their idea not ours so dairise it.

I have had one or two indications that campers are being specifically called up for duty around June 16. In one case a man was called up to do a case in Alexandra township. Have you noticed similar developments in your areas? It would certainly be useful to monitor these developments and possibly act on them. Action could possibly be linked to the call-up campaign, and in this case specifically include appeals directly to campers and a strong troops out call (possibly the troop stayaway call).

A final bit of news of a military nature is that a couple of soldiers have sent us letters asking whether they can join ECC. Interesting wouldn't you say?

Women and the Military

This was an area of considerable informal debate at the National Committee meeting. I've enclosed a few papers which can form the basis of further discussion in the regions.

Cultural Festival Speakers

NC came up with a few suggestions of foreign speakers. They are Joan Baez (veteran US peace activist, singer and chairperson of Humanitas International a US based civil and human rights monitoring group. They have sent us messages of support as well as a small donation in the past.), Bruce Kent (senior person in the British Catholic Church and very highly respected international peace activist. He was the past General Secretary of the British Campaign for Nuclear Disarmament.), Petra Kelly (a leading member of the German Green Party. The Greens are an activist-type political party which take up issues of ecological and social concern.), Pérez Esquivel (renowned Argintinian advocate of nonviolence and winner of the 1980 Nobel Peace Prize. He has along history of involving himself in struggles throughout Latin America. He was imprisoned under the regime of the generals in Argentina.), Ngugi wa Thiongo (Kenyan author with a long history of involvement in the struggle for justice. He was imprisoned for his political activities in Kenya), and Thomas Mapfumo (a Zimbabwean musician who was famous during the chimurenga for the songs of liberation that he composed. He was imprioned too for a number of years by the Smith regime.).

Be free to add to the list. We need however to have a list of 3 or 4 that we can prioritise and send to CIIR to follow up for us. Could regions consider the list and give their priorities.

National General

- 1) I have not been receiving minutes from the regions. Please send these to me.
- 2) Could all regions send me copies of their pressclips from the beginning of the year until now? I want to pull the lot together and compile a bound volume of all of our coverage until now.
- 3) Please send your call up campaign ideas to other regions, and also ask regions

- 4) Some regions have given me responses on certain issues that require national decisions. Here is the complete list on what we need answers on. Please let me know your regions feelings on them very soon.
 - a) Barbara Friedman to do the CIIR research job.
 - b) We require your list of nobs who have signed the statement of demands by the 5th of June.
 - c) Your list of local welfare, church organizations etc.
 - d) What does your region think of a "Troops stayaway from the townships" call.
 - e) Any ideas on the proposal of a "peace walk" raised at National Committee.
 - f) Could you forward names of anyone doing research in your region on the psychological effects of militarisation.
 - g) Have you discussed the idea of another National Organiser?
 - h) Could you please pull together a list of the names, adresses and phone numbers of your sub-committeco-ordinators?

If I can't dance I don't want to

be part 1989 of your revolution



Emma Goldmann, the Russian/ American activist, summed up the feminist, non-sexist approach to peacemaking with her comment "If I can't dance I don't want to be part of your revolution". Dancing, laughing, and celebrating are an integral part of feminist peacema-king, which is the antithesis of the traditionally "male" way of resolving conflict with violence and domination.

Peacemaking means beginning to live the new society here and now. It means learning new ways of being, which recognise the dignity of the individual and respect group integrity and liberty. How can we put these ideas into practice, given the hostile and unpeaceful environment in which we live?

We can start on an inter-personal level: developing relationships that are not dominating, unequal, or characterised by sex-role stereo-typing. When we are familiar and comfortable in one-to-one relationships that are respectful of the other person and liberating for both individuals, we will be able to work like this in our crganising and group work.

In groups, we could develop simple ways of controlling personal sexism and dominance: by rotating facilitators rather than having chair-people, each person round a circle sharing in an allotted number of minutes, consensus decision-making, rotating of functions within a group, and the sharing of skills and child-care. When our relationships and organising style reflect these new ways of being, then our care in society to change will have that such more credibility.

These are all important steps. But we also need to identify and confront the attitudes which are at the root of relationships based on dominance and submission. Unless we develop new ways of thought and action, we will simply be playing around with the old system.

One important area is that of symbols and language. If we continue to use the language of war ("my room looks as if it had been hit by a bomb", or "X is a walking minefield of problems") we continue to give legitimacy ato the methods used by armies and governments to control and dominate ordinary people like ourselves.

Language which recognises that maleness is the norm for humanity (eg. using "mankind" where "people" are meant) needs also to be changed, to demonstrate our belief that all human beings are created with equal beauty and potential. "We can best help you prevent war not by repeating your words and following your methods but by finding new words and creating new methods". (Virginia Woolf)


Feminist, non-sexist peacemaking takes very seriously the threat of nuclear annihilation, wars between nations, civil war within a nation-state, and oppression in its many forms precisely because feminists know the effects of domination and oppression at first hand. But, in opposing all that is destructive, peacemakers want to create and live the new order.

It is not enough just to pull down old structures - we should be building the new as we go along. And so peacemaking can be creative, spontaneous, and fun. It can involve all who wish to be part of building the new society - it does not discriminate against women, children, the aged, the handicapped, etc.

The peace camps at US Cruise missile bases in Britain are an example of the commitment of peace activists: "I've been accused cobeing cruel and hard-hearted for leaving my children behind, but it's exactly for my children that I'm doing this. In the past, men have left home to go to war. Now women are leaving home for peace". (Sarah Greenham Common Peace Camp)

This article by Richard Steele and Anita Kromberg — the first of two articles — argues for a particular understanding of the relationship between "militarism and patriarchy". In doing so it poses the question of the effect on women of militarisation, an area which OBJECTOR has not examined in much depth. Responses from readers are welcomed, as any debate would broaden our understaning. The forthcoming article will look at non—sexist strategies for peacemaking. most explicit illustration of the

alliance between male sexuality, male dominance and the military mentality is. rape in warfare. Where rape is the ultimate sign of the virility and dominance of the conqueror. Rape by soldiers in the operational area of Namibia and by police in the townships is common. (see the Report on Police Conduct during Township Protests, by the Southern African Catholic Bishops Conference). To quote Susan Brownmiller: 'rape by a conquering soldier destroys all remaining illusions of power and property for men of the defeated side. The body of a raped woman becomes a ceremonial battlefieeld, a parade ground for the victors trooping of the colours' (p31).

The military encapsulates patriarchy because it desiberately fuses male sexuality with aggression and dominance.

Any soldier who has done basic training can give examples of this correlation. A common chant goes, 'This is my rifle, is my gun, the one is for killing the other's for fun', as the soldiers slap their rifle and crotch in turn. On the one hand woman are a prize to be sought after and fought for if neessary), on the other hand they epitomize all that is weak and despicable - one of the worst insults for any soldier is to be called a 'sissy'. Whichever way they are viewed, woman are to be 'conquered' and dominated.

The military functions not only as an armed force, but as a powerful reinforcer of patriarchal values and attitudes. If we are serious about overcoming female oppression, then we must address militarism as well. If we are serious about overcoming militarism we must address the problems of male domination and female oppression. We can take control of the kind of values and attitudes we display in our everyday lives and in that way rob the military and patriarchy of valuable psychic support.

Here, the ECC and the COSG's perform important functions: they are concerned with the broad political scene, but are potentially a community within which individuals can learn and practise on an inter—personal level what we are calling for on a macro level. We must challenge the attitudes and practises in our daily lives, to authentically challenge these patterns more broadly.

This article has focussed on militarism and its connection with patriarchy. We do recognise that in South Africa sexism is compounded by other factors such as racism, generating a particularly violent pattern of domination. We believe too that there are structural and psychic links between all forms of oppression (racism, sexism, class exploitation, ecological destruction, etcetera), so all forms must be addressed in order to achieve liberation, justice, equality and peace.
