1. Graag wens ek te bevestig dat bogenoemde, vergesel van haar eggenoot, Lionel BERNSTEIN op 4.8.1964 uit die Republiek na Betsjoeanaland gevlug het. Op 17.8.1964 het hulle die Protektoraat verlaat op pad na Noord-Rhodesië en uiteindelik vermoedelik Engeland.

2. In agneming van die feit dat hierdie persone die land uitgevlug het terwyl inperkingsbevele teen hulle van krag is en waarskynlik ook sonder geldige reisdokumente, kan met sekerheid aanvaar word dat hulle nie in die voorsienbare toekoms na Suid-Afrika sal terugkeer nie.

3. Ek gaan dus akkoord dat geen verdere stappe ingevolge Artikel veertien van Wet 44 van 1950 teen bogenoemde geneem word nie.
