He was somewhat astonished at the inconsistencies in the evidence. and had expected slightly more unanimity in the police evidence, the Magistrate said in the Regional Court here last week when he found Richard Mhlobiso and Jim Phillip not guilty on a charge of public violence, or alternatively, assault with intent to commit grievous bodily harm.

Blames Police

Giving judgment, the magistrate said that no reliance could be placed by the court on Sergeant Laubscher's evidence of identity.

Outlining the course which the defence would follow, Mr. V. C. Berrange, for Mhlobiso, declared that the wrong persons were standing in the dock. "The police should have been standing there, charged with attempted murder," said Mr. Berrange.

On Friday, pay-day, last week police parties were sent out into seven of the city's northern suburbs to round up "loiterers."

In Louis Botha Avenue, the city's busiest thoroughfare, they chose the peak traffic period to stop every single African bus and taxi and car carrying African passengers and to search everyone indiscriminately.

DISLOCATION

The traffic was completely dislocated. Taxis and cars carrying Africans were diverted into a side street. lined up, and then searched methodically by the police.

Entering the buses, the police went from passenger to passenger demanding his pass book and other documents.

Troop carriers stood by to carry the arrested to the cells.

The buses were thrown off their schedules and Louis Botha Avenue was choked with traffic and searching police.

Police also entered flats and houses and rounded up Africans walking in the streets.

After the operation the police announced their "catch": 500 Africans arrested for being without passes and trespassing. The highest number of arrests was in Norwood: 166. Arrests for the other areas were: Hospital Hill 35; Yeoville 23; Rosebank 60; Parkview 50; Ferndale 47; Craighall 37.

These raids, which make criminals instead of taking them, must stop!

No African got by. Police were at the bus stops, in the buses, on the pavements to stop every soul in sight. "Pass," they said.



THE ONLY REPLY TO THE BANNINGS

On May 29, before breakfast time, a ban was served by the Minister of Justice and delivered by the Worcester Special Branch of the police on Kaiser March, an old A.N.C. member and defender of the human cause in this area. It was served under section 5 of the Suppression of Communism Act.

I do not know this gentleman as a Communist nor does any member of the A.N.C. Nevertheless the ban prohibits him from any gathering for a period of five years. We were not a little shocked because we know that anyone in the struggle for freedom is termed a Communist, not necessarily because one was a member of the Communist Party of South Africa but simply to hold back the fast on-coming freedom.

Now if the Communist Party was dissolved why should it be necessary to hunt for its former members? Does not dissolution mean death to any organisation which once existed?

I am sure this banning and much talk about Communism makes more Communists out of people because what is dead cannot be killed a second time, but the possibility for revival is thereby more and more ascertained.

Poisonous Snake In Your Pocket?

In view of the fact that there is really no hostility between black and white people in South Africa, but between right and wrong, e.g., between God and the Devil, I appeal on behalf of the Cape A.N.C. Women's, League to our honourable Native Commissioner to come to our rescue from this most destructive law - Passes for Women, all summed up in the Identification Books.

Asking anybody to take any kind of a permanent pass document is like forcing a person to take a sharp knife for cutting his or her own throat. It is the same as forcing a human being to take and put a poisonous snake into one's pocket.

EDITORIAL THE COLOUR BAR IN SPORT

The international cultural and sporting boycott of South Africa is spreading. First the British Musicians' Union decided not to permit its members to tour South Africa if they were required to perform before Europeans only. Then the International Table Tennis Federation disaffiliated the Europeans-only South African Table Tennis Union; from now on South African table tennis will be represented abroad by the non-colour-bar South African Table Tennis Board, without whose permission no visiting teams may visit this country.

Last week-end the Federation of International Football Associations met in Lisbon to decide whether to recognise the Europeans-only or the non-colour-bar South African soccer body. Although FIFA adopted a compromise to postpone a decision for two years, the issue is becoming clear. World opinion is hardening against the apartheid policy of the Nationalist Government, and in many spheres men and women of goodwill are taking action to ensure that those in South Africa who support the policy of White Supremacy understand that they are outraging the conscience of civilised humanity.

It is rather pathetic to hear the chairman of the Europeansonly South African Table Tennis Union complaining that "this whole question of admittance to the Federation has not been viewed by them (the international federation) in a factual and sporting light, but that other influences have played a predominant part in leading them to their decision.'

The time has come for the White Supremacists to understand that in the view of the majority of mankind, to enforce a colour bar is definitely not "sporting," and that the world's sportsmen are not going to make themselves a party to the enforcement of the colour bar in South Africa. It is no use the White Supremacists pleading that sport and politics don't mix. In South Africa politics is killing sport. Jake Tuli has to go to England before he can become an Empire champion. Barefooted Steward Monageng can break the South African 3-mile record by 21 seconds, but has no chance of representing South Africa at the Olympic Games. A Non-European soccer team was refused passports to make a tour of India.

Is this "sporting"? The White Supremacists must not hide their prejudices behind the cry of "sport for sport's sake." Nor must they seek refuge in the excuse that they are not allowed by law or the Government to play against Non-Europeans.

If all White sportsmen accepted the principle that sport should know no colour bar (and in the international arena it doesn't), they could soon enough compel the Government to change its policy, or else throw out this Government and bring in another one which would.

Meanwhile it is clear that the continuance of the policy of apartheid is going to lead to the ever-increasing isolation of white South Africa from the rest of the world, in the same way as sick people are isolated so that they cannot infect the healthy.

It remains only to emphasise that while this isolation will prevent the spread of the disease, it will not cure it. That job will still have to be done by the South African people themselves. We welcome these international demonstrations of support for the cause of democracy in South Africa. But they should not make us complacent, or even hopeful that our deliverance will come from outside our borders. Rather should they encourage us all to intensify the freedom struggle in South Africa until we ourselves can break the chains that bind us, and go forward as free men and women to greet our friends abroad as reguals.

Let All Workers Unite

Since the Nationalists took over in 1948, the United Party has failed hopelessly. Instead of reorganising themselves, they are wasting time by bluffing the country that they will one day become the Government. But they have no policy, and so have been unable to convince the electorate.

The United Party cannot tell the country what is their trade union policy. Are they for recog-nition of African trade unions? No, it seems their policy is the same as Mr. Schoeman, former Minister of Labour, who said African trade unions are detrimental to the interests of South Africa.

It should be possible for all, including the United Party, to work for the implementation of the Freedom Charter. As far as the Africans are concerned South Africa has long been a police state, and now the Coloureds are going to experience the Nats' dictatorship.

I urge all readers of this paper, irrespective of the industry they work in, to hunt for and join the trade union. Without unity of the workers, South Africa is going towards slavery again.



Instead of receiving £8 per month as her letter of appointment stated, Miss Makhunga alleges that she re-ceived only £5 9s. 7d. for the first three months of her employment and for the following three months an additional £1 4s. Od. was paid to her as "infection allowance."

Thereafter, her wages fluctuated each month between £7 and £8 0s. 3d.

per month. Other nurses interviewed by New Age made similar allegations.

BAD TREATMENT

"It is not only the question of wages that is the cause of the present dispute," said Miss X----, one of the nurse-aides who has refused to accept her wages, "it is the way we are treated generally by the hospital authorities."

Listing a number of complaints of discriminatory treatment, Miss X---- said: "When we go on leave deductions are made from our holiday pay for board and lodging for the period we are away on leave.

"European nurse - aides receive nearly four times as much as we do in cash wages. Apart from this, the food we receive is far below the standard received by the European nurses.

we have to provide our own forks,

with maids to do this for them.

FEAR VICTIMISATION

Asked why the Indian and Col-oured nurses had not joined them in the dispute with the authorities, According to Miss Makhunga, Miss X—— said that the African nurses had deliberately asked those wanted to join with them not to do so as they were so few in number that they might be victimised.

"In fact," said Miss X----, "we had to persuade one of the Indian nurses who joined us to take her wages as at this stage we do not want anyone to lose her job."

Deported From The Place He Was Deported To

JOHANNESBURG.

Mr. Robert Dumah, veteran African leader from Klerkslorp who was deported from hat town to his birthplace mzimkulu, cannot be found anywhere by his family and legal representatives.

Although he was preparing an application to the Supreme Court for an interdict restraining the Klerksdorp Council from deporting him, he was taken into custody and sent to Umzimkulu before he could sign his court petition.

His legal representatives contacted the Native Commissioner at Umzimkulu, asking him to forward a letter to Dumah. The Commissioner replied that Dumah had arrived in the district two days earlier, but that as he was registered as a taxpayer in Klerksdorp, he had sent him back there! His family has had no word from him since he was escorted from Klerksdorp.


