A REPORT to the United Nations that the banned Mr Robert Sobukwe had suffered a beart attack was vesterday dismissed as "malicious" by a close

friend.

The report was made to the Special Committee on Apartheid by the Pan-Africanist Congress representative, Mr. David Sibeko, after the committee had agreed that South African diplomats at the UN be replaced by "Irberation movement" delegates.

Mr Sobukwe, founding president of the outlawed Pan-Africanist Congress, may not be quoted because

the banning order in ce against him But a close friend, Mr Achnied Laher, confirmed that he was well.

"I spoke to Robert today and he is 100 per cent well," Mr Laher said, "I told him about the report and he had a laugh, It is just a malicious report."

Mrs Veronica Sobukwe, wife of the banned African nationalist, left South Africa for the United States on Tuesday to visit her two eldest children who are studying in Atlanta, Georgia.

The UN committee also heard that Robben Island prisoner, Govan Mbeki, was seriously ill and decided to ask the International Red Cross to investigate the matter.

A member of the banned African National Congress, Mr Mbeki, 64, is serving a life sentence. There have been persistent reports over the past few months that he is very ill.

But the Chief Liaison Officer of the Prisons Department, Colonel G. L. Steytler, said yesterday: "It is absolute nonsense to claim that he is or was seriously ill." Robert Sobukwe Papers
