1. Finances :

- each region needs to submit a proposed budget for the next 4 months.
- a copy of the books/bank statements/etc for the last 6 months to be submitted to the antional treasurer
- recommendation that each active ECC member pay R10 per month on a stop order basis. This is only a recommendation and must not be seen as a condition of becoming a member. Howver the recommendation was a strong one.

# 2 Idasa :

A recommendation that ECC can accept financial assistance from them on the basis of a specific project or when embarking on a co-hosted event.

- 3. PFP Relations : where there are regional difficulties, those regions should consult with the respective PFP reps and also be able to give a national picture of the relations with the PFP - these are generally quite good. We would consult with the PFP as we would any of our other member organisations.
- 4. Academic book on ECC : A reference group be set up in Grahamstown for the academic doing the research to use and for ECC to have some control over the process. Also to be able to keep other regions informed as to the development of the project.
- 5. Each region to discuss numbers needed for the distribution of the Phillip Wilkinson Trial booklet and give info to Adele.
- 6. A recomendation was made at the December 1986 NC that to facilitate the smooth employment of national office workers, the regions must have had their exec elections prior to the national elections - due towards the end of the year.
- 7.Eastern Cape to send a proposal to all the regions motivating for an Eastern Cape Organiser
- The 3 national workers were mandated to draw up a proposal for ECC's national structures, looking at our organisational needs, etc and to be sent to regions for discussion.
- 9. ECC national office workers to set up a meeting with the national executive of the UDF for a thorough consultation.
- 10.JHB ECC to meet with the UDF and COSATU National executives, with Cape Town setting up a meeting with Idasa and national office workers meeting with Nusas.

TASKS (contd) .....

- 11. Need to consult with other organisations in our regions on the issue of the Commission of Inquiry and waht thier response will be.
- 12. SACBC Alternative Service Proposal :

Johannesburg and Pretoria ECC members to represent ECC at the meeting on 31 August 1987.

- 13. VVAW Tour :
  - To get more information on the aims , structure and purpose of the organisation.
  - for regions to discuss more fully how they can use the tour, where they want the speakers to be, etc. We need to define more clearly what we want out of this tour.
- 14. Sue Lund Campaign :

Each region to take up this campaign as is appropriate for the region. Some regions will work in conjunction with other organisations such as the Black Sash for the release of all detainees, others will encourage ECC members to write letters of support to Sue and express concern to the Minister of Law and order.

- 15. Southern Africa WJP Project needs to be discussed more fully in all the regions to enable CT to go ahead with the feasibility study and explore the logisitics of such a project.
- 16. Memorial Proposal to be discussed as a natioanl project.
- 17. Regions need to discuss whether we go for an open and secure conference or a very secret and secure conference with no chnge in numbers which is BIG.

## Tasks from October 1987 NC.

- ECC Diary will be sold at R 5.00. Regions to give approximate numbers for order through the phone around for JHB.
- 2. ECC Record project being co-ordinated by Cape Town. Regions to discuss ideas for the title and approach their local bands if interrested in par ticip ating.
- 3. ECC 1988 Calender CT will distribute orders to the regions asap.
- 4. The revised proposal of the Southern Africa Alternative Service Project has been s sent to regions and the most important p art for discussion is the practical implementation of the project and determining if we can actually tke this on.
- 5. Smears ;
  - Adele and JHB to work with the lawyers on the Women for SA document circulated in Transvaal schools.
  - Regions to check distribution of this document in other schools
  - We need to have ongoing discussion on our tactical approach to legal responses wrt smears.
  - smear updated to be given at each phone around
  - a longterm project is to collect evidence pointing to the state's involvement in thenationally co-ordinated smear campaign against us.
- 6. Survey on attitudes to Conscription

GHT will co-ordinate the project

CT will approach Idasa for possible funding of a sophisticated market research project

Adele to explore other funding sources.

- 7. Noel Stott from the SACBC to be contacted wrt indexing resources on militarisation Adele to do this.
- 8. The discussion on the Way Forward needs to be peproduced in all the regions in conjunction with the workshop that the National Organisers will facilitate.
- 9. Know Your Rights Booklet

Pretoria is to take on the task of producing this booklet and all regions must submit relevant material to them asap.

10.VVAW Tour

Adele to make contact with them wrt dates and timing for 1988.

11.Reports on working relationships between ECC nad Idasa in the relevanr regions need to be submitted by end October to Adele.

12. Southern Africa Alternative Service Project

Regions need to give a simple Yes/No decision on the conceptual aspect of this project to Cape Town and then to make reccomendations wrt dates om which to move.

- 13. ECC to sent a rep from each region and 3 national workers to the UDF white affiliates workshop in December this year
- 14. A reccomendation that in each regional report to each NC that there be a brief evaluation of the national workers.
- 15. Nominations for National Workers:
  - Nominations need to be submitted to Adele by November 1st
  - there will be regional discussion of all the names brought forward with regions needing to make decisions on who they want to take national office bearers and to do it in order of priority a 2 week period for this process.
  - if there is no concensus at this point there will be asecond round of discussion.
  - final retification will happen at the February National Conference but the final decision needs to be made by mid December 1987.
- 16. Adele to draw up a suggested format for regional reports to NC
- 17. All letters from regions University Chancellors need to be at Stellenbosch by November 2nd.
- 18.Finances :
  - regional budgets for expected expenditure for the period Jan March 1988 must be in JHB by November 1st.
  - regions must discuss the proposal for a part-time national finance worker
  - Adele to draw up a more detailed proposal on the national finance worker with suggested criteria for the type of person required.
  - each region must have a full set of audited accounts for the financial year 1987 at the National Conference in Feb 1988.
  - a group needs to get together at National Conferecne to set up financial bylaws for ECC which will be discussed and adopted at the Nat Conf.
