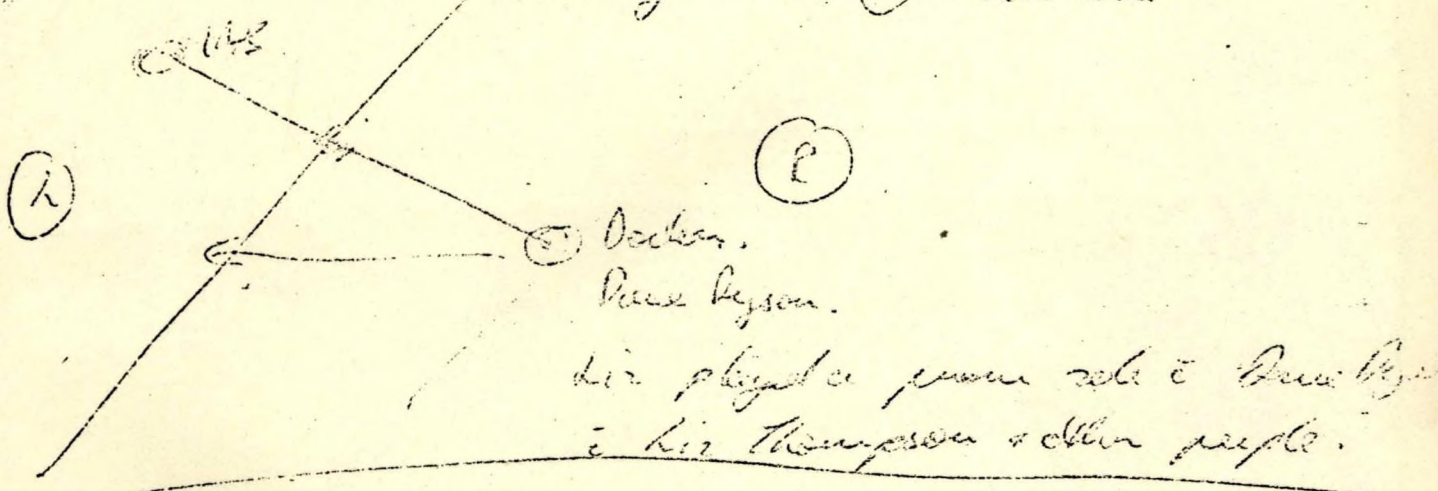

I was invited to attend in 1981, I was in favour
of it initially. Rejected the whole concept. I felt I
must work in the T.U. & do my work properly -
the T.U. basically, the whole education, work.

Wanted to meet workers secretly & see the line that S.M.C. was taking, criticize & appraise it, and the feeling was that that it was the correct position at least since S.M.C.'s reasons for going underground were that they needed organizing work, were secret organizations that couldn't be sanctioned by the state. Reason to organize w.c. into militant organizations that could challenge the existing structure of society; the present economy & the way the economy works. Through organizing workers exclusively to put pressure on the govt. by being a well organized working class. P.S.

In the last year I was building up the structure of the union - because I saw it important as working legally. I do see workers with both ^{has} communistic ideology. During this time I didn't want contact with any political organization - important to develop the union. Being involved in the A.C. was dangerous. I wanted

contact with them.

I've never been recruited, though I have
communicated ideas. Never been a member of
the S.W. S.K.T.A. and S.K.T.A. I associated myself
with S.K.T.A.
