Dear Mr. Whyte,

With reference to our request to obtain a copy of the record of the Paarl Riot Commission, my Committee, at their meeting of Friday, 8th February, have asked me to state the following:-

The Committee is unanimously of the opinion that a copy of the record is vitally necessary for Counsel. For purposes of argument it is essential that Mr. King has easy and ready access to the record. The Committee also wish to point out that the Institute is extremely fortunate to have received an offer of the record on the basis of lOc. per page instead of the normal price of 40c. per page. At the same time this expenditure should not be considered as a separate item but as part of the overall defence costs.

Lastly, my Committee is not in favour of approaching other organizations for assistance as they feel that when the Inquiry has ended the record should make a very interesting addition to the Institute's library in Johannesburg. It was therefore suggested that it should be considered whether the costs for the record might not come out of the Library vote.

As this offer of lOc. per page will not remain open indefinitely, I would be most grateful if this matter could be dealt with urgently.

Dear Mr. Whyte,

Thank you for your letter of the 21st February, 1963.

The Institute's expenses with regard to the Paarl Riot Commission of Inquiry have been causing us in Cape Town some concern. Financially we have received, or have been promised, R550.00, of which only a minimum amount of R130.00 has been received through our newspaper appeals. We have gone carefully into the figures and estimate that, should the Inquiry continue into April, which appears very likely, additional expenses for that period would be at least R1000.00. This would include the cost of the record.

It is considered that the Paarl Riot Commission of Inquiry is of great importance, especially as the Commission has given the Institute an admirable opportunity to express views that it has long held in regard to the migratory labour system. Evidence has already laid bare not only the evils of this system, but also the fact that its operation must inevitably result in corruption amongst administrative officials. Important evidence has also been revealed about Pogo.

Advocate E.L.King has not only lead evidence brilliantly to bring out the factual substance of the Institute's Memorandum, but he is also appearing for the Institute at the minimum amount of R21 per day, which is approximately one fifth of the normal fee.

The Cape Western Region has undertaken to show Sponono in Cape Town and it is proposed that this Region should keep RLOOO of the revenue from Sponono to pay our expenses at the Paarl Riot Commission. If our total revenue from the takings of Sponono does not in addition meet this year's allocated budget this Region will endeavour to find other means to meet this amount.

I write in reply to your letter of the 27th February, 1963.


I agree with you that the Paarl Riot Commission of Inquiry is of importance because it high-lights certain policies which may have application in other parts of the country. The proceedings are well reported here and Mr. King is doing an excellent job.

With regard to your proposal that you keep R1,000 from the revenue from Sponono, I should really refer this to the Finance Committee but the latter, however, does not meet for at least a fortnight. I myself would have had no objection to your doing this provided your allocated budget is also met. I feel this way because the Paarl Commission of Inquiry has national implications and national importance. I will, however, put the matter to the Finance Committe eventually.

Dear Mr. Schreiner,

The Paarl Riot Commission as you know, has turned out a much lengthier and involved inquiry than was envisaged at its start. We have been extremely fortunate in obtaining the services of Advocate E.L.King, who generously offered to appear on our behalf and that of the Paarl African residents at a fee of R21 per day instead of the normal fee of R105 per day being paid to the other advocates involved in the Inquiry. For the purposes of argument Mr. King has found it essential to have a copy of the Record which he also arranged for us at the unusually low figure of 10c. (instead of 40c.) per page.

To date the total we have received towards the cost of the Inquiry from all sources has been R1064.25. We estimate that the total expenses will amount approximately R2000.00. This leaves the Institute with a short-fall of R1000.00.

Why a lalere

We had hoped that the 'Sponono' show would provide us with a good profit and that it might be possible to use some of this money towards this short-fall. We wrote to the Director about this, but have not yet had confirmation. In any case the show has not been a success in Cape Town for many reasons, chief of which was that we finally only had about ten days notice in which to prepare everything. It looks as if we may yet have to call on the sponsors of the show here to pay up our share of the loss, if any.

At its last meeting our Regional Committee reiterated that the Paarl Riot Commission was really a national matter and that we were really acting on behalf of the Institute as a whole since we are on the spot. The Committee suggested that I should write to you to ask you whether you would not personally write to a number of persons throughout the country who might be in a position to contribute reasonably substantial sums towards the costs of the Inquiry, and appeal to them to help. We feel that such a letter would have much more effect than one sent out from this office and in any case we feel that a letter from us here might interfere with the Gifts Campaign which Head Office is preparing at the present moment.

Would you be so good as to consider this request and also discuss it with the Director and possibly the members of the Finance Committee who may be involved?

I would be glad to hear from you as soon as possible whether this can be done.



Dr. Wollheim has asked me to write to you with reference to the above.

The Civil Rights League has discussed in some detail the implications of the Interim Report and they were worried about the acceptance of hear-say evidence such as the press cuttings on Leballo's remarks being included in the record and secret evidence which may have been included in the Record, or if not may have influenced the Commissioner. The reason for our anxiety is that neither of these two kinds of evidence could be tested by cross-examination.

The Civil Rights League is also worried as to whether the Interim Report which was presented before argument was given, did not in effect anticipate the findings in certain respects since findings can only really be made after argument.

The Civil Rights League will however take no action until the final report is published.

As you may have noticed we have had to borrow R3,000 to tide us over a bad period and this will have to be paid off within the next two or three months. A new fund-raising project has been held up owing to inability to find a suitable chairman and the frequent absences of Douglas Roberts from Johannesburg.

The net result is that the sub-committee told me to write and say that we cannot find the R1,000 and to appeal to you to try Cape resources. Cannot you approach F.C. Robb whose wife is so energetic and interested. Is Clive Corder unapproachable? And there must be others, for although the Inquiry could be regarded as of National significance it very vitally affects the Cape Western areas.
