- (k) Non-European Boy's Club Association:- for a grant of £750 to enable them to equip a Boy's Club and appoint a whole time worker for the club.

IT WAS DECIDED

to grant a subsidy of a £ for £ basis up to £550.

- (l) Clements Kadali:- Reported that the Acting Manager of the Morija Printing Works had forwarded Mr Kadali's MS to the Trust with a request that the Trustees should indicate prior to calling for quotations whether they will be prepared to back its publication. The Assistant Secretary further stated that he had requested Mr Walker to read the MS through and express his opinion of the MS.

IT WAS AGREED THAT

Dr Edward Roux should be asked to advise the Trustees about the MS.

- (m) Chief Tshekedi Khama:- for a grant towards the erection of a Trades School for the Bamangwato Tribe.

AGREED to grant £2000

### 3. MR RAMFREY S. MAJOLA

The Assistant Secretary stated that Mr Ramfrey Majola had written asking the Trustees to allow him an extension of time for the payment of his account which was due in August.

AGREED

to extend his time until the beginning of the year.

### 4. LOAN TO ORLANDO COMMUNITY CENTRE

The Assistant Secretary stated that in response to a request by Dr Phillips that the Bantu Welfare Trust should lend a sum of £2000 to the Trustees of the Donaldson Orlando Community Centre, for the purpose of purchasing equipment, Lt Colonel J. Donaldson D.S.O. together with Mr Rheinallt Jones and Mr Edmunds had directed the Secretaries to circularise all the Trustees of the Bantu Welfare Trust requesting them to signify their approval of such a loan to the Donaldson Orlando Community Centre. The Trustees had all been circularised and had approved the loan. It now remained for the loan to be minuted and its conditions determined by the meeting.

IT WAS AGREED

to make a loan of £2000 to the Donaldson Orlando Community Centre for a period of five years provided that if at the end of this period the loan had not yet been paid off, the Trustees should give them an extension of time.

### 5. DONALDSON VALUE PRINT SERIES

5. DONALDSON BLUE PRINT SERIES

Reported that the first number of the Donaldson Blue Print series of publications which was an abridged edition of the report of the Fagan Commission had been very successful. Two editions had already been sold out and a third edition together with an Afrikaans translation were on sale. The Director of the S.A. Institute of Race Relations had decided that any profits which might accrue from the sale of these publications would be used for replenishing the fund.

The Assistant Secretary reported that he had tabulated the nominations for the James Donaldson Award for 1948 and wished the Trustees to appoint a sub-committee to consider them.

IT WAS DECIDED

to appoint Mr Rheinallt Jones, Mr Mosaka and Dr Ray Phillips to consider the James Donaldson Award and submit their recommendations to the next meeting of the Trust.

7. TRANSVAAL N.E. PROFESSIONAL BOXING ASSOCIATION

A letter was read from the Secretary of the Transvaal Non-European Professional Boxing Association requesting the Trustees to give them an extension of a year for the repayment of their loan.

8. TRUST'S SHARES

The Chairman stated that he wished the Trustees to give him authority to deal with the Trust's shares on the share market should he consider it advisable to do so.

Agreed

9. EKUTHULENI COMMITTEE

Reported that the above committee had invited the Trustees to attend their annual meeting on the 20th November, 1948.

Agreed that Mr G. Nakene should attend on behalf of the Trustees

10. SCHOOL FOR ORLANDO

The Chairman stated that it was his desire that the Trust's funds should as far as possible be spent during his lifetime and to carry out this wish he proposed that the Trust should build schools at Orlando or elsewhere at a cost of £30,000 even without state assistance should this be considered advisable.

IT WAS DECIDED

to appoint a sub-committee consisting of Dr Phillips, Mr Mosaka and Mr Rheinallt Jones to consider this proposal and prepare a report for the next meeting of the Trustees.
