I spoke to Desiree the other day and told her that I was settling the papers for the admission of Robert Sobukwe as an attorney. In the Petition it is necessary to say that he was registered as a student at the University of South Africa on the 12th Pebruary, 1970. I have spoken to Mr. Zeeman, who is the Student Information Officer at the University, and who is in Room 47 on the Fifth Floor. I have explained to him that this fact about registration must be proved by affidavit, and he has kindly consented to depose to such affidavit. I have accordingly drawn it and it is sent to you herewith. Will you please arrange for a Commissioner of Oaths to take it to him at the University for his signature, and for the Commissioner, after it has been sworn to, to attest it in the usual way.

It is also necessary that there be a certificate confirming that the Afrikaans examination passed by Robert entitles him to exemption from the Matriculation examination in that subject. I have spoken to Mr. Fischer, who is in Room 187 on the Fifth Floor of the University of South Africa, and he kindly consented to supply such certificate upon production to him of the original of the certificate issued by the Department of Bantu Education. Robert has just sent me this latter certificate, which I enclose herewith. Will you please arrange for the person who is going to the university to present this certificate to Mr. Fischer, who will on sight of it issue the certificate in regard to the Matriculation examination.

Thereafter, will you please deliver to me the certificate that I am sending you herewith, the Matriculation certificate issued by Mr. Fischer and the Affidavit signed by Mr. Zeeman. Please attend to this matter immediately, as Robert must give one month's notice to the Law Society in Cape Town, and he wishes to do this soon, to enable me to move his application in Kimberley before I go to England in June.
