

THE PROBLEM OF PENETRATION

Reference - "Memorandum Relating to the Penetration of Indian into predominantly European Areas in the Borough of Ladysmit since the 1st January, 1927 for submission to the Indian Penetration Commission".

Par. 11 " As the Indians held more than sufficient land and business premises in areas where they have been trading for very many years, they have not acquired such land or properties outside these areas for trading purposes."

Par. 13 (latter half) "It is presumed that in some cases properties have been purchased by Indians for the purpose of investing their money."

Reference - "Letter addressed by the Town Clerk to the Secretary, Indian Penetration Commission, commenting on submissions by the Natal Indian Congress."

Comment (3) "while the properties may at present be occupied by Europeans, there is no law to prevent the occupation such properties by Indians." 6th May, 1941.

Reference - Table appended by the Corporation to show Indian Penetration into predominantly White Areas as at January 1, 1927.

6 properties were sold to Whites.
