It has been very kind of you to help us contribute in doing a deserving cause to Prof. Robert Mangaliso Sobukwe. For you to have thought of doing it speaks a lot to me about yourself. In our difficult situation - many in PAC-leadership owe much to Prof. R.M.Sobukwe.for his suffering and dedication he made for their future as people of South Africa - our only motherland South Africa/Azania.

In the meanwhile, I have my own proposals to make to you but I am now free to travel to England, doing which time among other things I shall need to have a heart to heart talk with you in writing on my own works and achievements in the liberation movement itself. However, if you think you have any other suggestion to make in case you did not have much material - considering the fact that Prof, had his dear lifespan shortened by banning orders and detentions then we could discuss how to overcome that. But in the case of my works there is much to write about involving the whole Jan Smuts to President P.W.Botha, era and role of the present liberation movement by the entire people of South Africa - with particular reference to African people struggle against Apartheid, an issue that internationally uppermost at our time.

Finally, I wish you to let me know the whereabouts of your other journalist Mr.John Imeri, if you know where he is at present?
