## MEMORANDUM

(Submitted to his Worhip the Mayor of Brakpan) by the African Women in Re: Essue of Permits to African Women of Brakpan.

We the African Women of Brakpan desire to bring to Your Worship our deep grievance. It is now almost 2 months since a start has been made in Brakpan to issue permits to African Women. We therefore felt that, it was meet and proper under the circumstances to make representations to your Worship as the first Citizen of the town upon whom the whole responsibility of good relationship between the different sections of the population lie. In this connection, it is our sincere desire to do everything in our power to mantain the good relationship and to assist in every way possible. We feel also that it is our duty to bring to the notice of the chief citizen of our town any matter which is likely to disturb the peace and goodwillof all the citizens of Brakpan.

The issue of permits to African Women, is creating great ill feeling to the African Women for the following ressons:-

- 1. The permits are undesirable.
- 2. The permits being issued are passes, as we know these passes are enemy no one of the African people.
- 3. The raids by Police Officers for permits and passes conducted even during the middle of the night are most humiliating.
- 4. The passes subject the African Women to most humiliating and undignified circumstances.
- 5. Family life which we women, have great regard is being broken.
- 6. All of us will be faced with jail at any time and sent out to the farms as it is the case with men. We shall be removed from our place of employment.
- 7. We shall not be permitted to seek employment where we want, but shall be forced to take any employment to comply with

the demand of the permit.

- 8. We shall be forced to abondon our children and husbands to meet the demand inflicted upon us by permits and passes.
- 9. Passes create crimnals. As a result of these permits and passes more young girls will be arrested and introduced to the hardened crimnals and these young girls will in turn become crimnals to the disgrsce of our population.
- 10. Gaols will be filled up with innocent people, thousands of women will be rendered homeless and shall be forced to become wonderers.
- 11. To provide room for the crimnals created by the pass system more jails shall be built and more money spent on useless and unpleasant institutions. Money which is greatly needed to build Schools and other institutions dedicated to the improvement of the well being of our people.
- 12. All over the country, the African women are up in arms against these passes.
