NOTICE TO PERSON ENTERING THE BECHUANALAND
PROTECTORATE
(Regulation 5)

To..... MR. Lionel BERNSTEIN

You have been permitted to enter the Bechuanaland Protectorate in terms of the Immigration Law, 1963, but your attention is specially drawn to the fact that, in accordance with the Law, you are entitled to remain in the Territory only for the purpose of a visit to or transit through the same and only for 90 days at any one time or in any one calendar year. If you wish to take up residence in the Territory it will be necessary for you to apply for and obtain a residence permit before the expiration of this period.

2. In addition your attention is drawn to the fact that your stay may be subject to "visit conditions" prescribed in respect of you personally, by order in writing addressed to you, or in respect of all non-residents, or all non-residents of any class to which you belong, by order published in the 'Government Gazette' and given general publicity in the Bechuanaland Protectorate.

VISIT CONDITIONS

HIS EXCELLENCY ROBERT PETER FAWCUS, ESQUIRE, COMPANION OF THE MOST DISTINGUISHED ORDER OF SAINT MICHAEL AND SAINT GEORGE, OFFICER OF THE MOST EXCELLENT ORDER OF THE BRITISH EMPIRE, HER MAJESTY'S COMMISSIONER FOR THE BECHUANALAND PROTECTORATE

IN EXERCISE of the powers vested in him by sub-section (3) of section nineteen of the Immigration Law, 1963, His Excellency Her Majesty's Commissioner hereby gives you notice that while you remain in the Bechuanaland Protectorate by virtue of the provisions of sub-section (2) of section nineteen of the said Law you shall be subject to the following conditions, that is to say that you shall present yourself to an immigration officer and produce this notice to him every Monday at District Police Headquarters, Lobatsi, or on such other day of the week or at such other place as may from time to time be endorsed upon this notice by an immigration officer at your request or otherwise.

If you fail to comply with the above conditions you are liable under law to prosecution, and liable on conviction to a fine not exceeding R1,000 or to imprisonment not exceeding one year, or to both such fine and imprisonment.

NOTICE TO PROHIBITED IMMIGRANT.

To: MR ~~A~~ LIONOR BERNSTEIN
at LUSAKA.

Take notice that permission to enter Northern Rhodesia or to remain therein is refused to you on the ground that you are a prohibited immigrant by reason of the operation of:-

- *(a) paragraph () of subsection (1) of section 5 of the Immigration Act, 1954;
- *(b) subsection (2) of section 5 of the Immigration Act, 1954.
- *(c) section 6 of the Immigration Act, 1954.
- *(d) section 25 of the Immigration Act, 1954, in that you have *entered/ remained in Northern Rhodesia in contravention of _____

* IMMIGRATION OFFICER TO DELETE OR COMPLETE AS APPROPRIATE.

You are notified that, in terms of the Act, you may appeal to the nearest magistrate's court -

- (a) on the grounds of identity, as provided in section 10(1) of the Act, if you have been alleged to be a prohibited immigrant by reason of the operation of paragraph (a) or (h) of subsection (1), or of subsection (2), of section 5 of the Act, or
- (b) to determine whether or not you are a prohibited immigrant if you have been alleged to be a prohibited immigrant by reason of the operation of any other provision of the Act.

Such appeal must be noted within three days after this notice has been given and shall be made on Form No. 6 which may be obtained from any Immigration Officer.
