MINUTES OF THE THIRD EXECUTIVE MEETING HELD AT DR.R.GOPAL'S RESIDENCE

ON THE 8 MAY 1992 AT 8:45 PM.

# PRESENT :

AS PER ATTENDANCE REGISTER. TWO EXECUTIVE MEMBERS OF THE SWARAJ SPORTING CLUB WERE ALSO PRESENT.

#### NOTICE :

THE NOTICE OF THE MEETING WAS GIVEN AT THE SECOND EXECUTIVE MEETING OF THE CLUB.

#### MINUTES :

THE PRESIDENT, MR.A.GANDABHAI EXPLAINED TO THE MEMBERS PRESENT THE CLUBS PROPOSAL OF LEASING THE PROGRESS GROUNDS OR ANOTHER SUITABLE PLAYING FIELD FROM THE CITY COUNCIL. THE CLUBS INTENTION IS TO DEVELOP THIS GROUNDS INTO A SPORTING COMPLEX WHICH WOULD EVENTUALLY CATER FOR VARIOUS CODES OF SPORTS SUCH AS CRICKET, SOCCER AND TENNIS.

MR.A.GANDABHAI SAID THAT THE TENNIS COURT AT THE TECH GROUNDS ARE LEASED FOR A PERIOD OF 49 YEARS TO A TENNIS CLUB WHO PAY A NOMINAL SUM OF R500 PER YEAR TO THE CITY COUNCIL BUT THEY ARE RESPONSIBLE FOR THE UPKEEP OF THE TENNIS COURTS.

MR.GANDABHAI SAID THAT HE HAD A TELEPHONIC DISCUSSION WITH MR.LOUBSER FROM THE CITY COUNCIL CONCERNING THE LEASING OF THE PROGRESS GROUNDS. HE WAS INFORMED THAT THE CITY COUNCIL DOES NOT DEAL WITH INDIVIDUAL CLUBS THEY DEAL ONLY WITH ORGANIZATIONS. HOWEVER, MR.LAUBSER SAID THAT THE CITY COUNCIL HAD NO OBJECTION IN DEALING WITH THE CLUB IF THE TRANSVAAL CRICKET BOARD GAVE THE CITY COUNCIL PERMISSION TO NEGOTIATE THE LEASING OF THE GROUNDS TO THE CLUB.

HE INFORMED MR.GANDABHAI THAT THE CLUB SHOULD WRITE TO THE TRANSVAAL CRICKET BOARD FOR THE PERMISSION.

IN A GENERAL DISCUSSION WITH MR.LOUBSER, MR. GANDABHAI WAS INFORMED THAT

(1) THE LEASE WOULD BE VALID FOR 9 YEARS AND 11 MONTHS - RENEWAL THEREAFTER.

(2) IT WILL COST THE 3C PER SQUARE METRE PER WEEK IN THE MAINTENANCE OF THE GROUNDS IE. APPROXIMATELY R750 PER MONTH.

DR.R.GOPAL SAID THAT THE CLUB SHOULD INVESTIGATE THE POSSIBILITY OF OBTAINING ANOTHER-PIECE OF LAND TO DEVELOP AS A SPORTING COMPLEX IN THE EVENT THE CITY COUNCIL DOES NOT LEASE THE PROGRESS GROUNDS TO THE CLUB.

#### DEVELOPMENT TRUST FUND :

DR.R.GOPAL SUGGESTED THAT THE CLUB ESTABLISHES A DEVELOPMENT TRUST FUND AS SOON AS POSSIBLE TO ENABLE THE CLUB TO BE ON A SOUND FINANCIAL FOOTING FOR SUCH A VENTURE. HE SAID THAT MONEY WILL BE REQUIRED FOR LEGAL FEES DEVELOPMENT ETC AND THAT WE SHOULD HAVE MONEY READILY AVAILABLE FOR SUCH EXPENSES.

MONEY COLLECTED FOR THE DEVELOPMENT FUND WILL BE USED EXCLUSIVELY FOR THE DEVELOPMENT OF THE SPORTING COMPLEX.

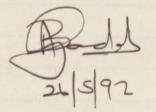

MINUTES OF THE SPECIAL MEETING HELD AT MR.A.RAVJEE'S RESIDENCE ON THE

21 MAY 1992 AT 8:45 PM.

PRESENT :

NOTICE :

THE NOTICE OF THE MEETING WAS GIVEN AT THE THIRD EXECUTIVE MEETING OF THE CLUB.

APOLOGY RECEIVED : MR.H.BHOWAN.

MINUTES :

DR.R.GOPAL PRESIDED OVER THE SPECIAL MEETING DUE TO MR.A.GANDABHAI'S INVOLVEMENT IN THE MATTER WHICH WAS TO BE RESOLVED.

DR.R.GOPAL OUTLINED THE INCIDENT BETWEEN MR.A.GANDABHAI AND MR.E.MIA THAT WAS REPORTED AT THE THIRD EXECUTIVE MEETING. HE SAID THAT THE COUNCIL HAD APPOINTED THE MEMBERS PRESENT TO RESOLVE THE ISSUE INSTEAD OF REFERRING THE ISSUE TO THE DISCIPLINARY COMMITTEE.

MR.H.UKA REPORTED THAT THE CONFLICT BETWEEN MR.A.GANDABHAI AND MR.E.MIA HAS PROBABLY RESULTED FROM THE TALKS HELD AFTER MATCHES. HE SAID THAT AT THESE MEETINGS THE PERFORMANCES OF THE PLAYERS WERE DISCUSSED FOR THAT MATCH. HE REPORTED THAT MR.E.MIA WALKED AWAY FROM ONE OF THESE DISCUSSIONS STATING THAT HE WAS DISAPPOINTED IN NOT RECEIVING BOWLING.

MR.M.NARAN REPORTED THAT THERE WAS LACK DISCIPLINE ON THE FIELD AND MANY OF THE PLAYERS HAVE AN EASY GOING ATTITUDE WHEN PLAYING CRICKET. HE ALSO STATED THAT ARGUMENTS ON THE FIELD WERE NOT UNCOMMON AND THAT THESE ARGUMENTS CONTINUE AT THE DISCUSSIONS HELD AFTER THE GAME.

DR.R.GOPAL STATED THAT IN WINNING TEAMS, THERE WAS LITTLE TO ARGUE ABOUT. HE SAID THAT SINCE THE TEAM IS NOT PERFORMING WELL, SOME SORT OF CONFLICT SITUATION WILL ALWAYS ARISE. HE STRESSED THAT PLAYERS SHOULD COMMIT THEMSELVES THEIR TEAMS NAD TO PLAYING CRICKET. HE SAID THAT PLAYERS MUST EARN RECOGNITION AS BOWLERS OR BATSMAN OR EVEN AS ALL-ROUNDERS.

MR.E.MIA REPORTED THAT THE INCIDENT OCCURRED BECAUSE HE WAS BECOMING FRUSTRATED AND DISAPPOINTED AT LOSING ALL THE TIME. HE SAID THAT THE CAPTAIN AND VICE CAPTAIN DID NOT DO A GOOD JOB AND THEY LACK THE KNOWLEDGE OF CRICKET. HE CITED AN INCIDENT SUCH WHEN HE WAS NOT SELECTED FOR THE A TEAM IN THE SIX-A-SIDE TOURNAMENT BUT ANOTHER UNKNOWN PLAYER - SANJAY PLAYED FOR THE A TEAM THAT ADDED TO HIS FRUSTRATION. HE STATED THAT IF THE CAPTAIN IS NOT STRONG, HE LOSES ALL CONTROL OF THE PLAYERS AND THE PLAYERS BECOME WEAK. MR.E.MIA ALSO SAID THAT ALTHOUGH THE CAPTAIN AND VICE CAPTAIN WERE ALWAYS PRESENT ON THE PLAYING FIELD, SENIOR PLAYERS WERE TAKING COMMAND AND DIRECTING ON THE FIELD. HE SAID THAT THE CAPTAIN DID NOT HAVE ANY IDEA OF THE BOWLERS CAPABILITY OR OF FIELD PLACING. MR.E.MIA STATES THAT AS FAR AS HE IS CONCERNED MR.H.NAGIN IS THE WORST BOWLER WHO BOWLS WILL SHEER LUCK. AS FAR AS THE PLAYERS ARE CONCERNED, MR.MIA SAID THAT THEY LACK MOTIVATION TO PLAY CRICKET.

MR.E.MIA SAID THAT THE PLAYERS WERE NOT AWARE OF THE RULES OF PLAY, THEY HAVE LITTLE KNOWLEDGE OF CRICKET AND THEY ONLY PLAYED CRICKET FOR FUN.

DR.R.GOPAL COMMENTED THAT MR.E.MIA WAS A SENIOR PLAYER AND THAT HIS VIEWS ARE RESPECTED. THE SAID THAT THERE WAS A GENERAL LACK OF COMMUNICATION. HE STRESSED THAT THE CAPTAIN WAS ELECTED TO RUN THE TEAM AT THE BEGINNING OF THE SEASON. DR.GOPAL SAID THAT HE WAS NOT AWARE OF THE SELECTION CRITERIA USED WHEN SANJAY WAS SELECTED FOR THE SIX-A-SIDE SIDE TOURNAMENT.

MR.GANDABHAI REPLIED THAT SANJAY WAS A PLAYER. BUT SINCE THERE WERE VERY FEW MEETING SANJAY WAS NOT FORMALLY REGISTERED WITH THE CLUB. MR.GANDABHAI SAID THAT SANJAY HAD PLAYED TWO MATCHES FOR THE CLUB BEFORE THE SIX-A-SIDE TOURNAMENT AND WAS CONSIDERED TO BE A GOOD PLAYER, THEREFORE HE WAS SELECTED.

MR.C.K.BHIKA SAID THAT HE WAS SURPRISED AT MR.MIA'S ALLEGATION AGAINST THE CAPTAIN AND VICE CAPTAIN AT THE END OF THE CRICKET SEASON. HE STRESSED THAT THE CAPTAIN WAS ELECTED AT THE BEGINNING OF THE SEASON AND THAT IF MR.MIA FOUND THE CAPTAIN WAS NOT PERFORMING WELL IN HIS TASKS, MR.MIA SHOULD HAVE REPORTED SUCH AN OCCURRENCE AT ONE OF THE COUNCIL MEETINGS. HE SAID THAT HE WAS ALSO AWARE THAT MR.MIA DID NOT ATTEND MEETINGS SO THERE WAS A GENERAL LACK OF COMMUNICATION. HE STATED THAT IF MR. MIA HAD DISCUSSED HIS ALLEGATIONS PREVIOUSLY, AN UNFORTUNATE INCIDENT SUCH AS THE ONE THE MEETING WAS HELD TO RESOLVE WOULD NOT HAVE OCCURRED.

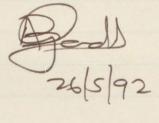
MR.A.RAVJEE COMMENTED THAT HE BELIEVES THE CAPTAIN AND VICE CAPTAIN WERE DOING A GOOD JOB IN RUNNING THE TEAM ESPECIALLY WITH THE LACK OF DISCIPLINE AND MOTIVATION AMONGST THE PLAYERS.

MR.GANDABHAI SAID THAT MR.E.MIA'S PERFORMANCE ON THE FIELD WAS NOT VERY GOOD. HE SAID THAT HE TRIED TO COVER UP MR.MIA'S POOR PERFORMANCE BY MAKING VARIOUS EXCUSES TO WHOEVER ENQUIRED ABOUT MR.MIA'S PERFORMANCE. HE ALSO STATED THAT MR.MIA'S ATTITUDE TO THE CAPTAIN AND THE TEAM AS A WHOLE LACKS RESPECT AND THAT MR.MIA HAD A "DON'T CARE" ATTITUDE AND ALWAYS ARRIVES LATE FOR THE CRICKET GAMES. HE SUGGESTS THAT THIS MAY HAVE A BARING ON THE INCIDENT THAT WAS WITNESSED AT THE FRIENDLY GAME WHEN HE WAS PUNCHED BY MR.MIA.

DR.N.BHOWAN WANTED TO KNOW IF THE INCIDENT BETWEEN MR.MIA AND MR.GANDABHAI WAS NOT AN ETHNIC ISSUE TO WHICH MR.MIA VERIFIED THAT IT WAS NOT AN ETHNIC ISSUE. THE CHAIRMEN DR.R.GOPAL, NOTED THAT THE INCIDENT BETWEEN MR.GANDABHAI AND MR.MIA WAS AN ISOLATED INCIDENT AND IS NOT AN ON-GOING PROBLEM AND THAT THIS INCIDENT IS EASILY RESOLVED BY MR.GANDABHAI AND MR.MIA. HE ALSO SAID THAT IT SEEMS THE POSITION OF CAPTAIN OF THE TEAM IS NOT AN HONOUR BUT A BURDEN AND THAT VERY FEW PLAYERS WILL UNDERTAKE THE CAPTAINS POST. HE SAID THAT THE NON-PLAYING MEMBERS AND PLAYERS SHOULD WORK TOGETHER TO RESOLVE ISSUES ENCOUNTERED IN THE CLUB.

DR.GOPAL SAID THAT THE MEMBERS PRESENT WILL RECOMMEND TO THE COUNCIL THAT THE MATTER BETWEEN MR.GANDABHAI AND MR.MIA BE CONSIDERED AS RESOLVED.
