REPORT OF NON-EUROPEAN CONSULTATIVE SUB-COMMITTEE.

The Sub-Committee appointed to consubt with representative Africans on the Chamber of Commerce Housing Scheme held a meeting with 15 Africans at the Donaldson Orlando Community Centre on Saturday afternoon, May 13th, 1950. The following members of the Sub-Committee were present: Mr. J. D. Rheinallt Jones (in the Chair), Messrs. J. P. Cope, A. J. Cutten, and A. D. McPhail and Rev. Ray Phillips. Dr. F. H. Donnelly attended by invitation as a member of the Housing Committee of the S. A. Institute of Race Relations. Dr. Winifred Hoernle and the Rev. C. B. Brink sent apologies for absence.

The Institute of Race Relations, through their Field Officer, Mr. W. B. Ngakane, had kindly contacted Africans of standing and had arranged for their attendance at the meeting. Their names are attached hereto; also other names, suggested by the Rev. C. B. Brink, Dr. Hoernle and the Institute of Race Relations, of persons who were not able to attend this meeting.

The Chairman briefly explained the purpose of the meeting and called on Mr. Cutten to explain the shheme, who did so with the aid of a map of the areas concerned. There followed many questions from the Africans and much discussion generally. The following are samples of the questions raised:-

Grievances over municipal administration matters tended to cloud the issues and to cause hesitation in welcoming the shbeme. Mr. Mosaka, a member of the Natives' Representative Council, however, expréssed strong support.

The Africans asked for a written statement setting out the principles and details of the scheme and the Chairman promised that this would be made available to them.

It was agreed to adjourn the meeting until 3 p.m. on Saturday May 27th. to enable those present to consider the shheme after having received the written statement.

The Chairman, in closing the meeting, emphasised that the

I suggest that the sub-Committee be converted into a Joint Consultative Committee and that the Africans named on the list attached hereto, and any others co-opted, be appointed as members of the Committee, the Committee to have power to co-opt. Membership of the Joint Consultative Committee will not give membership of the main Committee.
