This will not be the last package for this year as there is still the revised National Conference agenda to circulate as well as a whole lot of pressclips. Most of the information in this package is for your own resources and does not need much discussion. Included is the following :

- A copy of the latest Veterans for Victory publication :this was distributed to the school principals in the Transvaal. We have sought legal advice from Dave Dison and his feeling is that its running very much on the same lines as the famed APN wrt trying to slander us by alleging links with the ANC and SACP/KGB. Our best strategy would be to counter this with letters to the press about the infiltration of R wing smear publications into the schools. I will also be sending a letter to the schools in the Transvaal explaining the legitimate aims of ECC, denouncing both the Vets article and the Women for South Africa document on ECC and will enclose a copy of the ECC counter smear publication.

Please investigate whether there have been similar distributions in the schools in your region.
- The Women for SA document : We consulted with Dave Dison on this matter and over and above what has been suggested in the above point, he will be writing a letter to the organisation informing them of the gross inaccuracies which appear in their publication.
- Anti- Conscription article in the November edition of Armed Forces :
Another attempt to smear ECC! Will also lodge this with the lawyers but perhaps some letters to the editor for the next edition would be useful.
- Minutes of the ASP at SACBC in November : this is for your information.
Comments on the direction and content of this project would be welcome. It would be most important to get ECC church members discussing this issue and finding out if there are any conscripts available for this project.

- Press releases : on Angola ; support of Nusas etc against proposed De Klerk bills ; ECC rejects army death notices.
- Press statement on the Evangelical Lutheran Church re: military conscription. Important info for taking up issues around Namibia.
- International Coalition Against Violent Entertainment : could supplement work around anti-war toys campaigns in the regions where this is being done.

The End Conscription Campaign (ECC) is aware that all school principals in the Transvaal region have received a document compiled and circulated by Women for South Africa (W.O 02 200032 000 5) entitled "Leaving South Africa Defenceless. End Conscription Campaign. (ECC) "

The ECC understands the concern that teachers and educationists have for the well being of their students. It is because of this that we feel we should inform you of the gross inaccuracies and false information which is being distributed through documents such as the above-mentioned.

We are alarmed by the obvious misinformation of this document and have taken appropriate legal action concerning the matter.

We have enclosed a copy of a pamphlet produced by the ECC which puts into perspective the attempts by various organisations and individuals to smear a legitimate and completely legal organisation. The pamphlet also outlines the aims and objectives of the End Conscription Campaign.




