My dear Bulalie,

Can I trouble you again on behalf of Bob? Two things are required: firstly, his record player is not working, and I have suggested to him that it should be sent to the docks in Cape Town to be collected for reprir. Could you attend to this and let me know how such it costs? As two letters from how on the subject did not get to me, and his last one was much delayed by the authorities, in replying to him I have taken the liberty of telling him to tolegraph you to let you know that the player will be at the docks. I hope you will not mind, but it hasn't been working for some time now.

Secondly, his fan heater which I provided in 1964 has packed up and he tells me that he has been advised that it cannot be repaierd. -- so he hask been told by people to whom it was sent for repair. Is it possible to purchase and to have delivered to him a new fan heater? He also needs a second heater, and in this case I would suggest a normal two-bar affair. If possible, is there someone in Cape Town who might foot the bill for these? I ask because funds here are very low at present. But if there isn't anyone, then please buy the heaters anyway and let me know the cost. With the sudden cold snap, I am terribly anxious about the cold he will be experiencing.

I hope you will not akan mind my asking for your help in these matters.

There is some hope that the Government will allow me to travel to London for two weeks, in which case I hope to Fly off at the end of next week. If I hear from you before then about the costs, I shall naturally reply immediately. In any event, I don't even know if you'ld cape Town at present, so could I beg you to acknowledge the receipt of this letter?
