- FLASH: 59P Pathfinder Masters:- Black with emblem in white.

  - 61 P Instructors :- Yellow with emblem in green.

# 30. AMEND TO READ AS FOLLOWS:-

Delete "Senior" from heading of the section.

- HAT. (a) Either smasher type turned up on left side, dented front to back, and red flash with emblem in green fitted to left side of hat.
  - (b) Or ordinary Khaki Peak Cap and flash with emblem in green fitted in front between peak and cap.
  - (c) Or Beret and red flash with emblem in green fitted to front of Beret; members of a troop must wear the same type.

LANYARD. Alter to read as follows:-

Lanyard (Khaki) 58 P. Worn only by troop Leaders, Section and Assistant Section Leaders.

32. Alter to read as follows:-

Troop Name Badges. Name badges to be worn on the right shoulder (optional).

The Transvaal Divisional Council has asked me as Chairman of the South African Pathfinder Council to place before the Divisional Councils a matter of prime importance to the Pathfinder Movement, and to ask each Divisional Council for a clear expression of opinion on the issues which arise.

Owing to opposition from certain of the members the Transvaal Council has not yet adopted the Constitution of the Pathfinder Movement, the main objection originally being the provisions which explicitly place in the hands of the S.A. Scout Council a veto upon all decisions of the S.A. Pathfinder Council. More recently there has arisen the more fundamental objection: that non-European boys are not enrolled as Scouts.

A short historical statement here may help the Divisional Councils to understand how these difficulties have arisen:-

During the Great War, representatives of the non-European communities waited on the Transveal Scout Council with a request for the formation of Scout troops among non-European boys. The proposal was not favourably received and on its being referred to Lord Buxton (then Chief Scout for South Africa) he, after consultation with General Botha (as Prime Minister), expressed strong disapproval of any action being taken during the war.

In 1918, or thereabouts, the Rev.Ray Phillips of the American Board of Missions in Johannesburg, organised a group of Native boys as "Trackers" adapting the methods of the Scout Movement as known in America to the special needs of these boys. In 1922 the Rev.S.P.Woodfield, then Vice-Principal of the Diocesan Native Training College, Pietersburg, having recently arrived from England, with considerable experience as a Scout Master, began to train some of the students of the College as Scouts, and he applied to the Transvaal Scout Council for the registration of the troop. At about the same time representatives of the Coloured people in Johannesburg again approached the Transvaal Scout Council.

A conference between the Transvaal Scout Council, and representatives of the various Missionary bodies made it clear that the Scout Council was not prepared to admit non-Europeans as Scouts, fearing that the admission of non-Europeans would destroy the Scout Movement among European boys. The conference resulted in the establishment under the auspices of the Scout Council of a special organisation for non-Europeans on Scout lines, but having a ceparate name and uniform. A Constitution and Regulations were drawn up and the Pietersburg troop was enrolled as the first troop of Pathfinders. The Constitution provided that the control and direction of the Movement should be vested in the Transvaal Scout Council.

The Movement grew and in 1924 the Transvaal Scout Council set up an Advisory Council (with no explicit executive authority) to guide the work. The Council was composed of representatives of the various Church and Mission bodies likely to be interested and representatives of the Transvaal Scout Council. A new Constitution and amended Regulations were prepared in consultation with the Advisory Council. The Constitution still vested the control of the Movement in the Transvaal Scout Council. This was in force until early in 1929.

On the re-organisation of the Scout Movement in South Africa on a national basis, with supreme authority vested in the Union Scout Council, this Council adopted a new Constitution on similar lines for the Pathfinder Movement. This Constitution gave the South African Pathfinder Council the Divisional Council's executive authority but provided explicitly for the right of veto being vested in the Union Scout Council.

It is to this new Constitution that certain members of the Transvaal Pathfinder Council raised strong objection mentioning particularly (a) the right of veto and (b) the nature of Pathfinder representation on the Union Scout Council.

To meet these objections the Transvaal Pathfinder Council submitted a number of amendments through the S.A.Pathfinder Council. These were rejected by the Union Scout Council, the Pathfinder delegates (who had not been present at the S.A. Pathfinder Council meeting) voting for rejection.

The amendments were again submitted, and on this occasion the Scout Council appointed delegates to meet representatives of the Pathfinder Movement to discuss the situation. This joint Committee met in November 1930 and submitted recommendations to the following effect:-

- (a) Alteration of the title of the Pathfinder Movement in the Constitution to show that the Movement is "of the S.A. Boy Scout Association".
- (b) Numerous alterations to place more responsibility for appointments on the S.A.Pathfinder Council while retaining final control in the hands of the Union Scout Council.
- (c) Providing for the right of the three representatives of the Pathfinder Movement on the Union Scout Council to speak and vote in Pathfinder matters only.
- (d) Suggesting the formation of a Joint Committee equally representative of the Scout and Path-finder ofganisations to consider all questions affecting the relationships of the two Movements.

These recommendations were adopted by the Union Scout Council at its meeting in February 1931.

Prior to this meeting the Transvaal Pathfinder Council submitted to the S.A. Pathfinder Gouncil the following question for submission to the Union Scout Council:-

"That the South African Pathfinder Council ask the South Africa Scout Council whether its policy is the ultimate admission of all non-Europeans as Scouts without distinction".

This was altered by the S.A. Pathfinder Council to read as follows:-

"That the South African Scout Council be asked whether its policy provides for the ultimate admission of non-European troops as Scout Troops, and the South African Pathfinder Council suggests that if necessary this question be referred to the proposed joint advisory co-ordinating committee"

The reply of the Union Scout Council was given as follows:-

"That the South African Scout Council is not at present prepared to alter the general principles governing the Pathfinder Movement".

This reply has led certain members of the Transvaal Pathfinder Council to urge that one of the following actions be taken:-

- (a) Separation of the Pathfinder Movement from the Scout Movement, or
- (b) Establishment of a Non-European Boy Scout Association for the organisation of non-European boys into non-European Scout troops, or
- (c) Organisation of a Movement for non-European boys on lines entirely different from Scouting and more suitable to African needs.

It is felt by the Transvaal Pathfinder Council that issues of such major importance ought to be communicated to the other Divisional Councils and that their views ought to be ascertained. The Transvaal Council also suggests that a special Conference of delegates from all the Divisions ought to be held to consider these questions, although it realises that it will be by no means easy to arrange such a Conference. In any case there will be an ordinary meeting of the S.A.Pathfinder Council in Bloemfontein on October 3rd.

The Transvaal Council has also asked whether I would arrange to attend meetings of Divisional Councils, if they should wish me to be present when this communication is being considered. I am ready to do this so far as it may be possible. Will you please let me know if your Council wishes me to attend its meeting, and give me sufficient time to make my own arrangements accordingly.

The Minutes of the last meeting of the S.A. Pathfinder Council are being despatched to you by this post.

The following matters require your special attention and should be brought before your Council.

- 1. AMENDMENTS TO THE CONSTITUTION. Please note these.
- 2. AMENDMENTS TO THE REGULATIONS. Please note these as shown on the Schedule herewith. They include the amendments made by the previous meeting of the Pathfinder Council as well as those given in the Minutes.

Please inform your officers of these Additional copies of the Schedule may be obtained from me. It is hoped that the definite rulings regarding Uniforms will prove helpful.

- 3. NOMINATION OF VICE-PRESIDENTS. This matter will come up at the next Council meeting. It seems desirable that the Vice-Presidents shall be persons of some distinction, particularly sympathetic to non-European needs, and that, perhaps, some consideration should be given to Provincial or territorial distribution of the offices of Vice-Presidents.
- 4. PRESIDENT. The Scout Council has endorsed the request to His Excellency the Governor General that he should accept the office of President of the Movement in South Africa. His reply is now being awaited.
- that all Divisional Councils will now be constituted as provided by the amended Constitution, Section B.

Please see whether the membership of your Council conforms to the Constitution. Where no Divisional Council has been formed steps should now be taken to secure membership and to place the Movement on a sound basis. Section 2 (d) should be made use of as much as possible.

6. NEXT MEETING. I shall be glad to know whether Saturday October 3rd will be a convenient date for your Divisional

Council to be held at Bloemfontein.

- 7. JUNIOR PATHFINDERS. There seems to be a real need for regulations to provide for Junior Pathfinder troops. I shall be grateful for suggestions from your Division.
- 8. "ROVER" PATHFINDERS. Your Council's views are sought regarding the suggestion that "Rover" Pathfinders should be provided for in the Movement. It was felt by some at the Council Meeting that efforts to develop this section might seriously divert attention from the need for making the Pathfinders more efficient.
- 9. <u>BULLETIN</u>. Your Council's views on the Bulletin now being published will be welcomed, and news items regarding the Movement in your Division are invited.
- REVISION OF REGULATIONS. Please let me have any suggestions your Council has to make for alterations to the Regulations which are to come up for revision at the next meeting of the S.A. Pathfinder Council. Special attention should be given to improvements in the Syllabus—the scope and character of the Badge work and the provision of optional items to meet local needs. Should any alterations be made to meet actual conditions of life among Non-Europeans?

Attention should also be given to the qualifications required of Pathfinder Masters.

# 11. WARRANTS.

(a) Pathfinder Masters. All warrants for Pathfinder Masters and Assistant Pathfinder Masters, now obtainable from the Secretary, should be filled in and signed by the Divisional Pathfinder and then sent to:-

has not been approved by the Divisional Council.

(b) Troops. It is proposed to issue a Troop Warrant to be issued to registered troops, to be dated for a period of twelve months, new warrants not to be issued until the annual registration/has been paid for the troop. Temporary warrants might be issued by Divisional Pathfinders pending the payment of registration fee and registration of troops.

I shall be glad to hear from your Divisional Council on (b).

- 12. CENSUS. I attach a Census Form which please complete and return to me at an early date for inclusion with your Divisional Report in a special memorandum for circulation.
- I3. MEMBERS IN TROOPS. Attention is drawn to the regulation limiting the numbers of boys in troops to thirty two, and to the need for at least two Pathfinders to every troop.
- 14. PROGRESS OF THE PATHFINDER MOVEMENT. I shall be most grateful for frequent news from Divisions to show the progress of the Movements. Copies of bulletins issued by Divisional Councils or Divisional Pathfinders or District Pathfinder Masters will be appreciated, and I shall be happy to reply to enquiries and to assist Divisions in every way possible.
