#### ATTETATCE:

As per attached attenda ce register.

The convener of the meeting, Mr. P. Peffer, welcomed those in attendance a d declared the meeting open.

It was decided that items 4, 10 and 9 be moved at the bottom of the Agenda.

Ir. A.B. Gandabhai read the minutes of the meetings of the working committee held on 12 July, 1977 and 13 August 1977 and also the minutes of the meeting sponsored by Transvaal Council of Sport at which the working committee was set up, dated 26 June 1977.

Mr. M. Mara moved that the minutes be accepted as correct and was seconded by Dr. Gopal. The motion was unanimously carried.

Mr. P. Peffer explained that the name Transvaal Cricket Board of Control was only a tentative name and welcomed any other suggestions. It was unanimously agreed that the body be called Transvaal Cricket Board of Control and the motion was moved by Mr. C. Jacobs and seconded by Mr. A. Ahmed.

Mr. I. Gattoo moved the following resolution:

"That This meeting of representatives of cricket clubs and persons interested in the game of cricket hereby agree without dissent that the Transvaal Cricket Board of Control is hereby inaugurated".

The resolution was seconded by Dr. Gopal and passed unanimously.

Application for membership forms were handed in by the following clubs:-

The following clubs indicated that they have decided to join but have not as yet handed in their application forms:

Potchefstroom Cricket Club Protea Cricket Club Beidelberg Cricket Club.

The following clubs sent delegates to the meeting as observers:

Zulfikaars Cricket Club (Benoni) Benoni Sporting Cricket Club Ermelo A Cricket Club Ermelo B Cricket Club.

The observers pointed out that once they have reported back to their clubs the clubs will then take their decision whether to join or not. They expressed personal interest to join. Mr. P. Peffer informed the meeting that Mr. A. Bhamjee had been invited to address the Transvaal African Cricket Union.

The Ermelo delegates were told that the meeting could not guarantee that matches would be played in Ermelo itself, but were given the assurance in principle.

It was also decided that for the benefit of those clubs who have not made up their minds whether to join or not the deadline for application be moved to 4 September 1977.

at was made known that the following grounds would be available to the Board:

1. Vrededorp - 2 grounds

- 2. Potchefstroom
- 3. Ermelo

4. Heidelberg.

A letter was sent to the Swaraj Soccer Club for the use of the Mirvana Grounds. No reply has been received to date.

A letter was sent to the Johannesburg City Council for use of grounds in Lenasia. The Johannesburg City Council wrote back requesting certain information which could not be furnished because the inaugural meeting of the Board was still to be held.

Mr. P. Peffer indicated that grounds would be made available to teams from the City and Suburban areas.

Delegates from Vaal United from Vereeniging were asked to secure a ground in their area even if it was not in a useable state.

A committee incorporating the working committee together with Mr. A. Mangera was asked to go into the financial commitment the Board would incur and report back.

Various people expressed their vote of thanks to the Transvaal Council of Sport who made possible the emergence of the new Body.

It was also decided that the Board affiliate to the Transvaal Council of Sport.

Nr. A. Ahmed informed the meeting that Mr. H. Chotia of Nigel has offered his services in the umpiring field. Mr. Y. Kara asked to take note of the fact that the position of school cricket needs re-vamping and appealed that the matter be looked into.

Mr. A.B. Gandabhai read out the dates of the interprovincial fixtures which would be played between Transvaal Cricket Board of Control, Natal Cricket Board, Western Province Cricket Board and Eastern Province Cricket Board. The first match will take place on 25, 26 and 27 between Transvaal and Natal, and Western Province and Eastern Province. He also informed the meeting that the dates of the fixture will be ratified at the conference of Provincial Cricket Bodies to form a National Cricket Body which would be held in Kimberley on 25 September 1977.

Mr. P. Bhana moved that the meeting be adjourned to 4 September 1977 and was seconded by Mr. A. Ahmed. The motion was carried unanimously.

AS PER ATTENDANCE REGISTER.

The convener of the meeting, Fr. P. Peffer, declared the meeting open. It was unanimously agreed that the name Transvaal Cricket Board of Control be remained Transvaal Cricket Board. The motion was moved by Hr. A. Bhamjee and seconded by Hr. A. Ahmed.

The affiliation of the S.A. Haque Junior Cricket League was warmly welcomed and accepted. It was decided that the question of giving the league associate membership will only be decided once officials of the two parties have deliberated.

The following clubs paid in their entrance fee of R10.00 and thereby became fully-fledged members.

The draft Constitution was discussed and amendments made. Clause 37 on Defection will be included once legal opinion was taken as to its wording. Clause 9 will remain suspended until the end of the cricket season or as long as it may deem fit.

The Constitution as amended was accepted unanimously, the motion moved by Mr. A. Bhamjee and seconded by Mr. M. Bulbulia.

It was decided that Mr. 2. Gattoo of the Transvaal Council of Sport be appointed Chairman as to facilitate and conduct elections of office-bearers. The motion was moved by Mr. P. Bhana and seconded by Mr. Y. Kara and accepted unanimously.

#### SECRETARIAL REPORT 1977/8

#### . Mr. President and Gentlemen,

It gives me great pleasure and honour to submit my report.

#### 1. ACTIVITIES.

#### A. FORMATION:

The Transvaal Cricket Board was formed in September, 1977 on a principle of non-racialism because of dissatisfaction and discrepancies of "Normal" cricket which was officially described by the Department of Sport as "Multi-National" cricket.

#### B.FIXTURES:

The Board, in its very first year of existence fulfilled its "A" section fixtures and also sent a "B" team to Kimberley. This was an amazing feat against all odds, but it just proves the determination of the Board to provide for its members. My heartiest congratulation to Western Province for their clean sweep.

Locally, although only one round of fixtures were completed I am sure that now that the Board is on a firm and sound organisational footing two rounds will be organised. My heartiest congratulations to College Cricket Club on being the first Title-holders of the League.

#### C. SCHOOLS CRICKET:

Although a schools' cricket league was decided upon it did not eventuate due to the fact that being first year of its inception, the Board's time was utilised in getting the Senior League off the ground.

Nevertheless, a Schools' League will be organised and with the cooperation of the Transvaal High Schools' Sports Association it should be no problem.

#### D. COACHING AND UMPIRING:

The formation of an umpires' association is a must. To make some sort of a start i would strongly recommend that two non-playing members be officially appointed as umpires of each club who themselves should thoroughly acquaint themselves with the rules by reading the relevant material.

As far as coaching is concerned, I <u>appeal</u> to senior retired cricketers to attach themselves to clubs and put back something in the game. My special appeal is to teachers to discover and nurture the vast talent that is latent among the scholars.

#### 2. TRANSVAAL COUNC L OF SPORT.

My special thanks to TRACOS for their tremendous help and encouragement in getting the Board established and I wish them well in their struggle for non-racialism.

#### 3. DOUBLE-STANDARDS.

The South African Council of Sport (SACCS) resolution on Double-Standards has gained widespread support and my special appeal to the Winter code Sports is:

- d)"He (Mr. Varachia) said that Mr. Feldman was using the occasion for a personal vendetta and that participation by other races in Nuffield Week was a long process" - "THE STAR" 16.12.1977.

- j) "Jeppe Old Boys yesterday refused to consider membership applications by three Black cricketers because "We are a very conservative club and cannot contravene officially stated Government policy."

Mr. Elgins said Jeppe's understanding of the Government's sports policy was that the various ethnic groups should have their own clubs.

Asked if this was not contrary to cricket's mixed "blueprint" which did not specify such a point, he said:"That is why we have sought legal clarification"

- 6) I hereby quote contents of a Letter headed "International Status" from the White Western Province Cricket Club addressed to its members.
  - "Following on a decision at the last AGM, the club has applied for international status. If this is granted it will take effect from lst July. Non-whites may then be introduced as guests within the framework of the Club's constitution.
  - Regarding Non-White members, application for membership will be considered in the normal way in accordance with the existing procedure for candidates for membership. A candidate requires a proposer and seconder, both of whom have been members for at least 3 years and who have known the candidate for two years or more.
  - The screening process will therefore not in any way be relaxed, but there will be no restriction as to colour."
- 7) S.A.'s case was not even on the Agenda nor were SACU's leadership allowed to address ICC's meeting held on 25th and 26th August, 1978. Page 4/....

Reject from your ranks those who sought the fruits of our struggle in one season and then desert us in another season to accept hurtful concessions, thereby becoming stooges in a desperate fight by "White" sportsmen and sports administrators to regain international recognition.

In a nutshell, how can one be non-racial in soccer but racial in cricket? Or how can one have Winter Principles which go counter to one's Summer Principles?

It is therefore the duty of all non-racial Sports Bodies to get rid of those traitors.

#### 4. SOUTH AFRICAN CRICKET BOARD.

Our national body, the SACB, was formed in Johannesburg in November, 1977 and at the helm of affairs is Mr. H. Howa whose moral encouragement spurred those dedicated to the Frinciples of non-racialism to form the Transvaal Cricket Board.

#### GROUNDS :-

Facilities such as grounds have been used in the past to "force" non-racial sports bodies into a certain line of thinking and action. Your Board was faced with determined opposition last season when we aplied for the use of grounds from the Johannesburg City Council. The Transvaal Cricket Council was well represented and did their

utnost to prevent the City Council from allocating grounds to us. The Board is again applying for use of grounds in the Johannesburg municipal area. Unfortunately the Board is faced with the fact that cricketers in Lenasia are playing "normal" cricket. The Johannesburg City Council in reply to our application to make use of the Lenasia Stadium informed us that that it cannot be granted because: "The Council cannot act against the majority wishes of the cricketers of Lenasia who have remained affiliated affiliated to the Transvaal Cricket Council therefore the Lenasia Stadium cannot be made available for matches organised by your Board."

Gopal and Aboo Manacke to them I say a special thank you and urge them to carry on and only hnpermore individuals will join them to make their task easier and enjoyable.

The grounds position in Lenasia is still far from satisfac tory. The City Council is trying its utmost to fuel the fire be tween the two bodies. Taking into consideration the number of team we have in the Lenasia area we by right should have use of more than half the number of grounds in the area. The City Council has arbitrarily given the grounds to the Johannesburg City Council (J.C.C,) who ipsi facto are top officials of the Transvaal Cricket Council (T.C.C.) The City Council would like to lay us the mercy of the J.C.C. but I would like to ask who are the J.C.C. is it a private or public body, when do they hold elections? who are the Eligible? Are notice of meetings ever given? The questions are numerous and can go on and fill a page. In order to overcome this problems serious thought will have to be given to the idea of enforcement of our rights. The new season will show the postants

Hope that Lichenburg and fustenburg reaffiliate so that together with Potchefstroom Klerksdorp and Zeerust the West will be a formidable proposition . Any fears regarding exposure for Tvl. selection must be despelled because regular inter union or district matches will be played. Of late the black concious movement of which I am a member has been accused of being racist. It is one thing to be subjected to a gruellingsecurity Police interrogation to explain ones politics, but quite another to defend a palitical party of the oppressed masses to an audience that forms part of the oppressed.

By definition the term Black is used to describe all those who are oppressed in this country. The oppression is due to the racist law and the only way to rid ourselves of oppression is by fighting these laws and therefor Azapos STANCE OF ANTI RACISI. The term black exclusirism is a media created term which only the media can explain its reference upto now the B.C.L. has a membership of "Blacks" only and to date not a single "White" has applied for membership. How the applications will be dealt with will only be known once an application has been received but I know of no case that was rejected, on the basis of race.

The day A.S.APO or B.C.N. become racist that is the day my membership of it will cease.

Regarding mycandidacy for another term of office my words at last years A.G.L. are non negotiable. It is easy to be in Ali Bachers boots with money for Africa and facilities, to spare but another thing to be President of the T.C.B. On Sunday morning one is worried whether the carpets will be colected the wickets rolled, the dressing room opened and cleaned, whether the teams will pitch up on time whether food for upcountry teams will be provided and a hundred and one other worries. #### SECRETARIAL REPORT - 1980/81

## SUBMITTED TO THE FOURTH ANNUAL GENERAL MEETING OF THE TRANSVAAL CRICKET BOARD

#### MR P. SIDENT, DELEGATES AND MEMBERS,

I am privileged to submit for your consideration this report on the activities of the BOARD for the 1980/81 season.

#### 1. LEAGUE CRICKET

My congratulations to the Thistles C.C. for winning the Senior League Cricket Competition for the third successive time. Also to Vaal United C.C. for winning the "B" Section League Competion. I wish to stress that any team wishing to do well must give priority to net practices, to the development of basic skills and techniques and to reaching peak physical fitness before the season commences.

#### 2. HOWA BOWL

Western Province emerged as worthy withers after a strong challenge from Eastern Province.Although our team failed to win a match several good performances were put up.However,the standard of play remains well below that which one would associate with first-class three-day cricket.The standard will only improve if teams and cricketers take it upon themselves to devote and pay attention to the development of basic skills and techniques.

#### 3. BOOLEY TROPHY

The E.P.Cricket Association and Natal Cricket Board shared jointly the Booley Trophy and our thanks and appreciation to the W.P.Cricket Board who donated R 1 000,00 towards the "B"-Tournament which tremendously helped to less n the financial burden on the participating units.

Our Board, which hosted the North Zone Tournament successively, failed miserably and did not live up to expectations. Again, the lack of applying correct basic skills and techniques in batting and bowling saw the downfall of the team.

#### 4. SCHOOLS CRICKET

A lot of activity took place amongst the primary and high schools cricket.Although no national primary sch-ols tournament took place, the Transvaal high schools fared well in their national competition.

I would like to see high schools cricket being played throughout the season and not end once the Transvaal team is selected to play in the S.A.High Schools Tournament.

#### 5. JUNIOR CRICKET

It was encouraging to note the launching of a Junior Cricket League in Lenasia. If we fail to encourage cricket at junior level it will harm our cricket in many ways and with the compulsion of each senior team having to enter a junior team we can only be moving in the right direction.We must always remember that if our children and ourselves too reject coaching from racist sportsmen it is only right and duty bound that we provide our children with the necessary coaching to the best of our ability.

#### 6. SOUTH AFRICAN CRICKET BOARD

The following units constituted the SACB :

Transvaal,Border,Eastern Province,Griqualand West,Natal,SAPSSA, SASSSA,South-Western Districts and Western Province.

An application from the newly-formed Boland Cricket Board was accepted on the 28th May 1981 boosting membership to ten affiliates. The majority of the affiliates reported increases in membership and attempts at recruiting new members by clubs must be an ongoing process.

#### 7. SPONSORSHIP

It has become abundantly clear that due to the principle stand taken by the board in respect of our struggle for non-racial cricket requests for sponsorship have borne no fruit.Therefore fund-raising campaigns for the 1981/82 season must be pursued vigorously and the fullest co-operation must be forthcoming from all quarters.

I offer the following without comment :

A total of R 4 891 500,00 was budgeted last year by the Government for Sport and Recreation. In reply to a question in Parliament the Minister of Sport and Recreation said that during the financial year 1978/79 R 1 540 748,00 had been spent to further sport amongst the white population of South Africa. The Minister of Coloured Relations said that a total of R 141 207,00 was spent on the promotion of sport for Coloured persons. The Minister of Co-operation and Development said that R 190 000,00 was paid from the S A Development Trust Fund and R 128 954,00 from public funds to further sport amongst the African population.

#### 8. INTERNATIONAL CRICKET CONFERENCE

The majority of the members belonging to the I.C.C. made it quite clear that South Africa will not be accepted into the international fold until such time that Apartheid is abolished in South Africa.

I hereby take the pleasure of enclosing the SACB Memorandum which was presented to the I.C.C. conference in London during July 1981.

#### 9. SACU SUES SACOS BUT SACOS WINS

The South African Cricket Union was the Plaintiff when it sued SACOS. In its summons SACU claimed :

1. that during 1977 and 1978 SACOS addressed and published to its

members and associates and to the public a written document - the DOUBLE STANDARDS RESOLUTION.

- 2. that SACOS published in conjunction with the above document a list of persons who practise, perpetuate or condone racialism or multi-nationalism in sport.
- 3. that SACOS intended these words to mean that SACU practised racialism, (or multi-nationalism which SACOS equated with racialism) and that SACU was unfit to manage, administer or control cricket in South Africa.
- 4. that by using such words SACOS has brought SACU'S name into disrepute.As a result SACU should be paid R 15 000,00 by SACOS for this injury.
- SACU claims that these words were untrue and that its publication has -
  - (a) injured its "good name and reputation"
  - (b) turned away potential members from joining SACU
  - (c) caused SACU'S goodwill, name and standing in South Africa and elsewhere to be injured.
- that SACOS maliciously and unlawfully continues to publish such words concerning SACU.
- 7. SACU therefore claims from SACOS R 15 000,00 and interest;
- 8. interest on R 15 000,000 from date of judgment;
- 9. costs of the legal action;
- 10. an order stopping SACOS from publishing the words mentioned above.

Both SACOS and SACU had given an indication of the documents they intended to use at the hearing and the trial was set to be heard in Durban's Supreme Court beginning 4 February 1980.

Two days before the hearing SACOS were told by the Attorneys acting for SACU that SACU had withdrawn the case and at the same time had agreed to pay our costs.

#### 10. RECOMMENDATIONS

- 1. A brochure to commemorate the 1979/80 "8" Section North Zone was produced and I would like to see brochures being compiled for each of our interprovincial fixtures played at home.
- A coach be hired for a period of time allowed by our financial resources.
- 3. An effort must be made to involve parents in our Junior Cricket Leagues.
- 4. Efforts to win cricketers over to our cause must be intensified.
- 5. Inter-provincial fixtures be played in Potchefstroom and Roshnee to encourage the game there and it will serve as a lever for the BOARD to "spread its wings"
- 6. Clubs must concentrate on tightening their administration and BOARD officials must be invited to club meetings.
- 7. Each member of the BOARD must familiarise himself with the principles and policies of SACOS and thereby be able to expound them when called upon to do so.

## 11. CONCLUSION

The past season was a very successful one and my thanks go to the President for his leadership and total dedication and to the other officials for their assisstance,guidance and co-operation.

MEMORANDUM TO THE INTERNATIONAL CRICKET CONFERENCE ON THE QUESTION OF THE INTERNATIONAL RECOGNITION AND MEMBERSHIP OF A SOUTH AFRICAN CRICKET CONTROL BODY

#### 1. THE CONTROL OF CRICKET IN SOUTH AFRICA

We submit that in South Africa today there is no single body controlling cricket, but that there are two separate bodies, namely, the SOUTH AFRICAN CRICKET UNION, and the SOUTH AFRICAN CRICKET BOARD.

#### 2. THE SOUTH AFRICAN CRICKET UNION

The SACU was formed in September 1977, through a loose amale gamation of the South African Cricket Association (White), the South African African Cricket Board (African), and the South African Cricket Board of Control (non-racial). (See Appendix A) The SACU embraces the official sports policy of the South African Covernment.

#### 3. THE SOUTH AFRICAN CRICKET BOARD

The SACB was formed in November 1977. (See Appendix A)

#### 4. THE SACU APPLICATION

We submit to the members of the International Cricket Confe= rence that it would be premature to consider an application for affiliation from the South African Cricket Union, for the following reasons

- The SACE remains optimistic that all South Africa's sports= men and sportswomen can play an important role in the crea= tion of a truly open society in which the sports problems which they now experience could be resolved. The immediate commitment is the formation of a single non-racial control= ling body for all in a non-racial South Africa. International acceptance of the SACU and the resumption of cricket ties would remove a vital element in this historical task, and severely impede the process of the unification of all cricketers. The resumption of tours on a selective basis is not acceptable. The present situation is that some mem= ber countries of the ICC would only be allowed to come to South Africe as "honorary whites". The SACU is prepared to accept such a situation.

- The SACU does not represent all cricketers in South Africa. The SACA of which the provincial units and clubs until very recently had exclusion clauses in their constitutions, is still in existence and constitutes perhaps over 80% of the SACU. For the 1981-\*82 cricket season the SACB will approach the 5 00C mark for senior registrations (i.e. excluding schools' and junior cricketers).
- The SACU has not come out clearly in favour of a non-racial sports system (as distinct from the multi-racial setup as at present) and the removal of discriminatory legislation from the statute books. In other words, it believes that cricket can be isolated and compartmentalised within the broader Apartheid structure of South African society. (See Appendix B)
- The SACU has confined its so-called normalisation of cric= ket to club cricket and above. It has remained conspicuous= ly silent on schools' cricket and junior cricket.

We, therefore, request the International Cricket Conference to reject the application from the South African Cricket Union until such time as South African society has itself become non= racial and sport has been completely freed from the impediments which today hamper its natural development.

#### APPENDIX A

#### THE BREAKDOWN OF THE 1976 NECOTIATIONS

For the record we wish to recapitulate the causes of the breakdown in the negotiations for the formation of a single controlling body for cricket in South Africa in 1976. The Mine-Man Committee appointed on January 13, 1976 used as the basis for their exercise the question: "If there had been no laws in the way of the normalisation of cricket, how would South Africa's cricketers organise themselves from club level upwards ?" This major assumption was of crucial importance because the non-racial majority in SACBOC were acutely aware of the laws that stood in the way of non-racial cricket, even if the same could perhaps not be said of the SACBOC leadership at the time.

The announcement of the "new" sports policy in September of that year vindicated the suspicions of non-racial cricketers. It was quite clear that no laws would be changed and that cricketers were to be satisfied with governmental concessions on the question of mixed sports. Nevertheless, the Nine-man Committee went ahead and formed the CACU in September the following year.

Realising that their parent body had abandoned them, the majo= rity of cricketers in SACBOC reconstituted themselves into a new body, and the SACB was formed in November 1977.

#### THE POLICY OF THE SOUTH AFRICAN CRICKET BOARD

The SACU has no sports policy. Its policy coincides with the official sports policy of the South African government. The main facets of the SACB sports policy are :-

- That participation in organised sport is a natural and de= sirable social activity. Sport has been used as a powerful means of promoting understanding between people of diffe= rent colours and cultures, and of different religious and political persuasions throughout the world. Sport can trans= cend projudices and cultural differences, and can have a catalytic effect on the improvement of human relations. Every society should, therefore, encourage the free participation of all its citizens in sports, and provide facilities for the practising of sports equally. A society which denies the majo= rity of its members, through legalised action, this vital in= gredient in the socialisation process, does not deserve a place in international sports organisations.

The International Cricket Conference has been a major agency in the promotion of international understanding through sport. By denying South Africa international participation since 1968 are it has demonstrated quite clearly that there certain minimum requirements for membership to the international cricket fraternity. Surely there has been movement in that direction. But not nearly enough has been done.

- That sport cannot be viewed in a vacuua.

The human being has many needs. It is only after basic needs have been catisfied and a reasonable standard of living has been reached, that people can divert their attention to re= creational needs, such as participation in a relatively ex= pensive game such as cricket. The game of cricket clearly bears a direct relationship to the whole socio-economicpolitical structure of society. Where a society deliberately keeps the majority of its population at a level of social development where they sometimes are forced to struggle even to satisfy basic needs, the development of sport must necessarily be severely hampered.

Laws such as those concerning "race" classification, group areas, separate educational systems, job reservation, sepa= rate amenities, etc. have a serious social effect on commu= nities and their participation in sport. (See Press clip= pings)

4.

We could probably write a whole volume of case histories of affected how these humiliating laws have and are affecting non-racial cricketers in our fold.

We will, however, make brief mention only of a few instances :-

- (a) 55 Black people, mostly women, were declared to be illegally present in the Western Cape and summarily deported under the Urban Areas Act, to their homeland, the Transkei. After a few days 30 of the women returned with their children.
- (b) 150 families in Fordsburg, Johannesburg, were faced with Group Areas eviction. This area is in the heart of the stronghold of the SACU president. One important consequence of this event is that many of the cricketers were playing under SACU on Saturdays, when the Apartheid laws are lifted for their participation, and now they found themselves faced with evic= tion by the very same of group of people or their representa= tives. The hard reality that sport cannot be taken out of its social context was brought home to these cricketers, and many of them sought membership of the SACB instead.
- (c) An overseas Pop Group visiting South Africa cancelled all fur= ther shows when they discovered that patrons had to have permits to attend their shows.
- (d) reaceful anti-Republic demonstrations degenerated into rioting because of the draconian actions of the police. Many sportsmen suffered injury in these demonstrations.
- (e) A group of Black sports fans, returning from a multi-racial event, was driven out of a whites-only railway coach.

#### PRESS CUTTINGS;

The enclosed press cuttings have all been taken from the liberal conservative white opposition press in the Western Cape. Most of these cuttings reflect non-racial thinking. Yet a few years ago these same newspapers accused non-racial sportum nof agita= tion and unreasableness.

### APPENDIX D

The SACE has been very careful to define its terms, so that could be no sisunderstandings. When we use the term non= racialism, we imply the free interaction of all human beings in all the activities of society, with no regard to the race or racial group to which they belong. This, furthermore, means that as long as there is a race-classification law. and governmental pronouncements and concessions and permis= sions govern the practising of sport, there cannot be non= racial sport but only multi-racial sport (or in the case of the various "Black nations", multi-national sport). When the ICC uses the term multi-racialism we take it to mean non-racialism, because in the international context this means free interaction without regard to race. But when the SACU, for instance, claims that they are non-racial, thero is a definite misunderstanding here, for in the present South African context non-racial sport is not possible. The SACB has a non-racial commitment in sport and deliberately strug= gles towards a non-racial sports system. It has no interest in the furthering of multi-racial or multi-national sport. The SACE, therefore, clearly does not categorise its players into racial groups.

# PROBLEMS ENCOUNTERED :-

- 1. Rain interrupted many fixtures.
- 2. Playing fields Only three playing fields were used in Lenasia. The playing fields were not allocated to us and thus the fields were not maintained. Shortage of playing fields limited the number of teams we could accept. The "dog in the manger" attitude of the Johannesburg City Council must be strongly condemned. Whilst ten playing fields lie empty, we had to turn away juniors because of the shortage of playing fields.
- Lack of senior involvement left a few teams without any guidance or assistance.
- Lack of cricket gear Some teams were poorly equipped but the teams shared the limited stock that was available.

# SOLUTIONS :-

- The Board has acquired a lot of equipment for the juniors which will help the poorly equipped teams.
- If we are deprived of using the playing fields again, I recommend we use them by force.
- More seniors must participate more actively in coaching and administrating the juniors.

# RECOMMENDATION :-

- Every senior club centrally situated must have a junior team under their fold. They must be responsible for coaching their juniors.
- A squad of promising players from each team must be drawn up. This squad must be coached regularly by our senior provincial players on rotation.
- 3. Incentives for individual players and teams must be found.

South African Primary Schools' Sports Association (SAPSSA) The is organizing a cricket tournament in December and the Transvaal , Primary Schools' Sports Board has committed itself to participate in the tournament. It is the fervent wish of the Transvaal Primary 'Schools' Board that the T.C.B. would assist us to go on tournament. The assistance was promised last season, especially as regards cricket equipment, was not forthcoming.
