
CHOOSE SIDES IN

APARTHEID

THE GOVERNMENT is denying 85% of the population the right to vote, adequate housing, education, and land because they are Black.

THE GOVERNMENT is using its army and police to jail, torture and kill men, women and children demanding freedom.

THE GOVERNMENT, under tremendous pressure, is making changes to try and relieve sanctions pressure while maintaining white minority rule.

HAS APARTHEID ENDED?

No. Under mounting pressure at home and abroad, the South African government has made some dramatic concessions - unbanning the African National Congress and other opposition groups, and releasing Nelson Mandela.

But the pillars of apartheid remain. Black South Africans can't vote for President or Parliament, 87% of the land is reserved for whites and fearsome security laws threaten apartheid's opponents.

Real change must be based on the demand for effective political power through one person, one vote in a unitary, nonracial state. To this demand the government has said no.

WHY CHANGES NOW?

The people of South Africa are putting powerful pressure on the government, mobilizing millions through democratic organizations such as the trade union federation COSATU, the United Democratic Front and the African National Congress.

Sanctions are forcing change. International economic sanctions have cost the South African regime \$32 billion over the last five years.

TIME FOR NEGOTIATIONS?

The people of South Africa have pressed for peaceful change since the beginning of this century. The government has responded with brutality but now says it is willing to negotiate.

Before serious negotiations can even begin, the people insist the government create space for free political activity by: repealing all repressive legislation, ending the state of emergency, releasing political prisoners, unbanning all organizations, removing troops from the townships, and stopping all political trials and executions.

SANCTIONS UNTIL DEMOCRACY

The South African regime is already calling for sanctions to be ended. In Washington, the Bush administration is talking about lifting sanctions to encourage "reforms."

But the people are saying the aim of sanctions was never to reform apartheid. They say sanctions should be intensified until after apartheid has been replaced by democratic majority rule in a unitary, nonracial state. Until that time, sanc-

tions will play a critical role in forcing the regime to change.

WHY THIS CAMPAIGN?

THE VOTE FOR DEMOCRACY is a dramatic way to demonstrate support for the people of

South Africa and their demand for one person, one vote on a common voters roll in a unified nonracial state.

THE VOTE FOR SANCTIONS is the first step to support this demand in the United States. U.S. dollars have propped up apartheid for years.

> Sanctions passed by Congress in 1986 began to end this support. Now is the time to stop it altogether.

Your votes can send a powerful signal to South Africa that the American people aren't fooled by signs of change, but are demanding the fundamental right of all people to freedom and democracy.

To win this struggle for democracy, we will need hundreds of thousands of votes in the United States.

- Collect votes from your family, friends and co-workers.
- Organize an election. Announce you will collect ballots for DEMOCRACY and SANCTIONS.
- Organize a pledge drive for votes. Urge your church, school, union or community group to collect one vote for every member they have within the next three months.
- Contact your city officials, ask them to pass a city council resolution endorsing the campaign.


