ORIGIN AND DEVELOPMENT OF ALEXANDRA TOWNSHIP.

The township was first laid out in 1905 is 415 morgen 479 square roods in extent, and consisted, as first surveyed, of 338 lots, 2 parks and a square, in addition to streets. It was intended originally for European occupation, but there was no demand for lots on the part of European purchasers, and in 1912 the Township Company (The Alexandra Township, Limited) decided to turn it into a non-European Township, to be reserved exclusively for Natives and South African Coloured persons, and to include in the titles restrictions against ownership or occupation of lots by any European or Asiatic. With a view doubtless to giving effect to this plan of making Alexandra a Native and Coloured township, the general plan of the Township was altered in 1912, and the ground was sub-divided into 2,308 lots, 3 squares and 1 reserve. In 1916 the plan of the township was again amended by the relaying out of a certain portion of it, which resulted in a further increase in the total number of lots; since this amendment of the plan in 1916 the township has included 2,525 lots, of which 2,185 are 140 by 80 feet. and 340 are 140 by 50 feet.

The acquisition by Natives of lots in the township up to the present time has been sanctioned by Section 8(1)(i) of the Natives Land Act, 1913, which provides as follows:-

Nothing in this Act contained shall be construed as -

(i) prohibiting the acquisition by Natives from any person whatever of land or interests in land in any township lawfully established prior to the commencement of this Act, provided it is a condition of the acquisition that no land or interest in land in such township has at any time been, or shall in future be, transferred except to a Native or Coloured person.

In January, 1913, 167 lots had been sold. In 1928 636 lots in the township had been transferred to purchasers, and there were 797 lots which had been sold, and were in most cases occupied. but had not been transferred to purchasers; 1,088 lots were still unsold and unoccupied. By 1936 practically all the lots had been sold; 1,500 had been transferred, and 1,000 had been sold but not yet transferred to purchasers. In January, 1913, there were about 40 houses, and about 40 Native and Coloured families were living in the township. In 1916 there were 200 houses and a population of about 900. In 1924 there were 440 houses and a population of 2,640. In 1929 the number of houses had increased to 1,200 and the population was estimated at 7,200. In 1936, according to the preliminary census figures, the population consisted of 10 Europeans, 15,945 Natives and 808 Coloured persons.

In October, 1932, the Health Committee as constituted under Proclamation No. 23 of 1921 was disestablished by the Administrator, acting in exercise of the powers conferred by Section 146(2) of the Local Government Ordinance 1926, by reason of its failure to function efficiently as an administrative body.

Under Administrator's Proclamation No. 114 of 1932, dated 5th December, 1932, a new Health Committee was established for Alexandra Township, which assumed office on the 1st January, 1933. This Health Committee was constituted on an entirely different basis to the Committee provided for by the Proclamation of 1921. The new Committee was to consist of 7 nominated members, of whom four were to be Europeans, two were to be Natives and one was to be a Coloured person; the Native and Coloured members were to be nominated by the Minister of Native Affairs; (the Coloured by the Administrator on the nomination of the Minister); the Chairman of the Committee was to be a European appointed by the Administrator, and was to receive from the revenue of the Committee such remuneration for his services as might be fixed by the Administrator.

Mr. H.G. Falwasser, a senior official of the Native Affairs Department, who retired from the public service in January, 1933, after serving for 32 years in that Department was appointed Chairman of the 1933 Committee, his remuneration being fixed at £250 per annum in terms of the 1932 Proclamation.

From 1933 to 1958 changes in the constitution of the Health Committee were effected from time to time but no solution could be found for the then chronic complaint: the failure of the Health Committee to function efficiently as an administrative body.

Since February, 1958, the administration of Alexandra Township has been taken over by the Peri-Urban Areas Health Board.

DECIMALIZATION.

The topic of decimalization, i.e. the change-over from the present sterling (pounds, shillings and pence) to decimal (Rand and cents) currency has for more than a year received such wide and intensive radio and press publicity that it is not necessary for the Bulletin to add anything further except to point out that the new system will from the 14th of February, 1961, affect residents in all their financial transactions including the purchase of milk Depot commodities the relevant prices of which are given hereunder:

The Decimal equivalents for Sanitary, Water, Cemetery, Pound, Building Plan, Licence and Supervision Fees, Erf Tax and other charges payable to the Local Authority for various services will be supplied by officials and cashiers in charge of the departments concerned. Similarly with the decimal rates for beer.

The bus fare decimal tariff is desplayed on every vehicle and will also be explained by the officials concerned.

Malebjoe of the Bantu Methodist Church who is also a member of the Alexandra School Board, School Board Member, Z.P. Ramailane, Mr. L.C. Koza, vice Chairman of the Secondary School Committee and Rev. B.M. Molaba, School Board Chairman.

Making a total of R270.00 which will be allocated to the library fund, domestic science equipment fund and other incidental expenses.

The Regional Director announced that the Department had decided to grant R14,000.00 (Fourteen thousand rand) for a new Pholosho School in the new financial year.

The Pholosho School was established in 1956 following the disestablishment of the St. Michaels Anglican Mission School Alexandra, at the end of March 1955 following upon the coming into effect of the Bantu Education Act. The School has since been acommodated in isolated church halls and other premises scattered over an inconveniently accessible area of the township thus rendering effective control and supervision by the principal rather difficult.

The new school will be sited on No. 3 Square.

The Bulletin takes this opportunity to thank the Education Department and the local authority for their part in promoting and extending much needed and highly appreciated cultural and social services for the residents of Alexandra.

MR. G.D. KOTZÉ.

The resignation of Mr. G.D. Kotze, Chief of the Board's Alexandra Welfare Department, at the end of February 1961, virtually took everybody by surprise and his abserce will be felt not only by his colleques and members of his staff but also by the many residents who have since early in 1958 enjoyed the privilege of his sympathetic and generous handling of their problems.

Mr. Kotzé's duties included the organisation and administration of such social services as sport and recreation, care of the aged and infirm, youth clubs, rehabilitation of delingquents etc. He also took particular interest in the cultural side of the community's doings by helping to improve the local library.

BANTOE-BELEGGINGSKORPORASIE STŁL HUISBOULENINGS BE-SKIKBAAR.

Gedurende die eerste vyftien maande van die aktiewe bestaan van die Bantoe-beleggingskorporasie van S.A. Beperk, is 920 aansoeke om finansiële bystand ontvang; 688 van hierdie aansoeke is reeds ondersoek terwyl 85 lenings ten bedrae van R284,000 toegestaan is. Behalwe twee lenings vir die oprigting van klein nywerhede, is die oorgrote deel van die fondse wat tot dusver deur die Korporasie beskikbaar gestel is, vir die finansiëring van die klein- en groothandel aangewend. Hoewel daar 'n groot aanvraag om finansiële bystand bestaan, is weinig aansoeke egter vir die oprigting van nywerhede ontvang. As gevolg daarvan en met die oog op die dringende noodsaaklikheid van 'n versnelde tempo van nywerheids-ontwikkeling in die Bantoegebied het die Korporasie magtiging verkry om gevestigde besighede en nywerhede van nie-Bantoepersone in die Bantoegebiede oor te neem en self met die oprigting van besighede of nywerhede in die Bantoegebiede voort te gaan, met die uitsluitlike doel om geskikte Bantoepersone geleidelik op te lei vir die oorname van hierdie sake.

Dit word in die vooruitsig om groeipunte van ekonomiese bedrywighede te skep en uit te bou in elk van die agt tegniese gebiede van die Bantoe. Dit word beoog om 'n proses van ekonomiese ontwikkeling aan die gang te sit binne die bestaande groot bevolkingskonsentrasies in die Bantoegebiede, en veral by die plekke waar Bartoedorpe reeds gevestig is en waar daar reeds 'n kern van koopkrag aanwesig is. Daar sal gekonsentreer word op die ontwikkeling van kleiner nywerhede wat algaande uitgebou kan word, namate die Bantoe die nodige tegniese kennis en ondervinding opdoen. Die Bantoe sal sover moontlik by hierdie ondernemings betrek word sodat die geleentheid aan hom gebied word om die nodige tegniese kennis en opleiding te bekom.

Ten einde die ontwikkeling van die Bantoedorps- en ander goedgekeurde gebiede in die Bantoegebiede verder te stimuleer, sal die Bantoe-beleggingskorporasie voortaan huisboulenings onder bepaalde voorwaardes beskikbaar stel aan individue wat van voorneme is om woonhuise, volgens eie keuse van ontwerp, te bou.

BANTU INVESTMENT CORPORATION TO PROVIDE HOUSING LOANS.

During the first fifteen months of its active existence, the Bantu Investment Corporation of S.A. Ltd., has received 92C applications for financial assistance; 688 of these applications have already been considered whilst 85 loans amounting to R284,000 have been granted. With the exception of two loans

for the establishment of small industries, the greater portion of the funds so far advanced by the Corporation were for the financing of retail and wholesale undertakings. Although there is a substantial demand for financial assistance, very few of the applications received are for industrial undertakings, however.

As a result thereof and with a view to the urgency of an accelerated tempo of industrial development in the Bantu areas, the Corporation has obtained powers to acquire established business and industrial undertakings from Non-Bantu persons in the Bantu areas and itself to proceed with the establishment of business and industries in the Bantu areas, with the exclusive purpose of gradually training capable Bantu persons for taking over these projects later.

It is intended to create and develop centres of economic activity in each of the eight Bantu ethnic areas. It is also the aim to initiate a process of economic development if the existing large population concentrations in the Bantu areas particulary where the prospects of a consumers' market are assured by the existence of established Bantu townships.

The Corporation will concentrate on the development of small industries which will be extended as and when the Bantu gain the necessary technical knowledge and experience.

The Bantu will as far as possible be drawn into these undertakings so as to afford them opportunities to acquire the necessary knowledge and training.

With a view to stimulating the development of Bantu townships and other approved areas in the Bantu areas, the Bantu Investment Corporation will henceforth grant housing loans to Bantu individuals, under certain conditions, who intend to build houses in the Bantu townships, in accordance with their own specifications and designs.

SALE OF FURNITURE AND HOUSEHOLD EFFECTS.

Our local Bantu Affairs correspondent informs the Bulletin that a number of good and serviceable items of furniture and household effects left over when the assets of late DANIEL KAMANGA were auctioned last month by the Bantu Affairs Commissioner, are on view at the said Commissioner offices, 2nd Street, Wynberg, for sale at attractive prices.

The effects include a dining room suite, a dressing table, grass basket and an empty radio cabinot.

BLEEDING SESSIONS.

Two hundred-and-thirtynine donors turned up for the recent bleeding session at the stadium, shedding as many pints of blood in a good cause.

As everybody should know by now, all blood collected in this way goes to the hospitals where it is used to help restore to health the thousands of our people who become injured in all sorts of accidents and assaults. Many have been saved from death by these blood transfusions.

At the time of "going to press" we had not received a single reply to our invitation for comments on the Liquor Amendment Act wherein provision is made for the supply of European liquor to Bantu.

We, therefor, conclude that your silence means consent and that you want the Board to go ahead with the preparations which will be necessary to facilitate the sale of liquor as and when the authorities give the OK!!

N.G. SENDINGKERK, ALEXANDRA 1921 - 1961.

With the completion of extensions and renovations to the N.G. Sendingkerk building in 4th Avenue, and the re-dedication thereof next month, the Alexandra congregation can look back with satisfaction on forty years of progress and development.

Waar die jaar 1961 nou vinnig sy einde nader, en waar 'n mens gedurende die Kersgety onwillekeurig dink aan goeie dade wat mens aan andere kan doen is hierdie sekerlik 'n gepaste tyd om terug te dink aan dit wat gedurende die afgelope twaalf maande te Alexandra verrig is deur die Plaaslike Gebiedskomitee en die Raad. ens. Met die ander dienste hierbo genoem sal sonder onderbreking voortgegaan word.

As mens dink aan al die dinge hierbo genoem moet jy tot die gevolgtrekking kom dat goeie vordering gemaak is met die groot taak om Alexandra 'n aangenamer woonbuurt te maak vir sy inwoners deur die verbetering van toestande aldaar.

BOODSKAP DEUR MNR. M. SMUTS, HOOFBANTOESAKEKOMMISSARIS VAN DIE WITWATERSRAND, AAN DIE INWONERS VAN ALEXANDRADORP.

Die boodskap van Kersfees is 'n boodskap van vrede op aarde. Dit is my innige wens dat daar vrede mag heers ook in Alexandradorp en in die harte en gemoedere van alle inwoners van die dorp.

So dikwels lê 'n mens die blaam vir gebrek aan vrede by homself op die dade van andere. En tog is 'n mens tot 'n groot mate self daarvoor verantwoordelik, want vrede is 'n hoedanigheid wat vloei uit sy eie gemoed en uit sy eie denkwyse en lewenswyse. 'n Mens kan, indien hy wil, 'n gevoel van vrede geniet selfs te midde van die gewoel en die baie ergernisse van die stadslewe.

Maar indien elkeen sou agslaan op die boodskap wat jaar na jaar tot ons kom wanneer ons daardie groot gebeure in die geskiedenis van die mensdom, die geboorte van Christus, herdenk, hoeveel makliker sou dit nie vir almal wees om vrede te ondervind nie. Ek bedoel groepe soos die kommuniste en baie ander. Hulle haat die Christelike godsdiens met sy boodskap van vrede en goedgesindheid tussen die mense.

Die beste manier om sulke kwaadstokers op te behandel, is om te weier om na hulle te luister want hulle laat 'n mens net ongelukkig voel.

Die regering wil hê dat die mense gelukkig moet wees. Die regering streef daarna om gevestigde toestande te skep en om huise daar te stel waarin elke gesin by homself tevrede kan woon. Slumtoestande en oorbevolking skep geensins geluk en tevredenheid by die bevolking nie. Daarom word gesinne na huise in Diepkloof en Meadowlands verskuif.

Nou word gesê dat die regering die verskuiwing van huurders beplan het om die huiseienaars in die verknorsing te bring. Dit is nie so nie. MESSAGE BY MR. M. SMUTS, CHIEF BANTU AFFAIRS COMMISSIONER OF THE WITWATERSRAND TO THE RESIDENTS OF ALEXANDRA TOWNSHIP.

The message of Christmas is one of peace on earth.

It is my sincere wish that there may be peace also in

Alexandra Township and in the hearts and minds of each and

every resident of the township.

So often when one does not find peace, one places the blame on the actions of others. And yet much of the blame attaches to oneself, for peace is an inward quality, flowing from one's way of thinking and living, and from the

state of one's mind. One can have peace even amidst the bustle and the many annoyances of city life.

But if each one would heed the message which comes to us year after year when we celebrate that great event in the history of mankind, the birth of Christ, how much easier would it not be for all men to find peace. My wish, therefore, is that more people in Alexandra than ever before will go to their churches during this Christmas season to hear the message and to find peace.

Unfortunately there are individuals and associations that do not want peace. They are worshippers of strife and unrest. They thrive on discontent and they instil into the minds of men thoughts that make them dissatisfied and unhappy and annoyed. They do so because they belive that such thoughts will lead men to violence and they know that their unworty objectives are best furthered by conditions of unrest.

I refer to groups like the Communists. But there are many others! They hate Christianity with its message of peace and goodwil towards men. The best way of dealing with such trouble makers is to refuse to listen to them, for they only make you unhappy.

The Government wants the people to be happy. The Government strives to create settled conditions and to provide houses in which each family can live on its own in peace. Slum conditions in which families are overcrowded, cannot make for happiness and contentment. Therefore families are being moved to houses in Diepkloof and Meadowlands.

Now it is said the Government's object in moving the tenants is to injure the property owners. That is not so. The Government also looks after their interests and has made money available to enable the Peri-Urban Areas Health Board to buy houses when the owners have difficulty in meeting instalments on their bonds. In other words the Government

has in effect provided an insurance to safeguard them against undue losses. That shows there is no intention to be hard on them, but rather a desire to make things easier so that they too may be happy and contented.

I thank the people of Alexandra for their co-operation with the authorities during this year. Great progress has been made with the resettlement. I hope this spirit of co-operation will continue during the ensuing year so that Alexandra may soon be turned into a modern town where people can live in safety, in peace and in happiness and where conditions of prosperity prevail.

I wish you all a happy Christmas and a prosperious New Year.

Daar bestaan blykbaar by verskeie persone en liggame wat verantwoordelik is vir die aanstelling van onderwysers(esse) 'n sekere mate van misverstand in verband met hierdie saak.

Aangesien die jaar nou ten einde loop en baie nuwe aanstellings oorweeg moet word vóór die skole in Januarie 1962 heropen, word dit nodig geag om 'n sekere mate van leiding te gee

Dit moet beklemtoon word dat die ongetroude onderwyseres die eerste aanspraak op 'n pos het omdat sy pas opgelei is en nou die nodige ondervinding moet opdoen en ook 'n bestaan moet kan maak.

Die ongetroude onderwyseres is geregtig op 'n pos solank sy ongetroud bly. Indien sy trou kom sy in die groep van getroude onderwyseresse wat in sekere omstandighede 'n pos aangebied kan word maar dan alleen op 'n tydelike basis. Met tydelike basis word bedoel, vir 'n beperkte tydperk terwyl daar geen geskikte ongetroude onderwyseres beskikbaar is om haar te vervang nie maar in elk geval nie langer as 'n jaar nie.

Die prosedure by die aanstelling van onderwyseresse wat deur almal gevolg moet word is kortliks as volg:-

- (1) Alle vroulike poste moet deur onderwyseresse gevul word;
- (2) Sodra 'n vroulike pos wat deur 'n man of 'n getroude vrou gevul was vakant raak moet die pos adverteer word en aansoeke aangevra word om die vakature;
- (3) Nadat aansoeke ontvang is, is dit die plig van die betrokke Raad om voorkeur te gee aan 'n ongetroude onderwyseres indien daar een is;
- (4) Indien dit gevoel word dat die ongetroude aansoekers ongeskik is vir die betrokke pos dan moet die aansoeke deur middel van die Inspekteur na die Streeksdirekteur verwys word, met 'n volledige verklaring waarom die ongetroude onderwyserese ongeskik geag word en voorkeur aan 'n getroude onderwyseres gegee word. Hierdie kantoor sal die aansoek behandel en indien nodig, voorlê aan die Departement vir 'n beslissing;
- (5) Elke geval moet afsonderlik behandel word. Die Departement kan nie vir alle gevalle 'n algemene maatreël bepaal nie veral aangesien dit tog die beleid is dat voorkeur aan ongetroude onderwyseresse gegee moet word;
- (6) Die hierbo aangegewe prosedure moet vir beide prinsipaalsposte sowel as assistentsposte gevolg word;
- (7) Dit is in alle gevalle noodsaaklik dat slegs onderwyseresse wat aan die vereiste taalgroep behoort aangestel word.
