including any special session of Chiefs.(c)To call the roll of dele-gated; (d)To receive on behalf of the Speaker all reports by Committe es in convention;(e)And generally to be a recorder of all the pro-ceedings and deleberations of the Conventions of the National Con-gress, and to discharge such other duties as may be assigned to him by the Speaker the Speaker.

-(157) There shall also be elected on the nomination of the President Senior and Junior Chaplains of the National Congress. They shall have been fullyordained ministers for a period of seven years and shall hold office during pleasure of the President.

Their duties shall, in consultation with the Speaker be to prescribe the time of prayers and services during the Conventions and to conduct the services thereon. The Senior Chaplain or his Deputy shall preach the official sermon on the day and time appointed in the agenda. (158)It shall be competent for the Speaker to appoint Sergeants at arms

to act as ushers and orderlies in the preservation of order and the conduct of deliberations of the Conventions and generally to execute the orders of the Speaker. They shall receive remuneration varying to a sum not exceeding 10/- per diem each. (159) The Speaker shall also appoint competent persons to interpret during the Conventions and the sitting of the Committee-in-Convention.

The Speaker may also appoint official Translators on such remuneration as may be fixed. (165)Any member or delegate no being able to attend any meeting in per-son may be allowed to vote by proxy on payment of a fee of 2/6 in re-spect to a delegate. The proxy shall be as near as possible to the form prescribed in the Schedule hereunder marked "G".

(11) A delegate desiring to speak must rise in his place and address him calf to the chair No intermution to his speach chall be allowed event

self to the chair. No interruption to his speech shall be allowed except on question of"Order".

(111) When two or more delegates rise to speak the Chairman shall call allowed the name of the delegate who on rising in his place is first observed by the chairman: such call shall not be challenged. Provided never the less that A chief shall always receive preference: And provided further that a motion may be made that a delegate who has rissen to speak "be now heard".

(IV)All motions and amendments (except formal motions) must be seconded and handed to the Chairman in writing.

(V)Each speaker shall direct his sppech to the motion proposed as the question for discussion or to a motion or amendment to be proposed by him self or to a question of "Order".

(V1) No speaker shall be allowed to speak more than once on any subject nor longer than ten minutes. He may be allowed to explain or correct a mistatement or misunderstanding in regard to some material part of his speech but he is not to introduce new matter or to interrupt a member who is speaking.

(V11) A mover of a substantive motion or resolution may be allowed to reply.After the mover has commenced or made his reply no other member shall speak to the question. An amendment and formal motions are not substantive motions.

(VIL) When a point of order arises any member may speak, immediately and commence by a statement that he rises to order. The member who was addressing the meeting must there upon resume his seat, and so also, must the member who rose to order; when he concluded his appeal to the chair.

(1X) No motion or amendment or any matter which is the same in substance may be proposed or debated upon after it has been decided. No motion or amendment once made and seconded shall be withdrawn with out leave.

(X) Notice of every motion must be given before being presented for dis-cussion except any of the following which may be moved with out any previous notice:-

Appointing a Chairman. For consideration of any business or communication

specially brought forward by the Chairman.

For the adjournment of any meeting. For making entry or alteration on the minutes for receiving, adopting and carrying or referring back any report. For reading, answering and considering any correspondence or

other documents.

For hearing any applicant or petitioner.

For the precedence of any particular business.

For appointing any business for the consideration of any future meeting.

For appointing Committees or referring any matters to Committees,

On a matter of Privilage, For closing the debate or "That the question be now put". For any matter that is urgent or immediate, Amendments also may be moved without notice.

(X1)No notice of motion to rescind any Resolution which has been passed shall be in order, unless in addition to the names of the proposer and seconder, the names of ten other supporters are attached to the notice of motion. The rescission shall not be effectual unless the motion to rescind is carried by two-thirds majority of the members present. (X11)All questions shall be decided by a majority of votes.All votes shall be counted by the Chairman or his agent but in case of a ballot scrutineers shall be appointed. Elections may be by ballot. (X111)A delegate or officer shall not absent himself from the meeting without the consent of the Chairman. No absent member shall be nominated for any office unless his consent in writing to be nominated has been previously obtained.

(XIV)Any delegate refusing to obey the Chairman's ruling or being guilty of irregularity or misconduct shall, upon a vote being taken withdraw from the meeting, and the Convention shall have the right to suspend any such delegate for any period it may determine or impose by vote, a penalty not exceeding five pounds with or without suspension.

(XV) It shall be the duty of the Chairman:-To keep order,

To conduct the proceedings in accordance with the recognised principles and Rules of the debate.

To order any member to discontinue his speech for irrelevance, repetition, offensiveness, or use of unparliamentary language or on other ground or reason.

To order the withdrawl of a member for noice or unseemly conduct or irregularity.

To order the forcible ejectment of a member for any of the above causes or other just cause.

To quit the Chair upon disorder or other just reason and adjourn the meeting By the Chairman quitting the chair in case of disorder the meeting shall be adjourned.

To declare forfeiture of a delegate's deposit or the removal of the delegate's suspension.


(XV1)Whenever the Chairman quits the Chair or announces the adjournment, the Convention is thereby said to be immediately adjourned and no business subsequently transacted shall be valid upon any pretext whatsoever. (XV11) If a Chairman or vice Chairman shall be absent or late for more than five minutes after the appointed time, the members present forming a quorum shall immediately proceed with the meeting by electing one of them to take the chair and the Chairman so late so late shall be liable to forfeit his deposit hereunder mentioned.

(XVIII)It shall not be lawful for any member to remain standing whenever the Chairman rises to speak and no interruption shall be allowed. Deference to the Chairman's ruling and authority shall always be paidby all members.

(X1X) It shall be competent for the Committee of the branch to cause a list of members in default with their membership fees, fines or other payments to be read aloud in the meeting or to be published or posted on the door of the place in which the meeting of the branch is ordinarily held. No such reading or publication shall be inorder until one month's notice to that effect has been given to the member or member in default. (XX) Any one or more of the Standing Orsers or Rules of procedure on grounds of urgency or expediency, upon motion made after notice has been duly given in writing, may be suspended at any meeting, so far as regards business at such meeting for that particular occassion only, provided it is agreed upon by two-thirds majority of members present at the meeting (XX1) This Constitution shall be printed in two editions of Sechoana-Xosa and Zulu-Sesotho, and every officer of the Association shall possess a copy.

(XX11)It is hereby declared that for the conduct of business in the Convention the Rules of procedure herein contained shall each and every one of them be read as supplemental and in addition to the rules observed in the Houses of Parliament of the Union. And in the event of conflict between the rules and those of the Union Parliament the Rules here in contained or any future Rules and Regulations for the conduct of the business of the Convention, shall always prevail.



MINUTES OF A MEETING OF THE GOCIAL SERVICES SUB-COMMITTEE OF THE JOHANNESBURG SOCIAL SECURITY ACTION COMMITTEE, HELD IN THE SUB-COMMITTEE ROOM, CITY HALL, JOHANNESBURG, ON WEDNESDAY, 2nd DECEMBER 1942.

RESOLVED

STATEMENT OF POLICY REGARDING SOCIAL SERVICES. I.

RESOLVED

That this sub-committee recommend to the Executive Committee the adoption of the following statement of policy with regard to the extension and improvement of social services:-

The term "social services" includes the following :-

- 1. Education
- 2. Health
- 3. Housing
- Nutrition
- Welfare of children and young persons
- 4560 Institutional, family and rehabilitative serv ces
- 7. Recreation

1.

EDUCATION. This Committee recognises that education is the social service most fundamentally bound up with raising the standard of living of a community.

(a) <u>Pre-School Education</u>. A large and immediate increase is necessary in nursery schools and other forms of pre-school education, particularly for the poorer sections of the community. The same facilities are required for Coloureds, Asiatics and urbanised Africans.

(b) <u>Primary Education</u>. This Committee's general aim is to raise the minimum level of education to the equivalent of Standard VI for all sections of the community. As a first step in this direction, compulsory free education should be provided for Coloureds and Asiatics and for Africans in urban areas, together with a substantial increase in the facilities for primary education for rural Africans. To attain this object, it will be necessary for the Government to consider large capital expenditure on buildings and equipment and the extension of facilities for training teachers.

(c) <u>Post-Primary Education</u>. This Committee recognises the principle that education in its widest sense should not end with the primary school, but

that according to the abilities of the individual and the needs of the community, provision should be made for higher education and technical and vocational training.

Non-Europeans need similar facilities for post-primary education, but these will be useless unless there is a corresponding increase in their economic opportunities and a removal of such obstacles as debar them from higher forms of

work. For poorer children of ability, more adequate provision of ursaries is required to cover fees and maintenance for postprimary education. It is important that the educational system should

include in its objects training to equip young people for citizenship and to prepare them for the responsibilities of home and family life.

(d)

Physical Education. The introduction of a national service of physical education is recommended to improve the efficiency of the population.

Generally, this Committee is in favour of Union control of education as against provincial control, and deprecates any division of educational finance and control bases on racial distinctions.

2. HEALTH

This Committee is in favour of the creation of a national system of health services, both preventive and curative, accessible to all sections of the population.

As this matter is at the moment being dealt with by a State Commission, the Committee does not feel it necessary to make any specific references to health services at this stage.

3. HOUSING.

This Committee recognises the need for all sections of the population to be adequately housed, according to sound physiological, social and cultural requirements. To enable this object to be achieved a first step should be a nation-wide survey of housing needs conducted by a national planning

This Committee recognises that the provision of adequate housing for the poorer sections of the community must be on a subsidised basis.

4. NUTRITION.

There should be a national food and agricultural policy designed to produce optimum diet for all sections of the population. It will be necessary for the State to subsidise food. Systematic measures of dietetic education are also essential, and communal meals should be available when and where necessary.

5. <u>WELFARE OF CHILDREN AND YOUNG PERSONS</u>. To every child should be given the opportunity to be born healthy, brought up under healthy conditions, provided with facilities for education and training suited to his capacity, and on attaining the age and qualifications for work, work suited to his capabilities and such opportunities for physical, mental, moral and spiritual development as will enable him to become a useful citizen.

For those handicapped physically, mentally or socially, skilled services should be made available, according to their need, adequately financed and with the object of providing them with as nearly normal an environment as possible and that protection, training and happiness which should be the right of every child.

6. /

INSTITUTIONAL, FAMILY AND REHABILITATIVE SERVICES.

Other social services should be so developed as to minimise the need for institutions.

Adequate provision must be made for handicopped persons unable to be absorbed into the full life of the community.

This Committee calls attention to the urgent need for an increase in the number of specialist services rendered by skilled social workers in connection with family and social services and social security benefits.

7. RECREATION.

This Committee regards facilities for recreation as a means of preventing idleness and delinquency, of supplementing the work of the home in developing qualities of co-operation, discipline and leadership, and of providing opportunities for the creative use of leisure.

the creative use of leisure. In any housing and town-planning scheme, full facilities should be provided for recreation. Wherever possible, these should be organised on a co-operative basis, in conjunction with local authorities.

The need for recreational facilities is particularly urgent in the case of Non-Europeans.

This Committee recognises that adult education forms an integral part of schemes providing for recreation.

Finally, this Committee feels that the problems of <u>rural areas</u> in respect of opportunities for education and employment, the cultural level and incentive, health, etc., require special attention.

I thank you most sincerely for remembering me with your reminding circular of the Cradock and Blomefontein meetings of the African National Congress.

I very much regret that I got the intimation very late owing to unforseen circumstances, it will not be possible for me to attend, not through the sake of travelling expenses etc., that is no question at all.

For your information, I am a member of the Congress only it is not functioning in Port Elizabeth owing to it being in very hopeless hands.

I must congratulate you, Dr, for suspending the four officials of the Cape branch of the Congress as advertised, and I trust, in the welfare of the Congress, that you will eventually get these men dismissed permanently for the welfare of the Congress in the Cape.Without doubt, they endeavoured to use Congress for their own personal gains. However, Dr, I am your strong supporter, Rev. Calata was here a few weeks back, and he had promised to see me, before leaving, but he failed to do so, and the only brief short-notice meeting he held, I could not possibly attend as my hands were full with another important/function. IxmaxnakxnesssarilyxmexnxkkakxExemvafter

You can safely count on me as one of the members of the Congress, and you should not be **xfxr** afraid, in case you desired to give me an office, to appoint me.I have every confidence in you as our leader of the Congress.I do not necessarily mean that I am after an official position.
