of the

EXECUTIVE COMMITTEE

for the period

NOVEMBER 19th, 1937, to NOVEMBER 23rd, 1938.

In submitting the Report for the year 1937-8, the Executive Committee is glad to record a period of considerable activity and steady growth. The ready response in Johannesburg and the rapid spread of the movement to other centres in the Union testify that the Society caters for a definite need and fulfils an important function in the life of our country. The task of enlightenment by the spoken and written word is of particular importance in these days when overwhelming forces are at work to challenge the foundations of a civilised and humanitarian relationship between group and group. The very existence of a goodwill movement of this kind serves as a deterrent to forces seeking to destroy the good relations between the Jew and his non-Jewish fellow citizens.

The Society has to its credit manifold and widespread activities for the year under review, and we must rest content to record in this Report only the main items. It is equally difficult to give full details regarding the activities of Societies in other centres, and we shall accordingly deal only with the most important developments.

ORGANISATION.

The Society of Jews and Christians was formally constituted at the first Annual General Meeting which took place on the 19th November, 1937. Prof. R. F. A. Hoernlé was in the Chair. The meeting was addressed by the Hon. J. H. Hofmeyr and the Rt. Rev. The Bishop of Johannesburg. A constitution was passed (see page 11) and a Council was elected. The first meeting of the Council took place on December 2nd, 1937, at which the Executive Committee was duly elected.

THE SPOKEN WORD.

Insofar as enlightenment through the spoken word is concerned, three methods have been adopted: (a) Public functions; (b) Private gatherings; (c) Addresses to various organisations.

Public Functions: The first public meeting during the period under review took place on the 10th March, 1938, in the Selborne Hall, Johannesburg. It took the form of a symposium, the subject being "Jew and Gentile—Foes or Neighbours?" His Worship the Mayor was in the Chair, and the speakers were Father Runge, Rabbi Weiler, Mr. Karlton C. Johnson and Adv. Shacksnovis. The meeting was attended by about 400 persons.

On the 16th June, the public function which was held in the Selborne Hall took the form of a lecture-concert. Prof. P. R. Kirby delivered an address on Jewish music, Cantor B. Chagy rendered some Jewish liturgical tunes and folk songs, Mr. Hyman Sacks commented on each item, and Mr. G. Schulman performed violin solos. This function was attended by about 300 persons.

The Society collaborated in the organisation of a public meeting at the City Hall on Thursday evening, 17th November, to protest against the atrocities being perpetrated against Jews and Christians in Germany. His Worship the Mayor opened the meeting and then asked Father Runge to take his place in the Chair. The other speakers were: The Ven. Archdeacon Urquhart, Mrs. W. A. Hoernlé, Chief Rabbi Dr. J. L. Landau, the Rev. R. M. Dryden, the Rev. Fr. C. H. S. Runge, C.R., Prof. R. F. A. Hoernlé, Dr. Max Joffe, the Rev. A. S. Clegg, Mr. A. A. Moore and Rabbi M. C. Weiler. A message was read from Mr. J. H. Hofmeyr, M.P.

Private Gatherings: The Jewish question looms so large in the affairs of the world to-day that it is natural that every thinking man and woman, perplexed and often shocked by the tragic events in various countries, welcomes an opportunity of having a frank discussion on matters pertaining to the relationship between Jews and non-Jews. It has been found by the Society that a convenient venue for such discussions is at small gatherings in private houses attended by 40 to 50 invited members and friends. The informal character of these meetings is conducive to lively, outspoken and frank discussion.

On February 9th, at the residence of the Hon. Mr. Justice and Mrs. Schreiner, the Rev. Dr. J. Bruce Gardiner opened a discussion on the causes of anti-Semitism.

On April 27th, at the residence of Mr. and Mrs. J. M. Hellman, a paper was read by Dr. H. Sonnabend on "The Jew in the Economic Field."

On May 27th, at the residence of Mr. Adv. and Mrs. M. Franks, Dr. Wulf Sachs spoke on "My Attitude towards the Non-Jew."

On August 17th, at The Priory, Rosettenville, Adv. G. Saron discussed "The Problem of Combating Racial Incitement by Legislative Enactment."

On September 29th, at the residence of Mr. Adv. and Mrs. M. Franks, Prof. W. A. Willemse delivered an address, his subject being "Some modern views on the soul of a nation, with special application to the relations between the English, Boers and Jews in South Africa."

On June 29th, a social gathering of young non-Jewish and Jewish men and women was arranged by Mr. Karlton C. Johnson and Mr. M. Donen. During the course of the function, which took place in the hall of St. George's Church, Mr. Ramsay Thomson and Dr. H. Sonnabend delivered short addresses.

On Saturday afternoon, October 29th, an At Home was held at the residence of Mr. Adv. and Mrs. M. Franks in honour of Brigadier-General Sir Wyndham Deedes, C.M.G., D.S.O., and Prof. Norman Bentwich, M.A., O.B.E., M.C. Addresses to Various Organisations: Lectures and addresses by speakers of the Society to various non-Jewish and Jewish Societies, Clubs, etc., form an important branch of our activities. THE PRINTED WORD.

The poisoned plant of prejudice thrives best on ignorance, and is nourished by a flood of lying propaganda. It is therefore of the greatest importance to place before the public accurate information and reasoned arguments. The Society has accordingly published and distributed a number of pamphlets dealing with various aspects of the problem.

The following publications have so far been issued :---

No. 1 .- " Jews and Christians," by Dr. Maude Royden.

- No. 2.—" Some Facts about the Society," with an address by the Hon. J. H. Hofmeyr.
- No. 3.-" The Problem of Race," by Prof. R. F. A. Hoernlé.
- No. 4.—"A Jewish Rabbi Appeals to the Christian Conscience," by Rabbi W. Hirsch.

No. 5.—"The Jew in the Economic Life of South Africa," by Prof. J. L. Gray. Apart from the above larger publications, a series of short leaflets under the title "Facts versus Fancies," are in course of publication. Two of this series have so far appeared, one dealing with "The Jew and Finance," and the other with "Jews and Patriotism."

All these publications are issued in both English and Afrikaans and have been distributed amongst members and other suitable recipients throughout South Africa. They have also been used by Societies in other centres.

Apart from the literature issued by our Society, considerable use has been made of material obtained from overseas organisations with similar objectives.

SOCIAL WELFARE.

The Executive is fully alive to the importance of joint effort in the domain of social welfare as a means of closer co-operation. As a first step in this direction, the Society has asked its members to contribute towards a purse to be presented to the Children's Aid Society. The response has been satisfactory, a sum of £63 7s. having been raised.

ACTIVITIES IN OTHER CENTRES.

One of the most encouraging aspects in our work has been the rapid expansion of the movement to other centres in the Union. Steps have been taken to assure close co-operation between the different Societies, and it is hoped that at a later date it will be possible to convene a National Conference.

Benoni:

A Society of Jews and Christians was inaugurated at a public meeting called by the Mayor of Benoni on the 14th June. About 500 people were present; addresses were delivered by the Hon. Mr. J. H. Hofmeyr and Rabbi M. C. Weiler.

Bloemfontein:

A large audience, representing all sections of the community, attended the inaugural meeting of a Society of Jews and Christians in Bloemfontein on the 10th August. The Bishop of Bloemfontein, the Rt. Rev. A. H. Howe Brown, who was in the Chair, emphasised that the anti-Jewish movement was an offshoot of that intolerance which marred the history of our day. The Rev. Dr. J. Dexter Taylor, Joint Hon. Secretary of the Johannesburg Society, spoke of the personal enrichment derived by members of both sections from getting to know their respective spiritual values. Rabbi M. Romm described anti-Semitism as a symptom of general moral collapse. Mr. F. W. Storey, Principal of St. Andrews' School, pointed to the constructive work done by Jews in Bloemfontein, mentioning the efforts of the Ehrlich, Baumann and Leviseur families. Prof. I. S. Fourie, Head of the Department of Economics at the Bloemfontein University College, said that the fight against anti-Semitism was part of the struggle against the rising tide of materialism.

On the 2nd November, the Society held its first social gathering. The Bishop of Bloemfontein, the Rt. Rev. A. H. Howe Browne, welcomed the members and expressed the firm conviction of the good work the Society was called upon to do. Adv. I. L. Horwitz addressed the gathering in English and Afrikaans.

Capetown:

The formation of the Capetown Society of Jews and Christians came about through the Rt. Rev. Bishop S. W. Lavis bringing the matter before the Cape Peninsula Church Council on the 22nd April last. It was then resolved to convene a meeting for the purpose on the 8th June. About 180 people met for the occasion and the Society was duly formed. Bishop Lavis, with Rabbi Israel Abrahams and the Rev. Thos. Loose, who had been appointed Secretary by the meeting, were asked to draft a Constitution and take the necessary preliminary steps.

The inaugural meeting of the Society was held in the Zionist Hall, Capetown, on the 8th September, about 800 people being present. A brilliant address was given by the Hon. J. H. Hofmeyr and all other speeches were of a very high order. Bishop Lavis captivated the gathering by the forcefulness of his personality and able introduction of the speakers. They were Prof. A. W. Falconer, Vice-Chancellor of Capetown University; Councillor W. C. Foster, Mayor of Capetown; Rev. Israel Abrahams, Rev. Father Runge, the Lady de Villiers and Mrs. W. P. Steenkamp.

A Symposium on "The Scientific Approach to Race Problems" was held at the end of October, Professors Murray and Leslie, Dr. Marais and Mr. Goodwin, of Capetown University, taking part in it. This gathering was well attended.

On the 7th October a gathering was addressed by Brigadier-General Sir Wyndham Deedes and Professor Norman Bentwich. The Rt. Rev. Bishop W. S. Lavis took the Chair, and the Rt. Hon. Senator F. S. Malan and Adv. Douglas Buchanan also spoke.

The Society now has about 400 members, and there is a growing interest in the movement.

Kimberley:

At a crowded meeting in the Supper Room of the Kimberley City Hall on the 15th November, a Society of Jews and Christians was formed. The meeting, under the chairmanship of the Dean of Kimberley, the Very Rev. H. S. Chignell, was addressed by Rabbi M. C. Weiler, who outlined the objects of the Society and the necessity for its formation. Other speakers were the Rev. W. Pescod, the Deputy-Mayor, Mr. R. C. Elliott, Rev. W. Illsley, Mr. D. Cohen and Mr. S. D. Stoops.

Pretoria:

THE CONSTITUTION

OF THE SOCIETY OF JEWS AND CHRISTIANS

1. NAME.

Article 1:

The name of the Society shall be "THE SOCIETY OF JEWS AND CHRISTIANS."

II. OBJECTS.

Article 2:

The objects of the Society are to maintain and promote good relations between Jews and non-Jews and to spread knowledge concerning the factors (social, economic and others) which lead to friction.

III. LIMITATION OF SCOPE.

Article 3:

The Society as such shall be independent of all political parties.

IV. MEANS TO ATTAIN OBJECTS.

Article 4:

The Society shall endeavour to achieve its objects by the following means :--

- (1) Social intercourse, frank discussion and common study.
- (2) Lectures and writings addressed to the general public.
- (3) Co-operation in the field of social service.
- (4) The diffusion of positive knowledge concerning social and economic relations of Jews and Christians in order to eliminate grievances which tend to create ill-will, and
- (5) The endeavour by each member of the Society in his own sphere to promote the objects of the Society.

V. ORGANISATION.

Article 5:

The Society shall consist of a President, Vice-Presidents, a Council, and Executive Committee and other members.

The Council shall consist of the President, Vice-Presidents and not more than 50 other members, all of whom shall be elected by the Annual General Meeting of the Society.

The Executive Committee shall consist of a Chairman, Vice-Chairman, two joint Hon. Secretaries, a Treasurer, and not more than 15 other members, all of whom shall be elected by a duly authorised meeting of the Council.

The Executive Committee shall consist of an equal number of Jews and Christians.

VI. FUNCTIONS OF COUNCIL.

Article 6:

The functions of the Council shall be to govern the Society through the Executive, to determine the policy of the Society and to manage its affairs in accordance with the objects set out in the Constitution. The President, or in his absence one of the Vice-Presidents, shall preside at the meetings of the Council.

The Executive shall call a meeting of the Council at least once a year prior to the Annual General Meeting, and at any other time at the request of at least five members of the Council.

VII. FUNCTIONS OF EXECUTIVE.

Article 7:

The Executive shall meet at least once a month to transact all necessary business.

The Executive shall be empowered to frame rules and regulations for the conduct of the Society's business and for the election of members.

VIII. ANNUAL GENERAL MEETING.

Article 8:

There shall be held once a year on a date to be fixed by the Council a General Meeting of the members of the Society, at which

- (a) there shall be received and dealt with the annual report of the Council for the preceding year, and
- (b) there shall be elected the President, Vice-Presidents, and other members of the Council for the ensuing year.

IX. MEMBERSHIP.

Article 9:

All persons, whatever their religious or political affiliations, who are in sympathy with the objects of the Society shall be eligible for membership upon payment of a fee of 2/6d. per annum.

X. ALTERATIONS TO CONSTITUTION.

Article 10:

The Council shall have power to alter this Constitution by a twothirds majority of those present and voting at a general meeting of the Council.

FOR THE YEAR DECEMBER 9TH 1942 TO DECEMBER 8TH 1943.

The Society of Jews and Christians came into existence for the purpose of creating better relations between Jews and Christians and, through the study of its causes, to combat anti-semitism in South Africa. For the last seven years it has done its work through public addresses, private gatherings and the dissemination of various publications, but chiefly through its_journal "Common Sense." Today this journal's policy goes much further than the original aims of the Society. While our initial objectives have in no sense been obscured, they have been combined with the promotion of a more general policy of inter-racial and inter-faith understanding and with an emphasis on the solution of socio-economic problems. This follows our growing knowledge of the deep-seated causes of racial and group antagonism within our society. "Common Sense" is now well established as one of the leading progressive journals in South Africa. We have ample evidence that its message is steadily making itself felt, both among the civilian population and among men in the armed forces.
