without any reference to the Health Centre doctor or other doctors of the town.

- 2. Collectors for polio funds appointed.
- 3. Sir Richard Paget gave an interesting lecture on "Human Speech

and What to do About It". His method would teach deaf people to speak by signalling. Lady Paget co-operated by signalling a poem and a song with piano accompaniment.

March, 1949: 1. Safety first posters to be shown in the Native schools.

- 2. I.S.C. education circular discussed.
- 3. Donation towards feeding of local Native school children.

April, 1949: 1. Mrs. King, chairwoman, read her paper on "Aims and Ideals of Education", and deplored the C.N.O. policy which may be imposed on the country. Telegram sent to interim conference, Durban, endorsing Queenstown's resolution of protest against this policy.

2. Soil conservation. Members recommended to read "Road to Survival" from Reader's Digest.

May, 1949: Afternoon function held for fund-raising purposes. Goodwill message from Welsh children to South African children read in Afrikaans and English by two children.

June, 1949: Discussed the H.Q. special circular 2. Sent telegram of opposition to the South African Citizenship Bill to our local M.P.

Discussed home economics circular re shortage of edible fats. Have asked for duplicates to give to T.A.U. and Child Welfare, and will ask for their co-operation.

Soil erosion.—Have asked Organic Soil Association of South Africa about showing their colour film here.

Financial.—Am authorised to pay dues to H.Q.
