#### LATEST NEWS.

By the courtesy of the Colonel Commanding we are enabled to print the following :--

Telegrams received this morning report further hard fighting on the 10th, 11th and 12th instants, near Modder River, where Lord Methuen entrenched his forces while repairing the railway bridge. The losses on both sides were enormous. Communication south of Modder River having been kept open, additional forces were easily brought up. These telegrams are dated too early to include our reported successes this side Kimberley.

General Gatacre had a fight near Stormberg in which he lost 67 killed and wounded, and 200 men who were led astray by treacherous guides. The men were captured by the Boers, but they first shot their guides. No information as to the results of the action, but it may be assumed it was successful, as full telegrams have evidently been sent to Gapetown.

In Natal the enemy had engaged us at Colenso, 14th instant, and captured some of our guns, but General Buller advanced on the place a few days later, took it at the point of the bayonet, and recaptured the guns. Heavy. losses on both sides. Colenso is near Ladysmith, and as General Buller is evidently now on the move, we may expect him to have relieved Ladysmith by this time, and to have joined hands with Sir George White.

## The Bechuanaland Rifles.

I hereby tender a free and unreserved apology to the Officers, N.C.O.'s and men of the Bechuanaland Rifles for certain accusations made by me against the members of that Corps to the effect that at the fight at Game Tree on the 26th instant certain members were guilty of cowardice and disobedience to orders, which accusations I acknowledge to be untrue and without any foundation in fact. And I express my regret that I should have been led by petty malice to make statements so prejudicial to the honour of the Corps, and I agree that this apology shall be published at my expense in the *Mafeking Mail* and *Bechuanaland News*, or such other paper as the members of the Bechuanaland Rifles shall decide upon.

#### MAFEKING, 28TH DECEMBER, 1899.

A false rumour having been spread in town regarding the move of the "Bechuanaland Rifles" to a new post in the defences, the Colonel Commanding deems it desirable to state that the following is the reason for the change :---

For a long time it has been in contemplation to place the Rifles in a healthier camp than the Cemetery, and having now fully proved their efficiency in the field they have been selected for a more important post, where their services will be utilised in every respect as those of regular troops. When the time comes for placing on record his opinion of their value, the Colonel Commanding has no doubt that the present high estimation in which he holds them will in no wise be diminished. Under their able commander, Capt. Cowan, they have been unostentiously performing most useful and arduous work throughout the Siege.

The author of the rumour will be handed over to the "Bechuanaland Rifles" to make to them such personal explanation or apology as he may find best.

Court of Summary Jurisdiction.—The Court of Summary Jurisdiction will meet to-morrow, Friday, the 29th instant, at the Court House, at 10-15 a.m., for the examination of such prisoners as may be

put on rations by their masters daily. The following quantities should amply suffice under present circumstances: — I bb. to  $1\frac{1}{2}$  lbs. of Mealie Meal of Grain, proportionate deduction being made when Native women or children have to be fed, such as  $\frac{1}{2}$  to  $\frac{3}{2}$  lb. per diem.
