### ANNUAL REPORT

#### 1947.

The year has been an extremely busy one. The work of the Bantu Men's Social Centre has been carried on and preparations for future extension of services effected under unfavourable financial circumstances. As a result of a considerable deficit which was reflected in last year's Expenditure and Revenue Account, the Executive Committee was reduced to the necessity of making a special appeal for financial assistance to a number of Subscribers, Donors and interested friends of the Centre. The response was appreciable and made it possible for the Institution to continue to render the Non- European Community the same valuable service it has rendered since its inception.

The Social Centre is the one place where African men spend their leisure-time profitably with a programme which promotes wholesome fellowship and aims at the development of its members in Body, Mind, Spirit and Character.

#### B. M. S. C. STAFF.

The administrative staff of the Centre was depleted early during the year by the resignation of Mr. Theo B. Mdaniso from the Secretaryship after having served the Centre for six years. We wish

him every success in his present work.

Dr. James Dexter Taylor one of the Trustees of the Institution, who has served the Executive Committee for many years brought his period of useful service to a termination, when he resigned from his position to return to America. His resignation was accepted with regret. Although a Farewell function which was held in honour of Dr. and Mrs. Taylor was coloured with the sadness of saying "Goodbye," the occasion celebrated the success of a life work which has done so much good in Johannesburg and leaves its permanent memorial in the records of the Bantu Men's Social Centre.

#### MEMBERSHIP.

There has been a considerable increase in the membership during the past year which surpasses most of the previous records. Membership of the Social Centre is classified into five different categories:-

(a) Life Membership - Fees £5. 0. 0.

(b) Ordinary Membership - Fees 10s. per annum - offered to those resident within the magisterial area of Johannesburg.

(c) Country Membership → Fees 5s. per annum - offered to those resident outside the magisterial area of Johannesburg.

(d) Junior Membership - Fees 2s. 6d. per annum - offered to those who are bona fide Scholars.

(e) Visiting Membership - Fees 1s. per month - offered to Africans visiting Johannesburg.

The following table reflects the membership position and it appears evident that if the staff is re-inforced there will be further possibilities of an increase in the membership.

### ANNUAL FOUNDERS' DAY CELEBRATION.

Our Annual Founders' Day when we are afforded the opportunity of paying tribute to those responsible for the establishment of the Bantu Men's Social Centre and expressing our thanks to those who still assume the responsibility of its maintenance and upkeep, was held on the 31st. October, 1947. Colonel T. R. Ponsford, L.L. B., O.B.E., National Secretary of the South African National Council of Young Men's Christian Associations, who had recently returned from attending several World's Youth Conferences overseas, was our Guest of Honour. The Johannesburg Symphony Orchestra conducted by Mr. Joseph Trauneck provided a memorable musical programme.

### INDOOR GAMES.

The provision of recreational activities is an essential part of the programme of the Social Centre. Recreation is highly diversified giving our members the opportunity of pleasurable relaxation through wholesome self-expression. Activities such as Billiards, Snooker, Chess, Draughts, Fing-pong, Badmington, Basket Ball and Volley Ball are increasingly enjoyed. Competition in these games is very keen and the championships which were held during the year were not only very interesting but made manifest a growing spirit of enthusiasm.

A team from the Bloemfontein Bentu Social Institute competed against us on the 4th., 5th., and 6th. October, 1947 in Billiards, Draughts, Ping-pong, Tennis and a Debate. The Social Centre won in all the events with the exception of the Billiards. The Activities Committee which has been responsible for the organisation of the competition merits our gratitude.

#### TENNIS.

Our Tennis section has been exceptionally busy during the year. A few Inter-club matches were played, but the Bantu Men's Social Centre Lawn Tennis Tournament is worthy of mention. This tournament which attracted numerous entrants was played with peculiar zeal and an appreciable spirit of sportsmanship. Many players displayed a high standard of effeciency.

Our thanks are due to Dr. Ray E. Phillips and Mr. Hoosen Jajbhay for the provision of the trophies for the competition. We heartily congratulate Mr. A. V. Hoskins and Mr. L. Bopape for winning the "A" division and "B" division Singles trophies respectively, and Mr. F. Roro partner D. P. Jemaine and Mr. Peter Rezant partner Mr. Dale Nkwanca for winning the "A" division and "B" division Doubles trophies respectively.

#### BOXING AND PHYSICAL TRAINING.

The Physical Training Class under the direction of Mr. A. P. Khutlang has grown remarkably. Many of our members entered for the Amateur Boxing Championships which were held at the Centre during the year, organised by the Transvaal Non-European Amateur Boxing Association. They showed remarkable ability. Some of the older members of this class have joined the professional ranks and are gaining honours. The Centre has remained the venue of these Boxing Tournaments.

# GUEST NIGHTS AND SOCIAL FUNCTIONS.

Our Guest Nights, as in the past, have been held regularly on the last Friday of each month. Our members and guests have been entertained with programmes which varied from month to month in order to capture the interest of our members.
