- 6. Financial: Money left ffom light-box, we are informed, can be used for other capital equipment. Suggest we share costs of buying a good second-hand electro-scanner with P and R. Suggestion adopted by meeting.

Marion asked to buy stuff on list in Johannesburg.

Treasurer to find out if any untied money is awailable for Thami and Judy to buy supplies as available in Europe.

- 7. Xmas cards for Cuso: Cuso asks for 100 cards of Botswana-could also be sold elsswhere. Ellen mandated to produce. Chrismand Eric for designs.
